Building Condition Reports

Introduction

For the Condition Assessment portion of the project, Parsons performed comprehensive facility condition assessments on eighty-nine (89) campuses in the nine county school districts included in the project facility portfolio. This Appendix provides supplementary information in support of the summary data included in the main report.

In the Renewal Schedule and the Supplemental Tables and Graphs, the "stoplight" color-coded rating scheme is applied consistent with the usage in the main report.

School Assessment Reports

The standard report format includes an executive summary, a methodology description, an analysis of existing conditions, a total backlog of deferred maintenance and brief descriptions of each deficiency, capital renewal forecasts, and a 10-year renewal schedule. 5-Year Capital Renewal Schedule

This spreadsheet summarizes the deficiencies from the nine county school districts for the current year FY 2017 (which is the basis for the analysis in the main report) plus projections for each of the next four years, FY 2018 through FY 2021. This 5-year spread is similar to the DPI self-survey format. At the top of the page is a summary for each of the 9 counties including (left to right) current Replacement values of the facilities portfolio, the Facility Condition Index (FCI) and the reciprocal Facility Condition Assessment (FCA) Score, also referred to in the report as Condition Score, then the estimated costs of the deficiencies for each of the 5 years with subtotal and total. Following down the sheet, each county is reported with subgroups for Elementary, Middle, and High and each school listed within the groups. The schools within each facility type group are sorted from "worst" to "best" by the FCI and FCA scores.

Supplemental Tables and Graphs of Construction Needs

The last series of tables and graphs portray the condition assessment results in various ways to assist in comparing the counties both by actual dollar values and by condition ratings. The first 4 pages compare the 9 counties while the remaining pages look at each county individually. This last group separates the portfolio of buildings (not campuses but all the buildings) of each county into groupings by the decade in which they were built and shows the quantity and dollar values distributed according to the 5-grade condition scoring scheme.



The County with the lowest FCA Score is Anson County rated as "Unsatisfactory" with 55.03; and the County with the highest FCA Score is Clay County rated as "Good" with 89.93 score. Harnett County has the largest dollar value needs although the district is rated "Good," due to the number of schools.

Current Needs FY2017 and Forecast Renewal Needs FY2018-2021 by County, Type of School and FCA Score








Facility Condition Rating Group Needs FY2017 by County and FCA Score






Total Current Needs by County and by Total Number of Buildings by Decade Built


