A BILL TO BE ENTITLED

AN ACT TO ADD A SEAT OF DISTRICT COURT FOR ROWAN COUNTY IN KANNAPOLIS.

The General Assembly of North Carolina enacts:

Section 1. G.S. 7A-133 reads as rewritten:

"§ 7A-133. Numbers of judges by districts; numbers of magistrates and additional seats of court, by counties.

Each district court district shall have the numbers of judges and each county within the district shall have the numbers of magistrates and additional seats of court, as set forth in the following table:

 25 Office of the Courts \$19,434 for fiscal year 1989-90 and \$18,951 for fiscal year 1990-  
 26 91 for an additional deputy clerk of court in Rowan County to implement this act.

27           Sec. 3. This act shall become effective July 1, 1989.
