A BILL TO BE ENTITLED

AN ACT TO APPROPRIATE FUNDS TO ORGANIZATIONS FOR SPECIAL
PROJECTS IN PITT COUNTY.

The General Assembly of North Carolina enacts:

Section 1. There is appropriated from the General Fund to the Town of Ayden \$1,500 for the 1989-90 fiscal year for equipment and improvements for the Recreation Department.

Sec. 2. There is appropriated from the General Fund to the Town of Grifton \$5,000 for the 1989-90 fiscal year for renovation for the Depot provided that these funds are matched on a dollar-for-dollar basis with local funds.

Sec. 3. There is appropriated from the General Fund to the Town of Farmville \$500.00 for the 1989-90 fiscal year for equipment and supplies for the Senior Citizens Center.

Sec. 4. There is appropriated from the General Fund to the Town of Farmville \$500.00 for the 1989-90 fiscal year for the Dogwood Spring Festival.

Sec. 5. There is appropriated from the General Fund to the Village of Simpson \$1,000 for the 1989-90 fiscal year for the Municipal Building Fund.

Sec. 6. There is appropriated from the General Fund to the Town of Winterville \$1,500 for the 1989-90 fiscal year for repairs to the Community Center and for the History and Arts Society.

Sec. 7. There is appropriated from the General Fund to the Town of Winterville \$1,000 for the 1989-90 fiscal year for capital improvements to the Winterville Rescue Squad building provided that these funds are matched on a dollar-for-dollar basis with local funds.

1 Sec. 8. There is appropriated from the General Fund to the Board of
2 Governors of The University of North Carolina \$500.00 for the 1989-90 fiscal year for
3 equipment and supplies for the East Carolina University School of Medicine Rainbow
4 Services for pediatric cancer victims.

5 Sec. 9. There is appropriated from the General Fund to the Board of
6 Governors of The University of North Carolina \$500.00 for the 1989-90 fiscal year for
7 equipment and supplies for the East Carolina University School of Medicine Creative
8 Living Center for senior day care services.

9 Sec. 10. There is appropriated from the General Fund to the Pitt-Greenville
10 Arts Council \$500.00 for the 1989-90 fiscal year for equipment and supplies.

11 Sec. 11. There is appropriated from the General Fund to the Pitt County Fire
12 Marshall \$3,000 for the 1989-90 fiscal year for equipment and supplies for the Fire and
13 Rescue Squads in Pitt County.

14 Sec. 12. There is appropriated from the General Fund to the Pitt County
15 Senior Citizens \$750.00 for the 1989-90 fiscal year for equipment and supplies.

16 Sec. 13. There is appropriated from the General Fund to the County
17 Commissioners of Pitt County \$750.00 for the 1989-90 fiscal year for equipment and
18 supplies for the Pitt County Mental Health Child Developmental Day Center.

19 Sec. 14. There is appropriated from the General Fund to Children's Services
20 of Eastern Carolina, Inc., \$500.00 for the 1989-90 fiscal year for equipment and
21 supplies at the Ronald McDonald House serving Pitt County Memorial Hospital.

22 Sec. 15. There is appropriated from the General Fund to Pitt County
23 Memorial Hospital, Incorporated, \$550.00 for the 1989-90 fiscal year for operational
24 expenses of the hospital volunteer auxiliary.

25 Sec. 16. There is appropriated from the General Fund to Pitt County
26 Memorial Hospital, Incorporated, \$750.00 for the 1989-90 fiscal year for a mobile
27 telephone for the neonatal ambulance.

28 Sec. 17. There is appropriated from the General Fund to the Pitt County
29 Board of Education \$750.00 for the 1989-90 fiscal year for recreation supplies and
30 equipment at the Chicod Elementary School.

31 Sec. 18. There is appropriated from the General Fund to the Pitt County
32 Board of Education \$500.00 for the 1989-90 fiscal year for community and school
33 recreation projects at the Pactolus School.

34 Sec. 19. There is appropriated from the General Fund to the Town of
35 Grimesland \$5,000 for the 1989-90 fiscal year for the fire station and town hall
36 provided that these funds are matched on a dollar-for-dollar basis with local funds.

37 Sec. 20. There is appropriated from the General Fund to the Eastern Pines
38 Fire-Rescue Emergency Rescue Squad \$5,000 for the 1989-90 fiscal year for paving at
39 the building provided that these funds are matched on a dollar-for-dollar basis with local
40 funds.

41 Sec. 21. This act shall become effective July 1, 1989.
