A BILL TO BE ENTITLED

AN ACT TO APPROPRIATE FUNDS TO VOLUNTEER FIRE DEPARTMENTS IN ALAMANCE, ROCKINGHAM, AND STOKES COUNTY.

The General Assembly of North Carolina enacts:

Section 1. There is appropriated from the General Fund to Alamance County \$11,500 for the 1989-90 fiscal year to be distributed to the following volunteer fire departments and rescue squad in the amounts indicated for operating expenses:
