1	A BILL TO BE ENTITLED
2	AN ACT TO APPROPRIATE FUNDS FOR SERVICES FOR THE ELDERLY
3	CITIZENS OF CRAVEN, PAMLICO, AND LENOIR COUNTIES.
4	Whereas, Craven, Pamlico, and Lenoir Counties are made up of rural
5	communities; and
6	Whereas, many of the elderly population of these three counties are poor or
7	newcomers; and
8	Whereas, various organizations in Craven, Pamlico, and Lenoir Counties
9	provide such services as Meals on Wheels, and educational, recreational, social, and
10	cultural outreach programs to the elderly; and
11	Whereas, these organizations need funding to meet the needs of the growing
12	elderly population; Now, therefore,
13	The General Assembly of North Carolina enacts:
14	Section 1. There is appropriated from the General Fund to Craven County the
15	sum of \$10,000 for the 1989-90 fiscal year for services for the elderly to be allocated
16	among the following:
17	(1) \$5,000 to the United Tri-County Senior Citizens Corporation,
18	Incorporated;
19	(2) \$1,000 to the Craven County Council on Aging, Inc.;
20	(3) \$1,000 to the Vanceboro Community Organization, Incorporated;
21	(4) \$1,000 to the Dover Community Center, Incorporated; and
22	(5) \$2,000 to the Havelock Communities Improvement Association.
23	The funds shall be matched with non-State funds on the basis of \$1.00 of non-State

24 funds for every \$2.00 of State funds.

1	Sec. 2. There is appropriated from the General Fund to Pamlico County the
2	sum of \$11,000 for the 1989-90 fiscal year for services for the elderly to be allocated
3	among the following:
4	(1) \$10,000 to Pamlico County Services for a van for transporting senior
5	citizens; and
6	(2) \$1,000 to Hospice of Pamlico County, Inc.
7	These funds shall be matched with non-State funds on the basis of \$1.00 of non-State
8	funds for every \$2.00 of State funds.
9	Sec. 3. There is appropriated from the General Fund to Lenoir County the
10	sum of \$1,000 for the 1989-90 fiscal year for the Eastern Minority Economic
11	Development Corporation to assist in its community-based services for the elderly.
12	These funds shall be matched with non-State funds on the basis of \$1.00 of non-State
13	funds for every \$2.00 of State funds.
14	Sec. 4. This act shall become effective July 1, 1989.
