A BILL TO BE ENTITLED

AN ACT TO APPROPRIATE FUNDS FOR PROJECTS IN MONTGOMERY COUNTY.

The General Assembly of North Carolina enacts:

Section 1. There is appropriated from the General Fund to the Montgomery County Historical Society, Incorporated, the sum of \$10,000 for the 1990-91 fiscal year for the stabilization and preservation of the historic Roller Mill in Montgomery County and to promote programs conducted at the Roller Mill, which serves the Montgomery County area as a civic arts center.

Sec. 2. There is appropriated from the General Fund to Montgomery County Cares, Women's Crisis Council, Inc., the sum of \$5,000 for the 1990-91 fiscal year for mediation and crisis prevention in Montgomery County.

Sec. 3. There is appropriated from the General Fund to the Town of Biscoe the sum of \$10,000 for the 1990-91 fiscal year for renovation of Biscoe High School and for community development and recreation projects.

Sec. 4. There is appropriated from the General Fund to the Town of Troy the sum of \$10,000 for the 1990-91 fiscal year for renovation of Peabody High School.

Sec. 5. There is appropriated from the General Fund to the Town of Mount Gilead the sum of \$10,000 for the 1990-91 fiscal year for the renovation of the Leah Levin Auditorium and for community development and recreation projects.

Sec. 6. There is appropriated from the General Fund to the Town of Troy the sum of \$10,000 for the 1990-91 fiscal year for community development and recreation projects.

1 Sec. 7. There is appropriated from the General Fund to the Town of Candor
2 the sum of \$10,000 for the 1990-91 fiscal year for community development and
3 recreation projects.

4 Sec. 8. There is appropriated from the General Fund to the Town of Star the
5 sum of \$10,000 for the 1990-91 fiscal year for community development and recreation
6 projects.

7 Sec. 9. There is appropriated from the General Fund to Montgomery County
8 the sum of \$10,000 for the 1990-91 fiscal year for the YMCA for its public purpose
9 programs that serve the community.

10 Sec. 10. There is appropriated from the General Fund to Montgomery
11 County the sum of \$10,000 for the 1990-91 fiscal year for the Montgomery County
12 Firemen's Association to be distributed equally among the volunteer fire departments in
13 Montgomery County for operating expenses and equipment.

14 Sec. 11. This act shall become effective July 1, 1990.
