A BILL TO BE ENTITLED

AN ACT TO APPROPRIATE FUNDS, IF AVAILABLE, FOR THE TWENTY-FIFTH
HOUSE DISTRICT FOR LOCAL PUBLIC PURPOSES, PROJECTS,
PROGRAMS, AND SERVICES.

The General Assembly of North Carolina enacts:

Section 1. There is appropriated from the General Fund to Wesley Hall of Alamance, Inc., \$5,000 for the 1989-90 fiscal year for operating expenses to enable the continued drug addiction treatment of Alamance, Rockingham, Caswell, and other area patients.

Sec. 2. There is appropriated from the General Fund to Alamance County \$5,000 for the 1989-90 fiscal year for operating support for Alamance County restitution programs for juvenile, undisciplined, and delinquent children (Friends of Youth).

Sec. 3. There is appropriated from the General Fund to the Alamance County Historical Museum, Inc., \$5,000 for the 1989-90 fiscal year for continued operations or capital improvements.

Sec. 4. There is appropriated from the General Fund to the Alamance County Council on Elderly Services and Support, Inc., \$5,000 for the 1989-90 fiscal year to help meet ongoing meals on wheels services to provide hot and frozen meals to the home bound elderly in Alamance County.

Sec. 5. There is appropriated from the General Fund to the Friendship Center of Alamance, Inc., \$5,000, for the 1989-90 fiscal year for expansion of the day care and

1 respite services for persons suffering from Alzheimer's and other memory impairing
2 diseases.

3 Sec. 6. There is appropriated from the General Fund to the Swepsonville
4 Sanitary District \$5,000 for the 1989-90 fiscal year for operational expenses.

5 Sec. 7. There is appropriated from the General Fund to the Snow Camp
6 Historical Drama Society, Inc., \$5,000 for the 1989-90 fiscal year for operating
7 expenses for the outdoor drama, "Sword of Peace", in Alamance County.

8 Sec. 8. There is appropriated from the General Fund to the Rockingham
9 County Historical Society, Incorporated, \$5,000 for the 1989-90 fiscal year for
10 operating expenses and capital expenditures.

11 Sec. 9. There is appropriated from the General Fund to the Madison Colored
12 and Charles Drew Alumni Association, Inc., \$5,000 for the 1989-90 fiscal year for
13 renovation of the old Madison Colored School to be used as a community center for
14 youth and public groups.

15 Sec. 10. There is appropriated from the General Fund to REMMSCO, Inc.,
16 \$5,000 for the 1989-90 fiscal year for an Alcoholic's Half-Way House for Rockingham
17 County.

18 Sec. 11. There is appropriated from the General Fund to the Rockingham
19 Council on Mental Retardation, Inc., \$5,000 for the 1989-90 fiscal year for operating
20 expenses and capital expenditures.

21 Sec. 12. There is appropriated from the General Fund to the Rockingham
22 County Public Library \$5,000 for the 1989-90 fiscal year for the Genealogy Department
23 of the Madison Branch Library to be used to add new machines and additional shelving
24 and to buy genealogy books as they become available.

25 Sec. 13. There is appropriated from the General Fund to the Volunteer Fire
26 Departments serving the Sandy Ridge, Pinehall, and Mitchell Election Precincts of
27 Stokes County \$5,000 for the 1989-90 fiscal year for operating expenses and capital
28 expenditures.

29 Sec. 14. This act shall become effective July 1, 1989.
