A BILL TO BE ENTITLED

AN ACT TO APPROPRIATE FUNDS TO THE UNIVERSITY OF NORTH CAROLINA BOARD OF GOVERNORS FOR THE AGRICULTURAL EXTENSION SERVICE AT NORTH CAROLINA STATE UNIVERSITY FOR THE NORTH CAROLINA 4-H PROGRAM.

The General Assembly of North Carolina enacts:

Section 1. There is appropriated from the General Fund to The University of North Carolina Board of Governors for the Agricultural Extension Service at North Carolina State University the sum of one hundred eighty-two thousand dollars (\$182,000) for the 1989-90 fiscal year for capital improvements at the Betsy-Penn 4-H Center near Reidsville, N.C.

Sec. 2. There is appropriated from the General Fund to The University of North Carolina Board of Governors for the Agricultural Extension Service at North Carolina State University the sum of one hundred forty-nine thousand dollars (\$149,000) for the 1989-90 fiscal year for capital improvements at the Millstone 4-H Camp located near Ellerbe, N.C.

Sec. 3. There is appropriated from the General Fund to The University of North Carolina Board of Governors for the Agricultural Extension Service at North Carolina State University the sum of one hundred twenty-one thousand dollars (\$121,000) for the 1989-90 fiscal year for capital improvements at the Mitchell 4-H Camp located near Swansboro, N.C.

1 Sec. 4. There is appropriated from the General Fund to The University of
2 North Carolina Board of Governors for the Agricultural Extension Service at North
3 Carolina State University the sum of two hundred nine thousand eight hundred dollars
4 (\$209,800) for the 1989-90 fiscal year for capital improvements at the Sertoma 4-H
5 Camp located near Danbury, N.C.

6 Sec. 5. There is appropriated from the General Fund to The University of
7 North Carolina Board of Governors for the Agricultural Extension Service at North
8 Carolina State University the sum of eighty-seven thousand dollars (\$87,000) for the
9 1989-90 fiscal year for capital improvements at the Swannanoa 4-H Camp located at
10 Swannanoa, N.C.

11 Sec. 6. This act shall become effective July 1, 1989.
