A BILL TO BE ENTITLED

AN ACT TO INCREASE THE FEES THAT MAY BE CHARGED BY THE STATE BOARD OF BARBER EXAMINERS AND THE STATE BOARD OF EXAMINERS OF PRACTICING PSYCHOLOGISTS.

The General Assembly of North Carolina enacts:

Section 1. G.S. 86A-25 reads as rewritten:

"§ 86A-25. Fees collectible by Board.

The State Board of Barber Examiners shall charge fees not to exceed the following:

6	"(1) Each application for renewal must be accompanied by a renewal fee	
7	of not more than <del>thirty five dollars (\$35.00)</del> <u>one hundred twenty-five</u>	
8	<u>dollars (\$125.00)</u> . If a license is not renewed on or before the first day	
9	of January of each year, an additional fee of not more than fifteen	
10	dollars (\$15.00) shall be charged for late renewal; and".	
11	Sec. 3. This act is effective upon ratification.
