SENATE BILL 417

A BILL TO BE ENTITLED

1 AN ACT TO ALLOW FOR THE TRANSFER OF RESPONSIBILITY FOR
2 ADMINISTRATION OF LOCAL IV-D UNITS BETWEEN THE DEPARTMENT
3 OF HUMAN RESOURCES AND BOARD OF COUNTY COMMISSIONERS.

5 The General Assembly of North Carolina enacts:

6 Section 1. G.S. 110-141 reads as rewritten:

7 "**§ 110-141. Effectuation of intent of Article.**

8 (a) The North Carolina Department of Human Resources shall supervise the
9 administration of this program in accordance with federal law and shall cause the
10 provisions of this Article to be effectuated and to secure child support from absent,
11 deserting, abandoning and nonsupporting parents.

12 (b) Effective July 1, 1986, the entity, whether the board of county commissioners
13 or the Department of Human Resources, that is administering, or providing for the
14 administration of, this program in each county on June 30, 1986, shall continue to
15 administer, or provide for the administration of, this program in that county, ~~with one~~
16 ~~exception. If with two exceptions:~~

17 (1) When a county program administered by the board of county
18 commissioners is not operated in accordance with State and federal
19 laws, rules, and regulations, the Department of Human Resources may
20 assume administration by notifying the board of county commissioners
21 of its intent in accordance with a timetable and criteria established by
22 the Social Services Commission; or

23 (2) A a-county program is being administered by the Department of
24 Human Resources on June 30, 1986, and if the board of county

1 commissioners of this county desires on or after that date to assume
2 responsibility for the administration of the program, the board of
3 county commissioners shall notify the Department of Human
4 Resources between July 1 and September 1 of the current fiscal
5 ~~year~~year, except when the program is operated by the Department of
6 Human Resources as provided in subdivision (1) of this subsection.
7 The obligations of the board of county commissioners to assume
8 responsibility for the administration of the program shall not
9 commence prior to July 1 of the subsequent fiscal year. Until that time,
10 it is the responsibility of the Department of Human Resources to
11 administer or provide for the administration of the program in the
12 county.

13 (c) A county may negotiate alternative arrangements to the procedure outlined in
14 G.S. 110-130 for designating a local person or agency to administer the provisions of
15 this Article in that county."

16 Sec. 2. This act shall become effective July 1, 1989.
