A BILL TO BE ENTITLED

1 AN ACT TO ESTABLISH HOUSE OF REPRESENTATIVES DISTRICTS AND TO  
2 APPORTION SEATS IN THE HOUSE OF REPRESENTATIVES AMONG  
3 DISTRICTS.  
4

5 Whereas, legislative districts should avoid the dilution of the voting rights of  
6 racial minorities, as protected by the Voting Rights Act of 1965 and the 14th and 15th  
7 Amendments to the United States Constitution, concentrations of racial minorities shall  
8 not be fractured, divided, diluted, or submerged; and

9 Whereas, a minimum of 13 racial minority districts may be created in not  
10 only the counties covered by section 5 of the Voting Rights Act of 1965, but in all  
11 counties or areas where there are cognizable racial minority communities, while  
12 retaining the integrity of precincts as demarcated in the General Assembly's automated  
13 redistricting system as of May 1, 1991; and

14 Whereas, the requirements of the 14th Amendment to the United States  
15 Constitution and Section 5(1) of Article II of the North Carolina Constitution that all  
16 districts be drawn as nearly equal as possible would require that all districts contain to  
17 the extent possible 55,239 citizens for each district, and no district's deviation should  
18 exceed plus or minus 5%; and

19 Whereas, a truly representative body should be elected regardless of party  
20 affiliation, race, color, creed, or nationality; and

21 Whereas, the use of multimember districts submerges cognizable minority  
22 population concentration into larger white electorates; and

23 Whereas, legislative districts should consist of contiguous territory as  
24 required by the North Carolina Constitution; and

1           Whereas, legislative districts should be as compact as practical and meet the  
2 requirements of the 14th Amendment to the United States Constitution and the  
3 applicable sections of the North Carolina Constitution; and

4           Whereas, legislative districts should recognize the State's historic  
5 communities and commonalities of interest with respect to the inhabitants and  
6 constituencies of the district; and

7           Whereas, the creation of single-member districts not only minimizes but  
8 removes any doubt whatsoever as to whom a voter or constituent should seek out as his  
9 or her elected representative; and

10          Whereas, the creation of single-member districts will indicate to all North  
11 Carolinians that they have equal representation and voice in government; and

12          Whereas, the creation of single-member districts will remove any question  
13 about a double standard being applicable to parts of North Carolina because of the 40  
14 covered counties now under section 5 of the Voting Rights Act of 1965; Now, therefore,  
15 The General Assembly of North Carolina enacts:

16           Section 1. G.S. 120-2 reads as rewritten:

17 **"§ 120-2. House apportionment specified.**

18          (a) For the purpose of nominating and electing members of the North Carolina  
19 House of Representatives in ~~1984-1992~~ and periodically thereafter, the State of North  
20 Carolina shall be divided into the following districts with each District electing one  
21 Representative, except that District 69 shall elect two Representatives:

39 ~~Hertford County; Beargrass, Cross Roads, Giffins, Jamesville, Poplar Point, Williams,~~  
40 ~~and Williamston Townships of Martin County; and Bethel and Carolina Townships of~~

42          ~~District 7 shall elect one Representative and shall consist of Brinkleyville,~~  
43 ~~Butterwood, Conoconnara, Enfield, Faucett, Halifax, Palmyra, Roseneath, Scotland~~  
44 ~~Neck, and Weldon Townships of Halifax County; Goose Nest, Hamilton, and~~

1 ~~Robersonville Townships of Martin County; and Fishing Creek, Fork, Sandy Creek,~~  
2 ~~Shocco, and Warrenton Townships of Warren County.~~

3 ~~District 8 shall elect three Representatives and shall consist of the remainders of~~  
4 ~~Edgecombe, Nash, and Wilson Counties that are not included in District 70.~~

5 ~~District 9 shall elect two Representatives and shall consist of Greene County; and~~  
6 ~~Arthur, Ayden, Belvoir, Chicod, Falkland, Farmville, Fountain, Greenville, Grifton,~~  
7 ~~Grimesland, Pactolus, Swift Creek, and Winterville Townships of Pitt County.~~

8 ~~District 10 shall elect one Representative and shall consist of Duplin and Jones~~  
9 ~~Counties.~~

10 ~~District 11 shall elect two Representatives and shall consist of Wayne County.~~

11 ~~District 12 shall elect two Representatives and shall consist of Bladen and Sampson~~  
12 ~~Counties; and Burgaw, Caswell, Columbia, Holly, Canetuck, Grady, Long Creek,~~  
13 ~~Rocky Point, and Union Townships of Pender County.~~

14 ~~District 13 shall elect two Representatives and shall consist of Federal Point,~~

36 District 37 shall elect three Representatives and shall consist of Davidson and Davie

39 Cedar Grove, Concord, Grant, Level Cross, New Hope, New Market, Pleasant Grove,  
40 Richland, Tabernacle, Trinity, and Union Townships of Randolph County.

41 District 39 shall elect three Representatives and shall consist of the remainder of  
42 Forsyth County not included in Districts 29, 66, or 67.

43 District 40 shall elect three Representatives and shall consist of Alleghany, Ashe,  
44 and Surry Counties; Big Creek, Danbury, Meadows, Peters Creek, Quaker Gap,
