A BILL TO BE ENTITLED

AN ACT TO ADD FOUR MEMBERS TO THE NORTH CAROLINA BOARD OF SCIENCE AND TECHNOLOGY.

The General Assembly of North Carolina enacts:

Section 1. G.S. 143B-426.31 reads as rewritten:

**"§ 143B-426.31. North Carolina Board of Science and Technology; membership; organization; compensation; staff services.**

(a) The North Carolina Board of Science and Technology consists of the Governor, the Science Advisor to the Governor, and ~~13~~17 members appointed as follows: the Governor shall appoint one member from the University of North Carolina at Chapel Hill, one member from North Carolina State University at Raleigh, and two members from other components of the University of North Carolina, all nominated by the President of the University of North Carolina; one member from Duke University, nominated by the President of Duke University; one member from a private college or university, other than Duke University, in North Carolina, nominated by the President of the Association of Private Colleges and Universities; one member from the Research Triangle Institute, nominated by the executive committee of the board of that institute; one member from the Microelectronics Center of North Carolina, nominated by the executive committee of the board of that center; one member from the North Carolina Biotechnology Center, nominated by the executive committee of the board of that center; ~~four~~ two members from private industry in North Carolina; ~~Carolina~~, at least one

1 of whom shall be a professional engineer registered pursuant to Chapter 89C of the  
2 General Statutes or a person who holds at least a bachelors degree in engineering from  
3 an accredited college or university; and two members from public agencies in North  
4 Carolina. Two members shall be appointed by the General Assembly, one shall be  
5 appointed upon the recommendation of the President of the Senate, and one shall be  
6 appointed upon the recommendation of the Speaker of the House of Representatives in  
7 accordance with G.S. 120-121. The nominating authority for any vacancy on the Board  
8 among members appointed by the Governor shall submit to the Governor two  
9 nominations for each position to be filled, and the persons so nominated shall represent  
10 different disciplines.

11 (b) ~~The initial members~~ Members appointed to the Board by the General Assembly  
12 shall serve ~~for terms expiring June 30, 1983; thereafter, their successors shall serve for two-~~  
13 ~~year terms beginning 1 July 1~~ of odd-numbered years. Vacancies in appointments made  
14 by the General Assembly shall be filled in accordance with G.S. 120-122. The two  
15 members from public agencies shall serve for terms expiring at the end of the term of  
16 the Governor appointing them. Of the remaining nine appointments by the Governor, five  
17 ~~shall serve for four years expiring June 30, 1983, and four shall serve for two years expiring~~  
18 ~~June 30, 1981; thereafter terms of all nine of these remaining members appointed by the~~  
19 ~~Governor shall be for four years~~ The other 13 members appointed to the Board by the  
20 Governor shall serve for four-year terms, and until their successors are appointed and  
21 qualified. Of those 13 members, six shall serve for terms that expire on 30 June of  
22 years that follow by one year those years that are evenly divisible by four, and seven  
23 shall serve for terms that expire on 30 June of years that follow by three years those  
24 years that are evenly divisible by four. Any appointment to fill a vacancy on the Board  
25 created by the resignation, dismissal, ~~death~~ ~~death~~, or disability of a member shall be for  
26 the balance of the unexpired term.

27 (c) The Governor shall serve as chairman of the Board. The vice chairman of the  
28 Board shall be designated by the Governor from among the members of the Board. The  
29 Science Advisor to the Governor shall serve as executive director of the Board. The  
30 Secretary of Administration or his designee shall serve as secretary to the Board.

31 (d) The Governor may remove any member of the Board from office in  
32 accordance with the provisions of G.S. 143B-16.

33 (e) Members of the Board who are employees of State agencies or institutions  
34 shall receive subsistence and travel allowances authorized by G.S. 138-6. Legislative  
35 members of the Board shall receive subsistence and travel allowances authorized by  
36 G.S. 120-3.1.

37 (f) A majority of the Board constitutes a quorum for the transaction of business.

38 (g) ~~The Secretary of Economic and Community Development Administration~~ shall  
39 provide all clerical and other services required by the Board."

40 Sec. 2. Of the initial members of the North Carolina Board of Science and  
41 Technology that are added to the Board by this act, two shall be appointed by the  
42 Governor to serve for two-year terms that expire on 30 June 1993 and two shall be  
43 appointed by the Governor to serve for four-year terms that expire on 30 June 1995.

1           Sec. 3. This act shall not be construed to obligate the General Assembly to  
2 make any appropriation to implement the provisions of this act. The North Carolina  
3 Board of Science and Technology and the Department of Administration shall  
4 implement the provisions of this act from funds otherwise appropriated or available to  
5 the Board or to the Department.

6           Sec. 4. This act becomes effective 1 July 1991.
