A BILL TO BE ENTITLED

1 AN ACT TO FURTHER PROVIDE FOR THE SEPARATION OF POWERS
2 BETWEEN THE LEGISLATIVE AND EXECUTIVE BRANCHES OF
3 GOVERNMENT BY PROVIDING THAT THE PRESIDENT PRO TEMPORE OF
4 THE SENATE RATHER THAN THE LIEUTENANT GOVERNOR SHALL
5 MAKE APPOINTMENTS TO CERTAIN LEGISLATIVE COMMISSIONS AND
6 COMMITTEES.

18 Section 1. G.S. 120-70.2 reads as rewritten:

19 **"§ 120-70.2. Appointment of members and organization.**

20 The Joint Committee shall consist of six sitting members of the General Assembly.
21 Three shall be appointed by the President Pro Tempore of the Senate from the
22 membership of the Senate and three shall be appointed by the Speaker of the House of
23 Representatives from the membership of the House. Members will serve at the pleasure
24 of their appointing officer and any vacancies occurring on the Joint Committee shall be
25 filled by the presiding officer of the appropriate house. ~~The initial membership of the~~
26 ~~Joint Committee shall consist of the membership of the Utility Review Committee on~~
27 ~~June 28, 1985. A Senate cochairman and a House cochairman shall be elected by the~~

4 (a) The North Carolina Courts Commission is hereby created. Effective July 1,
5 1983, it shall consist of 24 members, six to be appointed by the Governor, six to be
6 appointed by the Speaker of the House of Representatives, six to be appointed by the
7 President Pro Tempore of the Senate, and six to be appointed by the Chief Justice of the
8 Supreme Court.

9 (b) Of the appointees of the Chief Justice of the Supreme Court, one shall be a
10 Justice of the Supreme Court, one shall be a Judge of the Court of Appeals, two shall be
11 judges of superior court, and two shall be district court judges.

12 (c) Of the six appointees of the Governor, one shall be a district attorney, one
13 shall be a practicing attorney, one shall be a clerk of superior court, at least three shall
14 be members or former members of the General Assembly, and at least one shall not be
15 an attorney.

16 (d) Of the six appointees of the Speaker of the House, at least three shall be
17 practicing attorneys, at least three shall be members or former members of the General
18 Assembly, and at least one shall not be an attorney.

19 (e) Of the six appointees of the President Pro Tempore of the Senate, at least
20 three shall be practicing attorneys, at least three shall be members or former members of
21 the General Assembly, and at least one shall be a magistrate.

22 (f) Of the initial appointments of each appointing authority, three shall be
23 appointed for four-year terms to begin July 1, 1983, and three shall be appointed for
24 two-year terms to begin July 1, 1983. Successors shall be appointed for four-year
25 terms.

26 (g) A vacancy in membership shall be filled for the remainder of the unexpired
27 term by the appointing authority who made the original appointment. A member whose
28 term expires may be reappointed."
29

30 -JUVENILE LAW STUDY COMMISSION

31 Sec. 8. G.S. 7A-740 reads as rewritten:

32 "**§ 7A-740. Creation; members; terms; qualifications; vacancies.**

33 (a) The Juvenile Law Study Commission is hereby created. It shall consist of 18
34 voting members, 14 to be appointed by the Governor, two by the President Pro Tempore
35 of the Senate, and two by the Speaker of the House of Representatives. The members
36 appointed by the President Pro Tempore of the Senate shall be members of the Senate at
37 the time of their appointment; the members appointed by the Speaker of the House of
38 Representatives shall be members of the House of Representatives at the time of their
39 appointment. Of the members appointed by the Governor, two shall be district court
40 judges, one from an urban district, one from a rural. Three shall be a chief court
41 counselor and two court counselors representing the Intake Division, one from an urban
42 district, one from a rural. Two shall be from Social Services, one from the State level
43 and one from the county. One shall be from the Division of Youth Services. One shall
44 be from a local facility of Community Based Alternatives. One shall be a youth

1 member representing the youth of the State who shall be a person under the age of 21 at
2 the time of the appointment, who shall serve for one year. One shall be a State or local
3 representative of the Guardian Ad Litem Services of the Administrative Office of the
4 Courts, who shall serve for two years. One shall be from Law Enforcement. One shall
5 be from the North Carolina Juvenile Detention Association. One shall be the member
6 of the Juvenile Justice Planning Committee of the Governor's Crime Commission
7 recommended for appointment by the Juvenile Justice Planning Committee and shall
8 serve for three years. The district court judges and the Social Services members shall
9 serve for three years. The chief court counselor and the court counselors shall serve for
10 two years. The representatives from the Division of Youth Services, Law Enforcement,
11 Community Based Alternatives, and the Juvenile Detention Association shall serve for
12 one year. The legislative members shall serve for two-year terms. All initial terms shall
13 begin July 1, 1980.

14 (b) A vacancy in membership shall be filled by the appointing authority who
15 made the initial appointment. When the members' terms expire, their successors shall
16 serve for the same length of time their predecessors served. A member whose term
17 expires may be reappointed. If, when a term expires, the appointing authority has not
18 filled the vacancy, the member whose term has expired shall continue to serve until the
19 appointment is made."

37 Chief, Office of Health Education, Department of Human
38 Resources; the Chief, State Health Planning and Development

9 member from a list of three names submitted by the North
10 Carolina Association for Health, Physical Education, and
11 Recreation; one member from a list of three names submitted
12 by the North Carolina Public Health Association; one member
13 from a list of three names submitted by the North Carolina
14 College Conference on Professional Preparation in Health and
15 Physical Education. The State Board nominees shall represent
16 local school administrative units and shall have been
17 recommended by the Superintendent of Public Instruction. The
18 Speaker's nominee shall be a member of the North Carolina
19 House of Representatives and the President Pro Tempore of the
20 Senate's nominee shall be a member of the Senate."

22 –COUNCIL ON EDUCATIONAL SERVICES FOR EXCEPTIONAL CHILDREN

23 Sec. 12. G.S. 115C-121(b) reads as rewritten:

24 "(b) The Council shall consist of 17 members to be appointed as follows: two
25 members appointed by the Governor; two members of the Senate appointed by the
26 ~~Lieutenant Governor~~ President Pro Tempore; two members of the House of
27 Representatives appointed by the Speaker of the House; and 11 members appointed by
28 the State Board of Education. Of those members of the Council appointed by the State
29 Board one member shall be selected from each congressional district within the State,
30 and the members so selected shall be composed of at least one person representing each
31 of the following: handicapped individuals, parents or guardians of children with special
32 needs, teachers of children with special needs, and State and local education officials
33 and administrators of programs for children with special needs. The Council shall
34 designate a chairperson from among its members. The designation of the chairperson is
35 subject to the approval of the State Board of Education. The board shall promulgate
36 rules or regulations to carry out this subsection.

37 Ex officio members of the Council shall be the following:

- 38 (1) The Secretary of the Department of Human Resources or the
39 Secretary's designee;
- 40 (2) The Secretary of the Department of Correction or the Secretary's
41 designee;
- 42 (3) A representative from The University of North Carolina Planning
43 Consortium for Children with Special Needs; and

1 (4) The Superintendent of Public Instruction or the Superintendent's
2 designee.

3 The term of appointment for all members except those appointed by the State Board

43 "**§ 164-14. Membership; appointments; terms; vacancies.**

1 (a) The Commission shall consist of 12 members, who shall be appointed as
2 follows:

- 3 (1) One member, by the president of the North Carolina State Bar;
- 4 (2) One member, by the General Statutes Commission;
- 5 (3) One member, by the dean of the school of law of the University of
6 North Carolina;
- 7 (4) One member, by the dean of the school of law of Duke University;
- 8 (5) One member, by the dean of the school of law of Wake Forest
9 University;
- 10 (6) One member, by the Speaker of the House of Representatives of each
11 General Assembly from the membership of the House;
- 12 (7) One member, by the President Pro Tempore of the Senate of each
13 General Assembly from the membership of the Senate;
- 14 (8) Two members, by the Governor;
- 15 (9) One member, by the dean of the school of law of North Carolina
16 Central University;
- 17 (10) One member by the president of the North Carolina Bar Association;
- 18 (11) One member, by the dean of the school of law of Campbell College.

19 (b) Appointments of original members of the Commission made by the president
20 of the North Carolina State Bar, the president of the North Carolina Bar Association,
21 and the deans of the schools of law of Duke University, the University of North
22 Carolina, and Wake Forest University shall be for one year. Appointments of original
23 members of the Commission made by the Speaker of the House of Representatives, the
24 President of the Senate, and the Governor shall be for two years.

25 (c) After the appointment of the original members of the Commission,
26 appointments by the president of the North Carolina State Bar, the General Statutes
27 Commission, and the deans of the schools of law of North Carolina Central University,
28 Duke University, the University of North Carolina, and Wake Forest University shall be
29 made in the even-numbered years, and appointments made by the Speaker of the House
30 of Representatives, the President Pro Tempore of the Senate, president of the North
31 Carolina Bar Association, the dean of the School of Law of Campbell College and the
32 Governor shall be made in the odd-numbered years. Such appointments shall be made
33 for two-year terms beginning June first of the year when such appointments are to
34 become effective and expiring May 31 two years thereafter. All such appointments
35 shall be made not later than May 31 of the year when such appointments are to become
36 effective.

37 (d) If any appointment provided for by this section is not made prior to June first
38 of the year when it should become effective, a vacancy shall exist with respect thereto,
39 and the vacancy shall then be filled by appointment by the Governor. If any member of
40 the Commission dies or resigns during the term for which he was appointed, his
41 successor for the unexpired term shall be appointed by the person who made the original
42 appointment, as provided in G.S. 164-14, or by the successor of such person; and if such
43 vacancy is not filled within 30 days after the vacancy occurs, it shall then be filled by
44 appointment by the Governor. In any case where an appointment authorized to be made

1 by G.S. 164-14(c) has not been made on or before July 31 of the year in which it was
2 due to be made, a vacancy shall exist with respect to that appointment and the General
3 Statutes Commission at its next meeting shall by majority vote fill the vacancy by
4 appointment.

5 (e) All appointments shall be reported to the secretary of the Commission.

6 (f) Notwithstanding the expiration of the term of the appointment, the terms of
7 members of the General Statutes Commission shall continue until the appointment of a
8 successor has been made and reported to the secretary of the Commission."

9 Sec. 33. This act applies to any appointments for terms beginning on or after
10 January 1, 1993, and also applies to the filling of any unexpired terms where the term
11 began before that date but the vacancy occurs on or after that date.
