1	A BILL TO BE ENTITLED
2	AN ACT TO APPROPRIATE FUNDS FOR THE MCSMILES PROGRAM, A
3	MOBILE PRESCHOOL PROGRAM FOR PRESCHOOL-AGED CHILDREN
4	AND THEIR PARENTS.
5	Whereas, in the years before the McSmiles Mobile Classroom was
6	implemented in McDowell County, there was the concern that many of the children in
7	the county were coming to school with poor backgrounds in social and preschool
8	readiness; and
9	Whereas, kindergarten teachers were having to teach basic preparatory skills
10	in language development, gross and fine motor skills, visual and auditory development,
11	and social skills; and
12	Whereas, in an effort to make each child feel safe and secure and good about
13	himself or herself so that the child would be able to move forward toward full potential
14	according to the child's stage of readiness, McDowell County implemented the
15	McSmiles Program; and
16	Whereas, the McSmiles Program is based on a nationally validated diffusion
17	program designed to prevent school failure through early intervention of children's
18	developmental skills and learning styles; and
19	Whereas, the McSmiles Program uses a teacher and a teacher assistant on a
20	retired school bus refurbished similar to a classroom to bring the program to the
21	children and their parents in their communities; and
22	Whereas, because of the McSmiles Program, children are coming to
23	kindergarten eager to learn, eager to participate in small and large group activities, and
24	eager to read and write; and
25	Whereas, the McSmiles Program involves the parents and the communities in
26	preparing their four-year-olds for kindergarten; and
27	Whereas, the McSmiles Program allows for health and other needed services
28	to be identified and appropriate referrals made; and

Whereas, children throughout the State would benefit from a McSmiles
 Program based on the McDowell County McSmiles Program; Now therefore,

3 The General Assembly of North Carolina enacts:

Section 1. There is appropriated from the General Fund to the Department of
Public Education, Aid to Local School Administrative Units, the sum of ten million
dollars (\$10,000,000) for the 1993-94 fiscal year and the sum of twenty million dollars
(\$20,000,000) for the fiscal year for teachers and teacher assistants to implement a
Mobile Classroom Instructional Laboratory of Education Success Program (the
McSmiles Program), beginning January 1, 1994. All other costs of the McSmiles
Program shall be met with non-State funds.

11 The McSmiles Program shall be a mobile preschool program for all unserved 12 four-year-old children in the State, which is based on the McSmiles Program in 13 McDowell County. The goal of the program shall be to prevent school failure through

- 14 early identification of developmental needs and learning styles of preschool children.
- 15 Sec. 2. This act becomes effective July 1, 1993.
