A BILL TO BE ENTITLED

AN ACT TO AUTHORIZE THE ISSUANCE OF ELEVEN MILLION FOUR 2 3 HUNDRED THOUSAND DOLLARS GENERAL OBLIGATION BONDS OF THE STATE, SUBJECT TO A VOTE OF THE QUALIFIED VOTERS OF THE 4 STATE, TO PROVIDE FUNDS, WITH ANY OTHER AVAILABLE FUNDS, 5 FOR CAPITAL IMPROVEMENTS FOR FACILITIES FOR THE HEAD START 6 7 PROGRAM. 8 The General Assembly of North Carolina enacts: 9 Section 1. Short title. This act shall be known and may be cited as the "Head 10 Start Facilities Bond Act". 11 Sec. 2. Purpose. It is the intent and purpose of the General Assembly by this act to provide for the issuance of general obligation bonds of the State in order to 12 facilitate the payment of certain capital costs required in providing new facilities and 13 improving existing facilities to be used by entities providing services under the "Head 14 Start" program, a program delivering comprehensive health, educational, nutritional, 15 social, and other services to economically disadvantaged children, primarily children 16 who have not reached the age of compulsory school attendance. These services are 17 18 delivered to the children directly as well as indirectly through parent and child services 19 and services to disadvantaged expectant mothers.

20 Sec. 3. Definitions. As used in this act, unless the context otherwise 21 requires:

16	Sec. 5. Uses of bond and note proceeds. The proceeds of Head Start				
17	Facilities Bonds and notes shall be used, together with other available funds, for the				
18	purpose of providing (i) grants by the State, (ii) loans by the State, (iii) grants by the				
19	State to the Center for Community Self-Help, a nonprofit corporation, for a revolving				
20	loan fund for loans, or (iv) a combination of these grants and loans, to provide funds to				
21	local private nonprofit corporations and public agencies administering Head Start				
22	programs for the payment of the cost of acquiring, constructing, reconstructing,				
23	renovating, equipping, and improving classroom facilities for the existing Head Star				
24	programs, including, without limitation, the acquisition of land. The classroom				
25	facilities may include, in addition to classrooms, rooms in which health, educational,				
26	nutritional, social, and other services are delivered to economically disadvantaged				
27	children, disadvantaged children and their parents, and disadvantaged expectant

29	The contribution to be made by the State shall be made only to nonprofit				
30	corporations and public agencies receiving monies from the federal government under				
31	the federal Head Start program. The contribution by the State shall be made pursuant to				
32	agreements between the State by the Department of Human Resources and the nonprofit				
33	corporations or pursuant to rules and regulations of the Department of Human				
34	Resources having application to public agencies. The agreements and the rules and				
35	regulations shall contain provisions necessary to assure that the proceeds of the bonds				
36	and notes are applied for the accomplishment of public purposes only, within the				
37	meaning of Article V, Section 2(7) of the North Carolina Constitution, including,				
38	without limitation, provisions to assure that facilities provided or improved shall be

7 Sec. 4. Authorization of bonds and notes. Subject to a favorable vote of a 8 majority of the qualified voters of the State who vote on the question of issuing Head 9 Start Facilities Bonds in the election held as provided in this act, the State Treasurer is 10 authorized, by and with the consent of the Council of State, to issue and sell, at one time or from time to time, general obligation bonds of the State to be designated "State of 11 12 North Carolina Head Start Facilities Bonds", with any additional designations as may be 13 determined to indicate the issuance of bonds from time to time, or notes of the State as 14 provided in this act, in an aggregate principal amount not exceeding eleven million four 15 hundred thousand dollars (\$11,400,000) for the purposes authorized in this act.

(1)Title to real property shall vest in the nonprofit corporations, in the 1 2 public agency, in the county in which the facilities are located, or in 3 another public agency. If State funds are to be used in connection with the construction of 4 (2)5 facilities to be owned by a nonprofit corporation, the nonprofit 6 corporation must comply with the applicable provision of Article 8 of 7 Chapter 143 of the General Statutes of North Carolina concerning 8 public bidding for construction and acquisition of equipment. State funds shall be provided at the sole discretion of the Secretary of 9 (3) 10 Human Resources following a review of applications. The applications are to document the need for additional space or 11 12 equipment to meet Head Start needs. The documentation shall state 13 why funds are needed; identify companion sources of funding; contain 14 the endorsement of the county in which the proposed project is or will 15 be located; identify the specific activities to be achieved including a 16 schedule of events; and contain a description of the anticipated impact 17 in the community. The Secretary of Human Resources shall give priority to Head Start 18 (4) programs that must complete renovations or add new facilities in order 19 20 to meet State and local safety, health, and other licensing requirements.

21 The General Assembly may change from time to time any of the foregoing 22 requirements.

Sec. 6. Allocation of proceeds. The proceeds of Head Start Facilities Bonds and notes, including premium thereon, if any, except the proceeds of bonds the issuance of which has been anticipated by bond anticipation notes or the proceeds of refunding bonds or notes, shall be placed by the State Treasurer in a special fund to be designated "Head Start Facilities Bonds Fund". Moneys in the Head Start Facilities Bonds Fund shall be used for the purposes set forth in this act.

Projected allocations may be increased to reflect the availability of other funds, including, without limitation, contingency funds, income earned on the investment of bond and note proceeds, and the proceeds of any grants.

The Office of State Budget and Management shall provide quarterly reports to the Chairs of the Appropriations Committee and the Base Budget Committee in the Senate, the Chair of the Appropriations Committee in the House of Representatives, the Joint Legislative Commission on Governmental Operations, and the Fiscal Research Division as to the projects funded under this act.

Sec. 7. Election. The question of the issuance of the bonds authorized by this act shall be submitted to the qualified voters of the State at an election to be held on the first Tuesday after the first Monday of November 1993. Any other primary, election, or referendum validly called or scheduled by law at the time the election on the bond questions provided for in this section is held may be held as called or scheduled. Notice of the election on the bond question shall be given by publication twice in a newspaper or newspapers having general circulation in each county in the State, and the election and the registration of voters therefor shall be held under and in accordance with the
 general laws of the State. Absentee ballots shall be authorized in the election.

The State Board of Elections shall reimburse the counties of the State for all necessary expenses incurred in holding the election which are in addition to those which would have otherwise been incurred; this reimbursement shall be paid out of the Contingency and Emergency Fund or other funds available to the State Board of Elections.

8 Voting machines, ballots, or both may be used in accordance with rules 9 prescribed by the State Board of Elections. The bond question to be used in the voting 10 machines and ballots shall be in substantially the following form:

19 20 "[] FOR the issuance of eleven million four hundred thousand dollars (\$11,400,000) State of North Carolina Head Start Facilities Bonds, constituting general obligation bonds of the State secured by a pledge of the faith and credit and taxing power of the State for making contributions by the State to public agencies and nonprofit corporations for the purpose of providing funds, together with any other available funds, to pay the cost of providing and equipping facilities for use by these entities in delivering comprehensive health, educational, nutritional, social, and other services, primarily to preschool children and their parents.

AGAINST the issuance of eleven million four hundred thousand 21 [] dollars (\$11,400,000) State of North Carolina Head Start Facilities 22 Bonds, constituting general obligation bonds of the State secured by a 23 24 pledge of the faith and credit and taxing power of the State for making contributions by the State to public agencies and nonprofit 25 corporations for the purpose of providing funds, together with any 26 27 other available funds, to pay the cost of providing and equipping facilities for use by these entities in delivering comprehensive health, 28 29 educational, nutritional, social, and other services, primarily to 30 preschool children and their parents."

If a majority of those voting on the bond question in the election vote in favor of the issuance of the bonds described in the question, those bonds may be issued as provided in this act. If a majority of those voting on the bond question in the election vote against the issuance of the bonds described in the question, those bonds shall not be issued.

The results of the election shall be canvassed and declared as provided by law for elections for State officers; the results of the election shall be certified by the State Board of Elections to the Secretary of State, in the manner and at the time provided by the general election laws of the State.

Sec. 8. Issuance of bonds and notes. (a) Terms and conditions. Bonds or notes may bear such date or dates, may be serial or term bonds or notes, or any combination thereof, may mature in such amounts and at such time or times, not exceeding 40 years from their date or dates, may be payable at such place or places, either within or without the United States of America, in such coin or currency of the United States of America as at the time of payment is legal tender for payment of public and private debts, may bear interest at such rate or rates, which may vary from time to time, and may be made redeemable before maturity, at the option of the State or otherwise as may be provided by the State, at such price or prices, including a price less than the face amount of the bonds or notes, and under such terms and conditions, all as may be determined by the State Treasurer, by and with the consent of the Council of State.

7 Signatures; form and denomination; registration. Bonds or notes may be (b) 8 issued as certificated or uncertificated obligations. If issued as certificated obligations, 9 bonds or notes shall be signed on behalf of the State by the Governor or shall bear his 10 facsimile signature, shall be signed by the State Treasurer or shall bear his facsimile signature, and shall bear the Great Seal of the State or a facsimile thereof shall be 11 12 impressed or imprinted thereon. If bonds or notes bear the facsimile signatures of the 13 Governor and the State Treasurer, the bonds or notes shall also bear a manual signature 14 which may be that of a bond registrar, trustee, paying agent, or designated assistant of 15 the State Treasurer. Should any officer whose signature or facsimile signature appears 16 on bonds or notes cease to be such officer before the delivery of the bonds or notes, the 17 signature or facsimile signature shall nevertheless have the same validity for all 18 purposes as if the officer had remained in office until delivery and bonds or notes may 19 bear the facsimile signatures of persons who at the actual time of the execution of the 20 bonds or notes shall be the proper officers to sign any bond or note although at the date 21 of the bond or note such persons may not have been such officers. The form and denomination of bonds or notes, including the provisions with respect to registration of 22 23 the bonds or notes and any system for their registration, shall be as the State Treasurer 24 may determine in conformity with this act; provided, however, that nothing in this act 25 shall prohibit the State Treasurer from proceeding, with respect to the issuance and form of the bonds or notes, under the provisions of Chapter 159E of the General Statutes, the 26 27 Registered Public Obligations Act, as well as under this act.

28 (c) Manner of sale; expenses. Subject to determination by the Council of State as 29 to the manner in which bonds or notes shall be offered for sale, whether at public or 30 private sale, whether within or without the United States of America, and whether by publishing notices in certain newspapers and financial journals, mailing notices, inviting 31 32 bids by correspondence, negotiating contracts of purchase or otherwise, the State Treasurer is authorized to sell bonds or notes at one time or from time to time at such 33 34 rate or rates of interest, which may vary from time to time, and at such price or prices, 35 including a price less than the face amount of the bonds or the notes, as the State 36 Treasurer may determine. All expenses incurred in preparation, sale, and issuance of 37 bonds or notes shall be paid by the State Treasurer from the proceeds of bonds or notes 38 or other available moneys.

- 40 (1) By and with the consent of the Council of State, the State Treasurer is 41 hereby authorized to borrow money and to execute and issue notes of 42 the State for the same, but only in the following circumstances and 43 under the following conditions:

4 Sec. 9. Variable interest rates. In fixing the details of bonds and notes, the 5 State Treasurer may provide that any of the bonds or notes may:

- 6 (1)Be made payable from time to time on demand or tender for purchase 7 by the owner thereof provided a credit facility supports the bonds or 8 notes, unless the State Treasurer specifically determines that a credit 9 facility is not required upon a finding and determination by the State 10 Treasurer that the absence of a credit facility will not materially or adversely affect the financial position of the State and the marketing of 11 12 the bonds or notes at a reasonable interest cost to the State; 13
 - (2)Be additionally supported by a credit facility;
- Be made subject to redemption or a mandatory tender for purchase 14 (3) 15 prior to maturity;
- 16 (4) Bear interest at a rate or rates that may vary for such period or periods 17 of time, all as may be provided in the proceedings providing for the 18 issuance of the bonds or notes, including, without limitation, such 19 variations as may be permitted pursuant to a par formula; and 20
 - Be made the subject of a remarketing agreement whereby an attempt is (5) made to remarket bonds or notes to new purchasers prior to their presentment for payment to the provider of the credit facility or to the State.

24 If the aggregate principal amount repayable by the State under a credit facility 25 is in excess of the aggregate principal amount of bonds or notes secured by the credit facility, whether as a result of the inclusion in the credit facility of a provision for the 26 27 payment of interest for a limited period of time or the payment of a redemption premium or for any other reason, then the amount of authorized but unissued bonds or 28 29 notes during the term of such credit facility shall not be less than the amount of such 30 excess, unless the payment of such excess is otherwise provided for by agreement of the 31 State executed by the State Treasurer.

32 Sec. 10. Interpretation of act. (a) Additional method. The foregoing sections of this act shall be deemed to provide an additional and alternative method for the doing of 33 34 the things authorized thereby and shall be regarded as supplemental and additional to 35 powers conferred by other laws, and shall not be regarded as in derogation of any 36 powers now existing.

37 Statutory references. References in this act to specific sections or Chapters of (b) the General Statutes or to specific acts are intended to be references to these sections, 38 39 Chapters, or acts as they may be amended from time to time by the General Assembly.

40 Liberal construction. This act, being necessary for the health and welfare of (c) the people of the State, shall be liberally construed to effect the purposes thereof. 41

42 Inconsistent provisions. Insofar as the provisions of this act are inconsistent (d)with the provisions of any general laws, or parts thereof, the provisions of this act shall 43 44 be controlling.

1 (e) Severability. If any provision of this act or the application thereof to any 2 person or circumstance is held invalid, such invalidity shall not affect other provisions 3 or applications of the act which can be given effect without the invalid provision or 4 application, and to this end the provisions of this act are declared to be severable.

5 Sec. 11. Effective date. This act is effective upon ratification.
