Section 1. G.S. 130A-291.1 is amended by adding three new subsections to read:

- "(g) The Department shall establish and administer a wastewater pump and haul management program or any other programs that the Department determines are necessary to provide existing rural primary residences that are not served by properly functioning on-site wastewater systems or connected to public or community sanitary sewage systems, or that are using privies for domestic sewage disposal. This program shall serve as a model for any local programs that are established under subsection (b) of this section. The Department shall publish a comprehensive on-site wastewater management manual to enhance the use, design, construction, operation, and maintenance of such systems.
- (h) The Department may approve the use of the pump and haul method of wastewater management and the establishment of a local pump and haul management program when:
 - (1) The local health department has determined that a residence cannot be served by a properly functioning on-site wastewater system and cannot be served by a public or community sanitary sewage system.

1	<u>(2)</u>	The residence was constructed prior to July 1, 1993.
2	<u>(3)</u>	The residence is used as a primary dwelling unit.
3	<u>(4)</u>	Either the county or the municipality in which the residence is located
4	, ,	will establish a pump and haul management program that will include
5		any necessary rules, fees, and remedies.
6	<u>(5)</u>	Either the county or the municipality in which the residence is located
7		will administer and manage the local program for the pump and haul
8		method of wastewater collection, treatment, and disposal.
9	<u>(6)</u>	The septage collected from such residences will be disposed of and
10		treated in facilities approved by the Department.
11	<u>(i)</u> A cou	anty or municipality may enter into contracts in order to implement its
12	pump and haul n	nanagement program established under subsection (h) of this section."
13	Sec. 2	2. There is appropriated from the General Fund to the Department of
14	Environment, H	lealth, and Natural Resources the sum of one million two hundred
15	thousand dollars	s (\$1,200,000) for the 1993-94 fiscal year to implement this act. The
16	funds appropriat	ted shall be used as follows:
17	(1)	The Department shall use \$100,000 for costs of publishing a
18		comprehensive on-site wastewater management manual pursuant to
19		G.S. 130A-291.1(g), as enacted by Section 1 of this act; and
20	(2)	The Department shall distribute the remaining \$1,100,000 as grants to
21		units of local government for the following:
22		a. Construction, expansion, or modifications of wastewater
23		treatment and disposal facilities to render them able to handle
24		pump and haul wastes managed under the pump and haul
25		management program.
26		b. Renovation of existing residences to provide holding tanks that
27		are constructed to separately receive storage waste for the water
28		closets and kitchen sink (black water) and all other wastewaters
29		(grey water).
30		c. Purchase of necessary equipment required by a county or
31		municipality for the hauling of the wastewater to a wastewater
32		treatment and disposal facility.
33		The Department shall determine the number of grants to award and the
34		amount of each grant.
35	Sec. 3	. This act becomes effective July 1, 1993.
