HOUSE JOINT RESOLUTION 1495

Sponsors: Representative Jack Hunt.

Referred to: Rules, Calendar and Operations of the House.

May 26, 1993

1 A JOINT RESOLUTION SETTING THE TIME FOR ADJOURNMENT OF THE
2 1993 GENERAL ASSEMBLY TO MEET IN 1994, AND LIMITING THE
3 SUBJECTS THAT MAY BE CONSIDERED IN THAT SESSION.

4 Be it resolved by the House of Representatives, the Senate concurring:

5 Section 1. At 4:00 p.m. on Thursday, July 1, 1993, the House of
6 Representatives and the Senate shall adjourn to reconvene at noon on Tuesday, May 24,
7 1994. During that session only the following matters may be considered:

8 (1) Bills directly and primarily affecting the State budget for fiscal year
9 1994-95, provided that no appropriations or finance bill may be
10 introduced in the House of Representatives or filed for introduction in
11 the Senate after Tuesday, June 7, 1994, provided that any such
12 measure submitted to the Bill Drafting Division of the Legislative
13 Services Office by 4:00 p.m. on that date and filed for introduction in
14 the Senate or introduced in the House of Representatives by 5:00 p.m.
15 on Thursday, June 9, 1994, shall be treated as if it had met the
16 deadlines established by this subdivision.

17 (2) Bills introduced in 1993 and having passed third reading in 1993 in the
18 house in which introduced, received in the other house, and not
19 disposed of in the other house by tabling, unfavorable committee
20 report, indefinite postponement, or failure to pass any reading, and
21 does not violate the rules of either body.

22 (3) Bills implementing the recommendations of study commissions
23 authorized or directed to report to the 1994 Session. Any bills

1 authorized by this subdivision must be filed for introduction in the
2 Senate or introduced in the House of Representatives no later than 5:00
3 p.m. on Thursday, May 26, 1994, provided that any such measure
4 submitted to the Bill Drafting Division of the Legislative Services
5 Office by 4:00 p.m. on that date and filed for introduction in the Senate
6 or introduced in the House of Representatives by 5:00 p.m. on
7 Tuesday, May 31, 1994, shall be treated as if it had met the deadlines
8 established by this subdivision.

9 (4) Any local bill introduced in the House of Representatives or filed for
10 introduction in the Senate by 5:00 p.m. on Tuesday, May 31, 1994,
11 and accompanied by a certificate signed by the principal sponsor
12 stating that no public hearing will be required or asked for by a
13 member on the bill, the bill is noncontroversial, and the bill is
14 approved for introduction by each member of the House of
15 Representatives and Senate whose district includes the area to which
16 the bill applies, provided that any such measure submitted to the Bill
17 Drafting Division of the Legislative Services Office by 4:00 p.m. on
18 that date and filed for introduction in the Senate or introduced in the
19 House of Representatives by 5:00 p.m. on Thursday, June 2, 1994,
20 shall be treated as if it had met the deadlines established by this
21 subdivision.

22 (5) Selection, appointment, or confirmation of members of State boards
23 and commissions as required by law, including the filling of vacancies
24 of positions for which the appointees were elected by the General
25 Assembly upon recommendation of the Speaker of the House of
26 Representatives, President of the Senate, or President Pro Tempore of
27 the Senate.

28 (6) Any matter authorized by joint resolution passed during the 1994
29 Session by two-thirds majority of the members of the House of
30 Representatives present and voting and by two-thirds majority of the
31 members of the Senate present and voting. A bill or resolution filed in
32 either house under the provisions of this subsection shall have a copy
33 of the ratified enabling resolution attached to the jacket before filing
34 for introduction in the Senate or introduction in the House of
35 Representatives.

36 (7) Any bills primarily affecting any State or local pension or retirement
37 system, introduced in the House of Representatives or filed for
38 introduction in the Senate by 5:00 p.m. on Tuesday, May 31, 1994,
39 provided that any such measure submitted to the Bill Drafting Division
40 of the Legislative Services Office by 4:00 p.m. on that date and filed
41 for introduction in the Senate or introduced in the House of
42 Representatives by 5:00 p.m. on Thursday, June 2, 1994, shall be
43 treated as if it had met the deadlines established by this subdivision.

- 1 (8) Joint resolutions, House resolutions, and Senate resolutions pertaining
2 to Section 5(10) of Article III of the Constitution of North Carolina.
- 3 (9) A joint resolution adjourning the 1993 Regular Session, **sine die**.
- 4 Sec. 2. The Speaker of the House of Representatives or the President Pro
5 Tempore of the Senate may authorize appropriate committees or subcommittees of their
6 respective houses to meet during the interim between sessions to:
- 7 (1) Review matters related to the State budget for the 1993-95 biennium,
8 (2) Prepare reports, including revised budgets, or
9 (3) Consider any other matters as the Speaker of the House of
10 Representatives or the President Pro Tempore of the Senate deems
11 appropriate,
- 12 except that no committee or subcommittee of a house may consider, after the date of
13 adjournment provided in Section 1 of this resolution and before the date of reconvening
14 provided in Section 1 of this resolution, any bill, or proposed committee substitute for
15 such bill, which originated in the other house. A conference committee may meet in the
16 interim upon approval by the Speaker of the House of Representatives or the President
17 Pro Tempore of the Senate.
- 18 Sec. 3. This resolution is effective upon ratification.
