A BILL TO BE ENTITLED

1 AN ACT TO EARMARK FUNDS FOR ALTERNATIVE LEARNING PROGRAMS
2 UNDER THE INTERVENTION/PREVENTION GRANT PROGRAM.
3

4 Whereas, the Alternative Schools Committee of the Legislative Research
5 Commission of the 1993 General Assembly has studied the issue of alternative schools
6 and has reported to the Legislative Research Commission that it supports earmarking
7 funds to continue or create alternative learning programs in all school systems; and

8 Whereas, the Alternative Schools Committee of the Legislative Research
9 Commission of the 1993 General Assembly suggested that these programs should serve
10 at-risk students at all levels; have a well-defined mission; use multiple strategies
11 including serving children in the standard classroom and in separate facilities and
12 programs; have strong community involvement; have high expectations for staff and
13 students; and have a strong program evaluation component; and

14 Whereas, the 1994 Extra Session of the General Assembly created and funded
15 the Intervention/Prevention Grant Program to target at-risk students in areas where there
16 is a high incidence of juvenile crime; and

17 Whereas, the Intervention/Prevention Grant Program allows counties to apply
18 to use funds under the Program to create alternative learning programs but does not
19 especially earmark funds for alternative learning programs only; Now, therefore,
20 The General Assembly of North Carolina enacts:

21 Section 1. G.S. 115C-238.41(c) reads as rewritten:

22 "(c) The application shall include the following information:

- 1 (1) Data on the incidence of juvenile crime in the geographical area to be
2 served by the grant. Sources of data may include the chief juvenile
3 court counselor in the judicial district, the clerk of superior court, and
4 local law enforcement officials.
- 5 (2) An assessment of local resources from all sources for, and local
6 deficiencies with regard to, responding to the needs of children who
7 live in conditions that place them at risk of school failure. This
8 assessment shall be prepared by the local task force.
- 9 (3) A detailed plan for removing barriers to success in school that exist for
10 these children and for minimizing disruptive and violent behavior
11 among all students. This plan shall include proposed goals and
12 anticipated outcomes, prepared after consultation with the task force.
13 This plan shall provide for the establishment or expansion of programs
14 that have components based on one or more of the following models or
15 other collaborative models:
- 16 a. School-based Resource Center Model. – A School-based
17 Resource Center is a school-based center that coordinates the
18 delivery of comprehensive and integrated services in or near a
19 school to children from kindergarten through the eighth grade
20 and their families. Services are provided through broad-based
21 collaboration among governmental and nongovernmental
22 agencies and persons reflective of the racial and socioeconomic
23 diversity in a community. Services are designed to (i) prepare
24 children to attain academic and social success, (ii) enhance the
25 ability of families to become advocates for and supporters of
26 education for the children in their families, (iii) provide
27 parenting classes to the parents of children who are at risk of
28 school failure, and (iv) otherwise enhance the ability of families
29 to function as nurturing and effective family units.
- 30 b. After School Program Model. – An After School Program is a
31 program that provides high quality educationally appropriate
32 and recreational activities to students after the regular school
33 day. The program may be targeted toward providing academic
34 support for students who perform significantly below their age-
35 level peers or for students with learning disabilities. Local
36 boards of education may permit teachers to adjust their work
37 schedules so they can work in the program.
- 38 c. Cities in Schools Program Model. – A Cities in Schools
39 Program is a community partnership among public agencies,
40 private nonprofit agencies, volunteer organizations, and local
41 businesses that delivers services to students who are at risk of
42 dropping out of school or who display discipline problems.
43 Services offered are based on an assessment of local needs and
44 resources.

1 d. Alternative Learning Program Model. —~~An~~—Alternative
 2 Learning Program ~~is a program that provides~~—Programs may be
 3 designed to serve students at any level, may use multiple
 4 strategies including serving students in the standard classroom
 5 or by providing individualized programs outside of a standard
 6 classroom setting in a caring atmosphere in which students
 7 learn the skills necessary to redirect their lives and return to a
 8 standard classroom setting. The—A program should maintain
 9 State standards and may include smaller classes and lower
 10 student/teacher ratios, school-to-work transition activities,
 11 modification of curriculum and instruction to meet individual
 12 needs, flexible scheduling, and necessary academic, vocational,
 13 and support services for students and their families. Services
 14 may also include appropriate measures to correct disruptive
 15 behavior, teach responsibility, good citizenship, and respect for
 16 rules and authority.

17 An alternative learning program should have a well-defined
 18 mission and high expectations for staff and students. The goals of the program should
 19 target ~~The goals of the alternative school programs should be to~~ (i) ~~reduce the school~~
 20 ~~dropout rate~~ reducing school dropout rates through improved student attendance,
 21 behavior, and educational ~~achievement;~~ achievement. and (ii) ~~When appropriate,~~
 22 programs should increase successful school-to-work transitions for students through
 23 educationally linked job internships, mentored job shadowing experiences, and the
 24 development of personalized education and career plans for participating students.

25 e. Safe Schools Program Model. – A Safe Schools Program is a
 26 locally designed program for making schools safe for students
 27 and school employees. The program may involve peer
 28 mediation and conflict resolution activities.

29 (4) A statement of whether and to what extent the local board of education
 30 intends to contract with local, private, nonprofit 501(c)(3) corporations
 31 to staff, operate, or otherwise provide services for one or more
 32 elements of the plan. Local boards are encouraged to contract for
 33 services, when appropriate.

34 (5) A statement of (i) how the grant funds would be used to address these
 35 local problems, (ii) what other resources, including Safe Schools
 36 Grants, Chapter 1 funds, Chapter 2 block grant funds, dropout
 37 prevention funds, Basic Education Program funds, remediation funds,
 38 small school system supplemental funds, and low-wealth counties
 39 supplemental funds, would be used to address the problems, and (iii)
 40 how all available community resources and the components of the
 41 proposed plan would be coordinated to enhance the effectiveness of
 42 existing services and of services proposed in the plan.

1 (6) A statement of how the proposed plan would assist a local school
2 administrative unit in implementing the local school improvement
3 plan.

4 (7) A process for assessing on an annual basis the success of the local plan
5 in addressing problems."

6 Sec. 2. There is appropriated from the General Fund to State Aid for Local
7 School Administrative Units the sum of five million dollars (\$5,000,000) to be used for
8 the 1994-95 fiscal year to implement alternative learning programs only under the
9 Intervention/Prevention Grant Program, Article 16 of Chapter 115C of the General
10 Statutes, as amended by this act. In awarding grants for alternative learning programs
11 under this act, the State Board of Education shall give first consideration to high quality
12 applications for alternative learning programs not selected for funding in the first round
13 of funding under the Intervention/Prevention Grant Program because the area to be
14 served by the applicant presented a lower incidence of juvenile crime than other
15 applications. New applications for high quality alternative learning programs serving
16 areas with varying incidences of juvenile crime may also be selected for funding under
17 this act.

18 Sec. 3. Of the funds appropriated under Section 42 of Chapter 24 of the 1994
19 Session Laws, up to two hundred thousand dollars (\$200,000) may be used by the
20 Department of Public Instruction to implement that section as amended by this act and
21 for program evaluation purposes.

22 Sec. 4. This act becomes effective July 1, 1994.
