A BILL TO BE ENTITLED

AN ACT TO REORGANIZE EDUCATION REPORTS, TO CLARIFY THE TERMS FOR A SCHOLARSHIP LOAN UNDER THE PRINCIPAL FELLOWS PROGRAM AND TO MAKE TECHNICAL AND CLARIFYING CHANGES TO THE EDUCATION LAWS.

The General Assembly of North Carolina enacts:

Section 1. G.S. 110-148(c)(5) reads as rewritten:

"(5) The State Board of Education shall, with the assistance of the Division of Community Schools, report to the General Assembly at the time of its convening on odd-numbered years the use of these funds and shall develop a State plan for the prevention of child abuse and neglect for submission to the Governor, the President of the Senate, and the Speaker of the House no later than January 1, 1987."

Sec. 2. G.S. 115C-21.1 reads as rewritten:

"§ 115C-21.1. ~~Biennial report on civic literacy; other reports.~~ Report on class size waivers.

(a) ~~The State Superintendent of Public Instruction shall submit a biennial report to the General Assembly on the implementation of G.S. 115C-81(g).~~

(b) The Department of Public Instruction shall monitor and provide a report to the General Assembly by May 1, 1991, and annually thereafter showing the school units that have been granted class size waivers pursuant to G.S. 115C-238.6(a), have reported

1 class size exceptions, and have converted State-funded teacher positions to other  
2 positions, dollars, or other expenditures."

3 Sec. 3. G.S. 115C-105.3 reads as rewritten:

4 **"§ 115C-105.3. Purpose.**

5 The purpose of the Commission is to develop high and clearly defined education  
6 standards for the public schools of North Carolina. These standards shall specify the  
7 skills and the knowledge that high school graduates should possess in order to be  
8 competitive in the modern economy. The purpose of the Commission is also to develop  
9 fair and valid assessments to assure that high school graduates in North Carolina meet  
10 these standards. No later than the Spring semester of the year 2000 or as soon as the  
11 State Board of Education adopts the standards and system of assessments, every  
12 graduating high school senior shall be required to achieve these standards as a condition  
13 for receiving a diploma.

14 These high standards and assessments shall focus on the key skills needed by  
15 students as they strive to be successful after high school and shall reflect the high  
16 expectations for every student demanded by the State's education mission in G.S. 115C-  
17 81(a), 115C-238.1, and 115C-238.13(a). Once these key skills are identified, parents,  
18 teachers, and the entire school community should be encouraged to help each student  
19 meet the student's fullest potential."

20 Sec. 4. G.S. 115C-105.5 reads as rewritten:

21 **"§ 115C-105.5. Reporting requirements.**

22 (1) No later than July 1, 1994, 1994, and annually thereafter, the  
23 Commission shall provide an initial a progress report on standards and  
24 assessments to the General Assembly, the Governor, and the State  
25 Board of Education. This report shall include progress include:

26 a. Progress being made on the development of standards,  
27 benchmarks, and related assessments. It shall also include  
28 recommendations assessments;

29 b. Recommendations for the education and training of educators to  
30 assist in incorporating standards into existing classrooms.  
31 implement the standards and assessments;

32 c. An estimation of (i) the number of students each year who are  
33 unlikely to achieve at their potential and the cost of the actions  
34 that should be taken to enable these students to achieve at their  
35 potential, and (ii) the number of students who are unlikely to  
36 meet the performance standards for high school graduation each  
37 year and the cost of the actions that should be taken to enable  
38 these students to meet the standards; and

39 d. An implementation schedule that includes field testing of the  
40 assessments, a public awareness campaign, public release of the  
41 assessment data, and the development of designations on  
42 graduation diplomas to reflect a student's achievement in the  
43 standards.

- 1           (2) ~~No later than July 1, 1996, The the Commission shall recommend to~~  
 2 ~~the State Board of Education standards and a system of assessments,~~  
 3 ~~and if the State Board adopts the standards and system of assessments,~~  
 4 ~~the Commission and the State Board shall use the following schedule:~~  
 5           a. ~~In the Spring semester of the 1994-95 school year, a field or~~  
 6 ~~pilot test of the system of assessments shall be given in a~~  
 7 ~~limited number of school units.~~  
 8           b. ~~During the 1994-95 school year, school personnel shall be~~  
 9 ~~educated and trained to implement the system of assessments.~~  
 10           e. ~~During the 1994-95 school year, there shall be a public~~  
 11 ~~awareness campaign regarding the standards and assessments.~~  
 12           d. ~~In the 1995-96 school year, standards shall be implemented in~~  
 13 ~~all school systems, and in the Spring semester of the 1995-96~~  
 14 ~~school year, the assessments shall be administered to all North~~  
 15 ~~Carolina high school seniors and in every local school~~  
 16 ~~administrative unit.~~  
 17           e. ~~In the Spring semester of the 1995-96 school year, the first set~~  
 18 ~~of assessment data shall be released publicly.~~  
 19           f. ~~During the 1995-96 and subsequent school years, appropriate~~  
 20 ~~designations shall be implemented on the diplomas of~~  
 21 ~~graduation to reflect the students' achievement.~~  
 22           g. ~~No later than the Spring semester of the year 2000, every~~  
 23 ~~graduating high school senior shall be required to achieve these~~  
 24 ~~standards as a condition for receiving a diploma.~~  
 25 assessments for the Board's consideration. No later than the year 2000 or as  
 26 soon as the State Board of Education adopts the standards and system  
 27 of assessments every graduating high school senior shall be required to  
 28 achieve these standards as a condition for receiving a diploma.

- 29           (3) ~~The Commission shall annually advise the General Assembly, the~~  
 30 ~~Governor, and the State Board of Education on the standards and~~  
 31 ~~assessments. In its report, the Commission shall estimate (i) the~~  
 32 ~~number of students each year who are unlikely to achieve at their~~  
 33 ~~potential and the cost of the actions that should be taken to enable~~  
 34 ~~these students to achieve at their potential, and (ii) the number of~~  
 35 ~~students who are unlikely to meet the performance standards for high~~  
 36 ~~school graduation each year and the cost of the actions that should be~~  
 37 ~~taken to enable these students to meet the standards."~~

38           Sec. 5. G.S. 115C-174.19 is repealed.

39           Sec. 6. G.S. 115C-238.17 reads as rewritten:

40           **"§ 115C-238.17. Annual assessment and reapproval of plans.**

41           (a) ~~Between March 15 and May 15~~ No later than May 31 of each subsequent year  
 42 of the project, the projects shall submit to the Department of Public Instruction any data  
 43 requested by the Department of Public Instruction or the State Board of Education and  
 44 any proposed changes in the projects. ~~No later than May 30 each year, the~~ The

1 Department shall review the data and the proposed changes in the plans for the projects  
2 and shall work with the project sites to assure that the plans carry out the provisions of  
3 this Part.

4 (b) ~~Between March 15 and June 1 of each subsequent year, the~~ The State Board of  
5 Education shall receive the data requested and the proposed changes in plans for  
6 projects from the project sites and shall receive the comments of the Department of  
7 Public Instruction regarding the data and the proposed changes in the projects. The  
8 State Board shall also consider the results of audits and evaluations performed pursuant  
9 to G.S. 115C-238.18.

10 (c) No later than ~~June~~ August 15 of each subsequent year, the State Board of  
11 Education shall reapprove the plans and any changes for the projects, reapprove the  
12 plans and any changes with modifications, or reject the plans.

13 (d) The project sites shall begin implementation immediately of projects  
14 reapproved, or reapproved with modifications, by the State Board."

15 Sec. 7. G.S. 115C-238.7(b) reads as rewritten:

16 "(b) The Task Force shall:

- 17 (1) Monitor the implementation of the School Improvement and  
18 Accountability Act of 1989, as amended, especially the development  
19 and implementation of building-level plans;
- 20 (2) Advise the Director of the Task Force on Site-Based Management on  
21 how to provide training and assistance to the public schools so as to  
22 facilitate the implementation of site-based management;
- 23 (3) Review ~~by September 1, 1992,~~ publications produced by the  
24 Department of Public Instruction on the development and  
25 implementation of building-level plans;
- 26 (4) Report annually to the General Assembly ~~within the first week of the~~  
27 ~~convening of the 1993 General Assembly and biennially thereafter~~ and the  
28 Joint Legislative Education Oversight Committee on the  
29 implementation of site-based management in the public ~~schools.~~  
30 schools on the first Friday in December. This report may contain a  
31 summary of recommendations for changes to any law, rule, and policy  
32 that would improve site-based management."

33 Sec. 8. Section 8 of Chapter 778 of the 1989 Session Laws reads as  
34 rewritten:

35 "Sec. 8. The ~~Department of Public~~ State Board of Education shall report ~~prior to May~~  
36 ~~1, 1990, and annually on the first Friday in February thereafter,~~ on the implementation of  
37 the School Improvement and Accountability Act of 1989, to the Joint Legislative  
38 Education Oversight Committee, the chairmen ~~chairs~~ of the Senate and House of  
39 Representatives committees on education, appropriations, and appropriations on  
40 education."

41 Sec. 9. G.S. 115C-238.24 reads as rewritten:

42 "**§ 115C-238.24. Grants of flexibility by the State Board.**

43 In implementing local projects, local boards need broad decision-making authority  
44 so that local boards and participating school leadership teams can carry out the activities

1 that meet the needs of students in that particular building. Each participating local  
2 school administrative unit may request from the State Board of Education, with  
3 specificity, those aspects of its project implementation that would be enhanced by  
4 flexibility with regard to statutes, policies, and regulations. Upon the recommendation  
5 of the State Superintendent, the State Board of Education may grant each local school  
6 administrative unit such flexibility with regard to Chapter 115C of the General Statutes,  
7 and its policies, and regulations, including the waivers allowed under G.S. 115C-  
8 238.6(a)(1) and (a)(2), as it finds necessary and appropriate to implement a local project  
9 so long as (i) the total amount of State funds expended for the project does not exceed  
10 the amount of State funds available for a school with that average daily membership; (ii)  
11 no health or safety standards relating to schools or school transportation are lowered;  
12 (iii) the State Board of Education does not find as a fact that the flexibility is being  
13 abused; (iv) the provisions of G.S. 115C-325 shall not be waived for any certificated  
14 teacher working in a Genesis school; and (v) the standard course of study is included in  
15 the education program offered to every child in the Genesis school.

16 Article 2A of Chapter 150B of the General Statutes shall not apply to actions by the  
17 State Board of Education when waiving its rules under this subsection.

18 The State Board of Education shall report annually on the first Friday in May on  
19 waivers granted with regard to statutes, policies, and regulations to the Joint Legislative  
20 Education Oversight Committee."

21 Sec. 10. G.S. 115C-325(i)(1) reads as rewritten:

22 "(1) The career teacher and superintendent will each have the right to  
23 designate not more than ~~30~~33 of the ~~121~~132 members of the  
24 Professional Review Committee as not acceptable to the teacher or  
25 superintendent respectively. No person so designated shall be  
26 appointed to the panel. The career teacher shall specify to the  
27 superintendent those Committee members who are not acceptable in  
28 his request for a review of the superintendent's proposed  
29 recommendations provided for in subdivision (h)(3) above. The  
30 superintendent's notice to the Superintendent of Public Instruction  
31 provided for in subdivision (h)(4) above shall contain a list of those  
32 members of the Committee not acceptable to the superintendent and  
33 the teacher respectively. Failure to designate nonacceptable members  
34 in accordance with this subsection shall constitute a waiver of that  
35 right."

36 Sec. 11. G.S. 115C-290.5(a) reads as rewritten:

37 "(a) The Board shall administer this Article. In fulfilling this duty, the Board  
38 shall:

- 39 (1) Develop and implement a North Carolina Public School Administrator  
40 Exam, based on the professional standards established by the Board.
- 41 (2) Establish and collect an application fee not to exceed fifty dollars  
42 (\$50.00), and an exam fee not to exceed one hundred fifty dollars  
43 (\$150.00). Fees collected under this Article shall be credited to the  
44 General Fund as nontax revenue.

- 1 (3) Review the educational achievements of an applicant to take the exam  
2 to determine whether the achievements meet the requirements set by  
3 G.S. 115C-290.7.
- 4 (4) Notify the State Board of Education of the names and addresses of the  
5 persons who passed the exam and are thereby qualified to be certified  
6 as public school administrators by the State Board of Education.
- 7 (5) Maintain accounts and records in accordance with the Executive  
8 Budget Act, Article 1 of Chapter 143 of the General Statutes.
- 9 (6) Adopt rules in accordance with Chapter 150B of the General Statutes  
10 to implement this Article.
- 11 (7) Submit an annual report by ~~March 1~~ December 1 of each year to the  
12 Joint Legislative Education Oversight Committee of its activities  
13 during the preceding year, together with any recommendations and  
14 findings regarding improvement of the profession of public school  
15 administration."

16 Sec. 12. (a) G.S. 116-74.43(b) reads as rewritten:

17 "(b) The State Education Assistance Authority shall forgive the loan and any  
18 interest accrued on the loan if, within six years after graduation from a school  
19 administrator program, exclusive of any authorized deferment for extenuating  
20 circumstances, the recipient serves for four years as a school administrator at a North  
21 Carolina public school or at a school operated by the United States government in North  
22 Carolina. The SEAA shall also forgive the loan if it finds that it is impossible for the  
23 recipient to work for four years, within ~~10~~ six years after completion of the two-year  
24 school administrator program supported by the scholarship loan at a North Carolina  
25 public school, or at a school operated by the United States government in North  
26 Carolina, because of the death or permanent disability of the recipient. If the recipient  
27 repays the scholarship loan by cash payments, all indebtedness shall be repaid within ~~10~~  
28 12 years after completion of the two-year school administrator program supported by  
29 the scholarship loan. If the recipient completes the school administrator program,  
30 payment of principal and interest shall begin no later than 27 months after the  
31 completion of the program. Should a recipient present extenuating circumstances, the  
32 State Education Assistance Authority may extend the period to repay the loan in cash to  
33 no more than a total of 15 years."

34 (b) This section is effective upon ratification and applies to scholarship loan  
35 contracts entered into by the State Education Assistance Authority on or after January 1,  
36 1994.

37 Sec. 12.1. G.S. 116C-3 reads as rewritten:

38 "**§ 116C-3. Strategic design for a continuum of education programs.**

39 The Education Cabinet shall develop a strategic design for a continuum of education  
40 programs. A continuum of education programs is the complement of programs  
41 delivered by the State to learners at all levels.

42 The new design shall take into account issues raised by the Government  
43 Performance Audit Committee of the Legislative Research Commission.

44 The design process shall:

- 1 (1) Include vigorous examination of all programs as if they were being  
2 created for the first time.
- 3 (2) Compare the existing structures, funding levels, and responsibilities of  
4 each system to the new design.
- 5 (3) Focus on issues concerning coursework articulation and plan for how  
6 to improve coursework articulation among existing providers of  
7 education.

8 The Education Cabinet shall report to the Joint Legislative Education Oversight  
9 Committee on the strategic design it develops prior to January 1, 1995."

10 Sec. 13. Section 6 of Chapter 199 of the 1993 Session Laws reads as  
11 rewritten:

12 "Sec. 6. The Board of Governors shall report on the design for the programs and the  
13 proposal process created in accordance with G.S. 116-74.21 to the Joint Legislative  
14 Education Oversight Committee no later than December 1, 1993. Requests for  
15 proposals shall be disseminated to the constituent institutions no later than January 15,  
16 1994. Proposals shall be submitted to the Board of Governors no later than June 1,  
17 1994. The Board of Governors shall then reconvene the panel of experts to screen the  
18 submitted proposals. After its screening, the panel shall make recommendations by  
19 September 1, 1994, to the Board of Governors. The Board of Governors shall choose  
20 the institutions that shall have school administrator programs no later than November 1,  
21 1994.

22 The Board of Governors shall report annually on the implementation of the act no  
23 later than December 1 of each year."

24 Sec. 14. Section 6 of Chapter 880 of the 1991 Session Laws reads as  
25 rewritten:

26 "Sec. 6. The Board of Governors shall coordinate a A-joint report of progress report  
27 made to develop a on the implementation of the system to provide an exchange of  
28 information-information among the public and independent colleges and universities, the  
29 community colleges, and the public schools. The report shall be made to the Joint  
30 Legislative Education Oversight Committee no later than February 15, 1993, and  
31 annually thereafter."

32 Sec. 15. Subsection (a) of Section 139 of Chapter 321 of the 1993 Session  
33 Laws reads as rewritten:

34 "Sec. 139. (a) Of the funds appropriated to Aid to Local School Administrative  
35 Units, the sum of two million five hundred thousand dollars (\$2,500,000) for the 1993-  
36 94 fiscal year and the sum of two million five hundred thousand dollars (\$2,500,000) for  
37 the 1994-95 fiscal year shall be used to provide grants for local school administrative  
38 units for locally designed innovative local programs to make schools safe for students  
39 and school employees. These funds shall be used for grants of from fifty thousand  
40 dollars (\$50,000) to one hundred thousand dollars (\$100,000) per year to local school  
41 administrative units. These funds may be used for continuing or noncontinuing  
42 expenses.

43 A local school administrative unit may apply for a grant, or two or three adjacent  
44 local school administrative units may apply jointly for a grant. Applicants for grants

1 shall submit to the State Board of Education an application that includes the following  
2 information:

- 3 (1) An assessment of local problems with regard to violence and  
4 harassment, including sexual and other forms of harassment, in the  
5 schools prepared by a local task force of educators, parents, students,  
6 community leaders, and representatives of social services and law  
7 enforcement, appointed by the local board of education.
- 8 (2) A detailed plan for addressing these local problems, including  
9 proposed goals and anticipated outcomes, prepared after consultation  
10 with the task force.
- 11 (3) A statement of how the grant funds would be used to address these  
12 local problems and what other resources would be used to address the  
13 problems.
- 14 (4) A process for assessing on an annual basis the success of the local plan  
15 for addressing problems with regard to violence and harassment in the  
16 schools.

17 The Superintendent of Public Instruction shall appoint a State task force to assist the  
18 Superintendent in reviewing grant applications. The State task force shall include  
19 representatives of the Department of Public Instruction, local school administrative  
20 units, educators, parents, the juvenile justice system, social services, and  
21 nongovernmental agencies providing services to children, and other members the  
22 Superintendent deems appropriate. In reviewing grant applications, the Superintendent  
23 and the State task force shall consider the severity of the local problems with regard to  
24 violence in the schools and the likelihood that the locally designed plan will deal with  
25 the problems successfully.

26 The State Board of Education shall consider the recommendations of the  
27 Superintendent in selecting grant recipients. The State Board shall also attempt to give  
28 grants to local school administrative units that are located geographically throughout the  
29 State, that have different demographic profiles, and that propose different approaches to  
30 their problems. The State Board shall select grant recipients prior to January 1, 1994.

31 The Superintendent of Public Instruction shall administer the grant program and  
32 provide technical assistance to grant applicants and recipients.

33 The State Board of Education shall report to the Joint Legislative Education  
34 Oversight Committee prior to March 15, 1994, ~~and prior to January 15, 1995-1995,~~ and  
35 October 1, 1995, and annually thereafter on how the funds are being used."

36 Sec. 16. (a) Section 7 of Chapter 210 of the 1993 Session Laws reads as  
37 rewritten:

38 "Sec. 7. This act becomes effective July 1, ~~1993-1993,~~ except that Sections 3, 5, and  
39 6 become effective July 1, 1995."

40 (b) This section is effective upon ratification. This section does not apply to  
41 employment contracts entered into between a local school unit and an assistant principal  
42 between July 1, 1993, and the effective date of this act.

43 Sec. 17. Subsections (d) and (e) of Section 96 of Chapter 830 of the 1987  
44 Session Laws are repealed.

2 Session Laws are repealed.  
3                   Sec. 19. Chapter 43 of the 1993 Session Laws is repealed.  
4                   Sec. 20. This act is effective upon ratification.
