1 A BILL TO BE ENTITLED 2 AN ACT TO DIRECT JOINT LEGISLATIVE UTILITY THE **REVIEW** 3 COMMITTEE STUDY RECENT **RULINGS** BYTHE UTILITIES TO COMMISSION ON THE REGULATORY TREATMENT OF THE GAIN ON 4 SALE OF WATER AND SEWER FACILITIES AND TO STUDY MUNICIPAL 5 ELECTRIC UTILITY SYSTEMS, AND TO DIRECT THE NORTH CAROLINA 6 7 UTILITIES COMMISSION TO STUDY ALTERNATIVE MEANS OF RATE MAKING FOR NATURAL GAS COMPANIES. 8

The General Assembly of North Carolina enacts:

Section 1. (a) The Joint Legislative Utility Review Committee shall study the recent rulings by the Utilities Commission on the regulatory treatment of the gain on sale of water and sewer facilities, and shall examine the impact of those rulings on expanding municipalities, the effect on the ratepayers of municipal utilities, and the effect on the shareholders of the water and sewer utilities. The Committee shall make findings and a recommendation on the need for legislation to modify or reverse those rulings and shall report the results of its study to the 1993 General Assembly, 1994 Regular Session.

- (b) The Joint Legislative Utility Review Committee shall:
- (1) Study municipal electric utility systems serving customers outside the corporate limits, concentrating on the following areas:
  - a. Whether cities have successfully organized their electric utility systems to allow participation either by customers inside the

2		by customers both inside and outside the corporate limits; and
3		b. Electric rates for customers with city service compared with
4		what those rates might be if a private utility served areas inside
5		and outside the city that the city currently serves, such analysis
6		also to examine what would happen to in-city rates if out-of-
7		city customers were no longer served.
8		The study required by this subdivision may focus on a particular
9		system or systems.
10	(2)	Study the feasibility of establishing special competitive electrical rates
11		in North Carolina in order to attract more industries to the State.
12	(3)	Study the rate disparity between investor-owned electric utilities in
13		North Carolina, and suggest methods of eliminating that disparity.
14	(4)	Study the need for regulation of municipal electric utility systems by
15		the Utilities Commission.
16	(5)	Determine whether municipal electric utility systems are providing
17		special rates for economic development purposes and whether such
18		rates comply with State law.
19	The Committee	shall report its findings and any recommendations to the 1993 General
20	Assembly, 1994	Regular Session.
21	Sec. 2. (a)	The North Carolina Utilities Commission shall study and conduct
22	public hearings	on alternative means of rate making for natural gas companies to
