A BILL TO BE ENTITLED

AN ACT TO IMPLEMENT AND STUDY RECOMMENDATIONS OF THE GOVERNMENT PERFORMANCE AUDIT COMMITTEE CONCERNING THE OPERATION OF THE GENERAL ASSEMBLY.

The General Assembly of North Carolina enacts:

Section 1. The Legislative Services Commission shall retain a consultant to conduct a study of job classifications and compensation of all legislative employees.

Under the direction of the Legislative Services Commission, the Legislative Administrative Officer shall provide assistance to the consultant.

The study shall include the development of the following components: classification system (including job descriptions), compensation philosophy, salary structure, pay delivery, and external and internal job evaluations. The study shall determine which jobs are paid below, at, or above the market rates.

The consultant retained by the Legislative Services Commission shall be selected through a competitive procurement process.

Beginning April 1, 1994, the consultant shall make quarterly reports on the study's progress to the Legislative Services Commission. The consultant shall complete the study and present its findings to the Legislative Services Commission no later than October 1, 1994.

Sec. 2. The Legislative Services Commission shall study (i) the benefits provided to temporary legislative employees and (ii) the appointment of a Human Resources Management Officer for the General Assembly.

- Sec. 3. The General Assembly shall have conducted a peer review of the organizational structure and staffing capabilities and levels required to serve the General Assembly in the future. The review shall be completed by July 1, 1994.
- Sec. 4. The Legislative Services Commission shall develop a facilities plan that defines current space needs and plans for future needs for facilities and storage space. This plan shall be completed by July 1, 1994.
  - Sec. 5. G.S. 120-31 is amended by adding a new subsection to read:
- "(f) The Legislative Services Commission shall meet at least quarterly, but may provide for cancellation of a meeting if there is no business to transact."
- Sec. 6. There is allocated to the Legislative Services Commission from funds appropriated to the General Assembly for fiscal year 1993-94 the sum of fifty thousand dollars (\$50,000) to implement the provisions of Section 3 of this act. There is allocated to the Legislative Services Commission from funds appropriated to the General Assembly the sum of twenty thousand dollars (\$20,000) for the 1993-94 fiscal year and the sum of ten thousand dollars (\$10,000) for the 1994-95 fiscal year for the study required under Section 1 of this act.
- Sec. 7. Section 6 of this act becomes effective July 1, 1993. The remainder of this act is effective upon ratification.
