1 A BILL TO BE ENTITLED
2 AN ACT TO PROVIDE FEES TO BE CHARGED BY THE SECRETARY OF STATE
3 UNDER THE REVISED NONPROFIT CORPORATION ACT AS
4 RECOMMENDED BY THE GENERAL STATUTES COMMISSION.

5 The General Assembly of North Carolina enacts:

6 Section 1. G.S. 55A-1-22 as enacted by A BILL TO BE ENTITLED AN
7 ACT TO REWRITE CHAPTER 55A OF THE GENERAL STATUTES RELATING
8 TO NONPROFIT CORPORATIONS AS RECOMMENDED BY THE GENERAL
9 STATUTES COMMISSION reads as rewritten:

10 "~~§ 55A-1-22. Reserved for future codification purposes.~~ Filing, service, and copying
11 fees.

12 (a) The Secretary of State shall collect the following fees when the documents
13 described in this subsection are delivered to the Secretary for filing:

25 (b) The Secretary of State shall collect a fee of ten dollars (\$10.00) each time
26 process is served on the Secretary under this Chapter. The party to a proceeding
27 causing service of process is entitled to recover this fee as costs if the party prevails in
28 the proceeding.

29 (c) The Secretary of State shall collect the following fees for copying,
30 comparing, and certifying a copy of any filed document relating to a domestic or foreign
31 corporation:

- 32 (1) One dollar (\$1.00) a page for copying or comparing a copy to the
33 original; and
34 (2) Five dollars (\$5.00) for the certificate."

35 Sec. 2. This act becomes effective January 1, 1994, but shall not become
36 effective unless A BILL TO BE ENTITLED AN ACT TO REWRITE CHAPTER 55A
37 OF THE GENERAL STATUTES RELATING TO NONPROFIT CORPORATIONS
38 AS RECOMMENDED BY THE GENERAL STATUTES COMMISSION is ratified by
39 the 1993 General Assembly.
