1	A BILL TO BE ENTITLED
2	AN ACT TO REQUIRE THAT THE LEGISLATIVE STUDY COMMISSION ON
3	CHILD CARE REVIEW THE MAKEUP, FUNCTIONING, AND
4	EFFECTIVENESS OF THE DIVISION OF CHILD DEVELOPMENT,
5	DEPARTMENT OF HEALTH AND HUMAN SERVICES, AND OF THE CHILD
6	CARE COMMISSION, AND TO APPROPRIATE FUNDS.
7	The General Assembly of North Carolina enacts:
8	Section 1. (a) The Legislative Study Commission on Child Care shall review
9	the makeup, functioning, and effectiveness of the Division of Child Development,
10	Department of Health and Human Services, and of the Child Care Commission of the
11	Department of Health and Human Services to determine whether to recommend changes
12	in the Division of Child Development or in the Child Care Commission or both. The
13	Division is established in the Department of Health and Human Services pursuant to G.S.
14	143B-138.1 and is the executive agency charged with administering Article 7 of Chapter
15	110 of the General Statutes, with administering any other child care programs and
16	services that fall under the jurisdiction of the Department of Health and Human Services,
17	and with providing clerical and other services required by the Commission pursuant to
18	G.S.143B-168.4(b). The Commission is established and organized pursuant to Part 10A
19	of Article 3 of Chapter 143B of the General Statutes and is the executive body charged

with rulemaking and other duties for Article 7 child care facilities, as set out in G.S. 11090, 143B-168.3, and 143B-168.5.

3 (b) This study shall focus on the issue of whether the Division of Child 4 Development and the Child Care Commission effectively and fairly serve the best 5 interests of the taxpayers of North Carolina, the child care providers of North Carolina, 6 and the children of North Carolina who are in child care.

7 (c) The Legislative Study Commission on Child Care shall report the 8 results of its study, together with any legislative or policy recommendations, in its regular 9 report to the 1999 General Assembly.

10 Section 2. There is appropriated from the General Fund to the General 11 Assembly the sum of fifteen thousand dollars (\$15,000) for the 1998-99 fiscal year for 12 the Legislative Study Commission on Child Care to implement the additional study 13 required by this act.

14 Section 3. This act is effective when it becomes law.
