A BILL TO BE ENTITLED

- 2 AN ACT TO DIVIDE NORTH CAROLINA INTO TWELVE CONGRESSIONAL3 DISTRICTS.
- 4 The General Assembly of North Carolina enacts:
 - Section 1. (a) G.S. 163-201(a) reads as rewritten:

6 "(a) For the purpose of nominating and electing members of the House of 7 Representatives of the Congress of the United States in 1998 and every two years 8 thereafter, the State of North Carolina shall be divided into 12 districts as follows:
