A BILL TO BE ENTITLED

AN ACT TO EXTEND THE CORPORATE LIMITS OF THE TOWN OF LELAND.

The General Assembly of North Carolina enacts:

Section 1. The corporate limits of the Town of Leland are extended to include the following described tract of land:

Being a tract of land located in Town Creek Township, Brunswick County, North Carolina, and being more fully described as follows:

16 Section 2. (a) The corporate limits of the area annexed by Section 1 of this act
17 shall be considered satellite corporate limits within the meaning of Part 4 of Article 4A of
18 Chapter 160A of the General Statutes, except they are excluded in any calculations made
19 under G.S. 160A-58.1(b)(5). The corporate limits of the area annexed by Section 1 of this
20 act are not external boundaries for the purposes of Part 2 or 3 of Article 4A of Chapter
21 160A of the General Statutes until they are contiguous to the town.

22 (b) Notwithstanding any provision of law, this act does not affect the existing
23 franchise or other right of Brunswick Electric Membership Cooperative to continue to
24 provide electric service to the area annexed by this act.

25 Section 3. Real and personal property in the territory annexed pursuant to this
26 act is subject to municipal taxes as provided in G.S. 160A-58.10.

27 Section 4. This act becomes effective June 30, 1997.
