2	AN ACT TO REQUIRE ALL SCHOOL BUSES AND SCHOOL ACTIVITY BUSES
3	PURCHASED AFTER JULY 1, 1999, TO BE EQUIPPED WITH SEAT BELTS
4	AND TO APPROPRIATE FUNDS TO EQUIP NEW SCHOOL BUSES WITH
5	SEAT BELTS.
6	The General Assembly of North Carolina enacts:
7	Section 1. G.S. 115C-47(24) reads as rewritten:
8	"(24) Purchase of Activity Buses with Local Capital Outlay Tax Funds
9	Local boards of education are authorized to may purchase activity buses
10	with local capital outlay tax funds, and are authorized to may maintain
11	these buses in the county school bus garage. Reimbursement to the State
12	Public School Fund shall be made for all maintenance cost-costs
13	including labor, gasoline and oil, repair parts, tires and tubes, antifreeze,
14	etc. Labor cost reimbursements and local funds may be used to employ
15	additional mechanics so as to insure that all activity buses owned and
16	operated by local boards of education are maintained in a safe
17	mechanical condition. Replacement units for activity buses shall be
18	financed with local funds. Activity buses purchased after July 1, 1999,
19	shall be equipped with seat belts for all passengers."

Section 2. G.S. 115C-240(c) reads as rewritten: 1 The State Board of Education shall from time to time adopt such any rules and 2 "(c) 3 regulations with reference to the construction, equipment, color, and maintenance of 4 school buses, the number of pupils who may be permitted to ride at the same time upon 5 any bus, and the age and qualifications of drivers of school buses as-that it shall deem 6 deems to be desirable for the purpose of promoting safety in the operation of school 7 buses. No school bus shall be operated for the transportation of pupils unless such-that 8 bus is constructed and maintained as prescribed in such-the applicable regulations and is 9 equipped with adequate heating facilities, a standard signaling device for giving due 10 notice that the bus is about to make a turn, an alternating flashing stoplight on the front of the bus, an alternating flashing stoplight on the rear of the bus, and such-any other 11 12 warning devices, fire protective equipment and first aid supplies as may be prescribed for installation upon such-on the buses by the regulation of-rules issued by the State Board of 13 Education. All buses purchased after July 1, 1999, shall be equipped with seat belts for 14 15 all passengers." 16 Section 3. There is appropriated from the General Fund to the State Board of 17 Education the sum of one million nine hundred thousand dollars (\$1,900,000) for the

18 1999-2000 fiscal year to equip all school buses purchased after July 1, 1999, with seat 19 belts for passengers.

Section 4. This act becomes effective July 1, 1999.
