1	A BILL TO BE ENTITLED
2	AN ACT TO PROVIDE FOR THE PROTECTION AND RESTORATION OF
3	VEGETATED RIPARIAN BUFFERS IN ORDER TO PREVENT THE
4	POLLUTION OF SURFACE WATERS.
5	The General Assembly of North Carolina enacts:
6	Section 1. Part 1 of Article 21 of Chapter 143 of the General Statutes is
7	amended by adding a new section to read:
8	" <u>§ 143-214.20. Protection and restoration of vegetated riparian buffers.</u>
9	(a) <u>Policy; Purpose and Intent. – Protection and restoration of vegetated riparian</u>
10	buffers along surface waters will prevent and reduce pollution of those waters. Vegetated
11	riparian buffers remove sediment, nutrients, and other pollutants before those pollutants
12	enter and impact surface waters. It is the purpose and intent of this section to provide for
13	the protection of vegetated riparian buffers along all surface waters of the State and to
14	provide for the restoration of vegetated riparian buffers along surface waters where
15	buffers do not currently exist.
16	(b) <u>Protection of Riparian Buffers. – The Commission shall adopt rules to provide</u>
17	for the protection of riparian buffers along all surface waters of the State, including
18	intermittent streams, perennial streams, lakes, ponds, and estuaries. These rules shall be
19	consistent with any rules adopted by the Commission that apply to riparian buffers along
20	the Neuse River The Commission shall adopt temporary rules for the protection of

1	vegetated riparian buffers along all surface waters in watersheds designated as nutrient
2	sensitive waters (NSW) under rules adopted by the Commission.
3	(c) <u>Restoration of Riparian Buffers. – The Commission shall examine</u>
4	opportunities to restore vegetated riparian buffers in watersheds through the development
5	and implementation of basinwide water quality management plans as provided in G.S.
6	<u>143-215.8B(b)(3).</u>
7	(d) Reporting Requirement The Commission shall report no later than
8	November 1 of each year to the Environmental Review Commission regarding
9	implementation of this section. The report shall document the status of the statewide
10	protection of vegetated riparian buffers along surface waters and the status of vegetated
11	riparian buffer restoration in each of the 17 major river basins."
12	Section 2. G.S. 143-215.8B(b) is amended by adding a new subdivision to
13	read:
14	"(3) Examine opportunities to restore vegetated riparian buffers in
15	watersheds, identify surface waters that lack vegetated riparian buffers,
16	establish priorities regarding vegetated riparian buffer restoration along
17	surface waters, and identify sources of funds for buffer restoration. In
18	carrying out the requirements of this subdivision, the Commission shall
19	coordinate its efforts with the Wetlands Restoration Program under G.S.
20	<u>143-214.8 through G.S. 143-214.13.</u> "
21	Section 3. When referring to rules adopted by the Environmental Management
22	Commission that apply to riparian buffers along the Neuse River, G.S. 143-214.20(b), as
23	enacted by Section 1 of this act, means temporary rule 15A NCAC 2B.0233, as defined in
24	Section 1.1 of S.L. 1998-221, as revised pursuant Section 1.8 of S.L. 1998-221 and
25	adopted by October 1, 1999.
26	Section 4. This act becomes effective October 1, 1999.
