A BILL TO BE ENTITLED

AN ACT TO PERMIT THE TEMPORARY WAIVER OF CERTAIN RULES FOR CERTAIN LICENSED HEALTH CARE FACILITIES THAT PROVIDE TEMPORARY SHELTER OR SERVICES DURING DISASTERS AND EMERGENCIES.

The General Assembly of North Carolina enacts:

Section 1. Part A of Article 6 of Chapter 131E of the General Statutes is amended by adding the following new section to read:

"§ 131E-112. Waiver of rules for health care facilities that provide temporary shelter or temporary services during a disaster or emergency.

(a) The Division of Facility Services may temporarily waive, during disasters or emergencies declared in accordance with Article 1 of Chapter 166A of the General Statutes, any rules of the Commission pertaining to facilities or home care agencies to the extent necessary to allow the facility or home care agency to provide temporary shelter and temporary services requested by the emergency management agency. The Division may identify, in advance of a declared disaster or emergency, rules that may be waived, and the extent the rules may be waived, upon a disaster or emergency being declared in accordance with Article 1 of Chapter 166A of the General Statutes. The Division may

1 also waive rules under this subsection during a declared disaster or emergency upon the  
2 request of an emergency management agency and may rescind the waiver if, after  
3 investigation, the Division determines the waiver poses an unreasonable risk to the  
4 health, safety, or welfare of any of the persons occupying the facility. The emergency  
5 management agency requesting temporary shelter or temporary services shall notify the  
6 Division within 72 hours of the time the preapproved waivers are deemed by the  
7 emergency management agency to apply.

8 (b) As used in this section, 'emergency management agency' is as defined in G.S.  
9 166A-4(2)."

10 Section 2. Article 1 of Chapter 131D of the General Statutes is amended by  
11 adding the following new section to read:

12 **"§ 131D-7. Waiver of rules for certain adult care homes providing shelter or services**  
13 **during disaster or emergency.**

14 (a) The Division of Facility Services may temporarily waive, during disasters or  
15 emergencies declared in accordance with Article 1 of Chapter 166A of the General  
16 Statutes, any rules of the Commission pertaining to adult care homes to the extent  
17 necessary to allow the adult care home to provide temporary shelter and temporary  
18 services requested by the emergency management agency. The Division may identify, in  
19 advance of a declared disaster or emergency, rules that may be waived, and the extent the  
20 rules may be waived, upon a disaster or emergency being declared in accordance with  
21 Article 1 of Chapter 166A of the General Statutes. The Division may also waive rules  
22 under this subsection during a declared disaster or emergency upon the request of an  
23 emergency management agency and may rescind the waiver if, after investigation, the  
24 Division determines the waiver poses an unreasonable risk to the health, safety, or  
25 welfare of any of the persons occupying the adult care home. The emergency  
26 management agency requesting temporary shelter or temporary services shall notify the  
27 Division within 72 hours of the time the preapproved waivers are deemed by the  
28 emergency management agency to apply.

29 (b) As used in this section, 'emergency management agency' is as defined in G.S.  
30 166A-4(2)."

31 Section 3. This act becomes effective July 1, 1999, and applies to shelter or  
32 services provided on and after that date.
