S 1 SENATE BILL 794 Short Title: Exempt Tobacco Settlement Payments. (Public) Sponsors: Senators Wellons; Albertson, Gulley, Harris, Jordan, Kerr, Lucas, Martin of Pitt, Purcell, and Warren. Referred to: Judiciary I. April 8, 1999 A BILL TO BE ENTITLED AN ACT TO EXEMPT PAYMENTS UNDER PHASE I AND PHASE II OF THE TOBACCO SETTLEMENT AGREEMENT FROM EXECUTION EXCEPT FOR DEBTS INCURRED FOR FARMING OPERATIONS IN CALENDAR YEARS 1999 AND 2000. The General Assembly of North Carolina enacts: Section 1. G.S. 1C-1601(a) is amended by adding a new subdivision (10) to read: "(10) Payments distributed to an active tobacco farmer under the terms of the master settlement agreement between tobacco manufacturers and the states as ratified in North Carolina through a consent decree in the action of State of North Carolina v. Philip Morris, et al., 98 CVS 14377 in the General Court of Justice, Superior Court Division, Wake County (generally known as the 'Phase I' agreement), or from a national tobacco trust fund established by tobacco manufacturers to compensate tobacco farmers and quota holders for losses sustained as a result of the master settlement agreement (generally known as the 'Phase II' agreement).

This exemption shall not apply to the enforcement of the claims of
