1 A BILL TO BE ENTITLED  
2 AN ACT TO UPDATE THE MANUFACTURED HOUSING BOARD STATUTES, TO  
3 PROVIDE FOR CONTINUING EDUCATION FOR LICENSEES, TO IMPROVE  
4 THE BUYER CANCELLATION LAW, AND TO UPDATE THE LAW ON  
5 MANUFACTURED HOME STANDARDS TO COMPLY WITH FEDERAL LAWS  
6 AND REGULATIONS.

7 The General Assembly of North Carolina enacts:

8 Section 1. Article 9A of Chapter 143 of the General Statutes reads as  
9 rewritten:

10 "ARTICLE 9A.

11 "NORTH CAROLINA MANUFACTURED HOUSING BOARD –  
12 MANUFACTURED HOME WARRANTIES.

13 "§ 143-143.8. Purpose.

14 The General Assembly finds that ~~mobile-manufactured~~ homes have become a primary  
15 housing resource for many of the citizens of North Carolina. The General Assembly finds  
16 further that it is the responsibility of the ~~mobile-manufactured~~ home industry to provide  
17 homes which are of reasonable quality and safety and to offer warranties to buyers that  
18 provide a means of remedying quality and safety defects in ~~mobile-manufactured~~ homes.

1 The General Assembly also finds that it is in the public interest to provide a means for  
2 enforcing such warranties.

3 Consistent with these findings and with the legislative intent to promote the general  
4 welfare and safety of ~~mobile-manufactured~~ home residents in North Carolina, the General  
5 Assembly finds that the most efficient and economical way to assure safety, quality and  
6 responsibility is to require the licensing and bonding of all segments of the ~~mobile~~  
7 manufactured home industry. The General Assembly also finds that it is reasonable and  
8 proper for the ~~mobile-manufactured~~ home industry to cooperate with the Commissioner of  
9 Insurance, through the establishment of the North Carolina Manufactured Housing Board,  
10 to provide for a comprehensive framework for industry regulations.

11 **"§ 143-143.9. Definitions.**

12 The following words, terms and phrases, when used in this Article, shall have the  
13 meanings respectively ascribed to them in this section, except where the context clearly  
14 indicates a different meaning: definitions apply in this Article:

- 15 (1) ~~"Board" means the Board.~~ – The North Carolina Manufactured Housing  
16 Board.
- 17 (2) ~~"Buyer" means a Buyer.~~ – A person who purchases at retail from a dealer  
18 or manufacturer a manufactured home for personal use as a residence or  
19 other related use.
- 20 (3) ~~"Code" means the appropriate Code.~~ – Engineering standards adopted by  
21 the Commissioner.
- 22 (4) ~~"Commissioner" means the Commissioner.~~ – The Commissioner of  
23 Insurance of the State of North Carolina.
- 24 (5) ~~"Department" means the Department.~~ – The Department of Insurance of  
25 the State of North Carolina.
- 26 (5a) License. – A license issued under this Article.
- 27 (5b) Licensee. – A person who has been issued a license under this Article  
28 by the North Carolina Manufactured Housing Board.
- 29 (6) ~~"Manufactured home" or "mobile home" means a Manufactured home.~~ – A  
30 structure, transportable in one or more sections, which, in the travelling  
31 mode, is eight feet or more in width or is 40 feet or more in length, or  
32 when erected on site, is 320 or more square feet, and which is built on a  
33 permanent chassis and designed to be used as a dwelling with or without  
34 a permanent foundation when connected to the required utilities, and  
35 includes the plumbing, heating, air conditioning and electrical systems  
36 contained therein.
- 37 (7) ~~"Manufactured home dealer" or "dealer" means any Manufactured home~~  
38 dealer or dealer. – Any person engaged in the business of buying, buying  
39 or selling or dealing in manufactured homes or offering or displaying  
40 manufactured homes for sale in North Carolina. Any person who buys,  
41 sells or deals in buys or sells three or more manufactured homes in any  
42 12-month period, or who offers or displays for sale three or more  
43 manufactured homes in any 12-month period shall be presumed to be a

1 manufactured home dealer. The terms 'selling' and 'sale' include lease-  
2 purchase transactions. The term 'manufactured home dealer' does not  
3 include banks and finance companies that acquire manufactured homes  
4 as an incident to their regular business.

5 (8) ~~"Manufactured home manufacturer" or "manufacturer" means any~~  
6 Manufactured home manufacturer or manufacturer. – Any person,  
7 resident or nonresident, who manufactures or assembles manufactured  
8 homes for sale to dealers in North Carolina.

9 (9) ~~"Manufactured home salesman" or "salesman" means any~~  
10 Manufactured home salesperson or salesperson. – Any person employed as a salesman  
11 by a manufactured home dealer to sell manufactured homes to buyers.

12 (10) ~~"Person" means any Person.~~ – Any individual, natural persons, firm,  
13 partnership, association, corporation, legal representative or other  
14 recognized legal entity.

15 (11) ~~"Responsible party" means a~~ Responsible party. – A manufacturer, dealer,  
16 supplier, or set-up contractor.

17 (12) ~~"Setup" means the Setup.~~ – The operations performed at the occupancy  
18 site which render a manufactured home fit for habitation. ~~Such~~  
19 ~~operations include, but are not limited to, transportation by a bona fide~~  
20 ~~private or exempt carrier operating under the provisions of the Public~~  
21 ~~Utilities Act, positioning, blocking, leveling, supporting, tying down,~~  
22 ~~connecting utility systems, making minor adjustments, or assembling~~  
23 ~~multiple or expandable units. Such operations do not include lawful~~  
24 ~~transportation services performed by public utilities operating under~~  
25 ~~certificates or permits issued by the North Carolina Utilities~~  
26 ~~Commission.~~

27 (13) ~~"Set up contractor" means a~~ Set-up contractor. – A person who engages in  
28 the business of performing ~~set up operations~~ setups for compensation in  
29 North Carolina.

30 (14) ~~"Substantial defect" means any~~ Substantial defect. – Any substantial  
31 deficiency in or damage to materials or workmanship occurring in a  
32 manufactured home which has been reasonably maintained and cared  
33 for in normal use. The term also means any structural element, utility  
34 system or component part of the manufactured home which fails to  
35 comply with the Code.

36 (15) ~~"Supplier" means the~~ Supplier. – The original producer of completed  
37 components, including refrigerators, stoves, hot water heaters,  
38 dishwashers, cabinets, air conditioners, heating units, and similar  
39 components, and materials such as floor coverings, panelling, siding,  
40 trusses, and similar materials, which are furnished to a manufacturer or  
41 dealer for installation in the manufactured home prior to sale to a buyer.

42 **"§ 143-143.10. Manufactured Housing Board created; membership; terms;**  
43 **meetings.**

1 (a) There is hereby created the North Carolina Manufactured Housing Board  
2 within the ~~Department of Insurance~~ Department. The Board shall be composed of nine  
3 members as follows:

- 4 (1) The Commissioner of Insurance or his ~~designee~~ designee.  
5 (2) A manufactured home ~~manufacturer~~ manufacturer.  
6 (3) A manufactured home ~~dealer~~ dealer.  
7 (4) A representative of the banking and finance ~~business~~ business.  
8 (5) A representative of the insurance ~~industry~~ industry.  
9 (6) A manufactured home ~~supplier~~ supplier.  
10 (7) A set-up ~~contractor~~ contractor.  
11 (8) Two representatives of the general public.

12 The Commissioner of ~~Insurance~~ or his designee shall ~~serve as chairman of~~ chair the  
13 Board. The Governor shall appoint to the Board the manufactured home manufacturer  
14 and the manufactured home dealer. The General Assembly upon the recommendation of  
15 the Speaker of the House of Representatives in accordance with G.S. 120-121 shall  
16 appoint the representative of the banking and finance industry and the representative of  
17 the insurance industry. The General Assembly upon the recommendation of the President  
18 Pro Tempore of the Senate in accordance with G.S. 120-121 shall appoint the  
19 manufactured home supplier and set-up contractor. The Commissioner of ~~Insurance~~ shall  
20 appoint two representatives of the general public. Except for the representatives from the  
21 general public and the persons appointed by the General Assembly, each member of the  
22 Board shall be appointed by the appropriate appointing authority from a list of nominees  
23 submitted to the appropriate appointing authority by the Board of Directors of the North  
24 Carolina Manufactured Housing Institute. At least three nominations shall be submitted  
25 for each position on the Board. The members of the Board shall be residents of the State.

26 The members of the Board shall serve for terms of three years ~~to begin on October 1,~~  
27 ~~1981, except that the persons appointed by the General Assembly upon the~~  
28 ~~recommendation of the Speaker shall serve two year terms to expire on September 30,~~  
29 ~~1985, and the persons appointed by the General Assembly upon the recommendation of~~  
30 ~~the President Pro Tempore of the Senate shall serve for three year terms to expire on~~  
31 ~~September 30, 1986.~~ years. In the event of any vacancy of a position appointed by the  
32 Governor or ~~Commissioner of Insurance~~, Commissioner, the appropriate appointing  
33 authority shall appoint a replacement in the same manner as provided for the original  
34 appointment to serve the remainder of the unexpired term. Vacancies in appointments  
35 made by the General Assembly shall be filled in accordance with G.S. 120-122. In the  
36 event of any vacancy, the appropriate appointing authority shall appoint a replacement to  
37 serve the remainder of the unexpired term. Such appointment shall be made in the same  
38 manner as provided for the original appointment. No member of the Board shall serve  
39 more than two consecutive, three-year terms.

40 The member of the Board representing the general public shall have no financial  
41 interest connected with the manufactured housing industry. No member of the Board  
42 shall participate in any proceeding before the Board involving that member's own  
43 business.

1 Each member of the Board, except the Commissioner of Insurance and any other State  
2 employee, shall receive per diem and allowances as provided with respect to occupational  
3 licensing boards by G.S. 93B-5. All per diem and travel expenses shall be paid  
4 exclusively out of the fees received by the Board as authorized by this Article. In no case  
5 shall any salary, expense, or other obligation of the Board be charged against the ~~Treasury~~  
6 General Fund of the State of North Carolina. All moneys and receipts shall be kept in a  
7 special fund by and for the use of the Board for the exclusive purpose of carrying out the  
8 provisions of this Article. At the end of the fiscal year, the Board shall retain fifteen  
9 percent (15%) of the unexpended funds collected and received during that year. The  
10 remaining eighty-five percent (85%) of these funds shall be credited to the General Fund.

11 (b) In accordance with the provisions of this Article, the ~~North Carolina~~  
12 ~~Manufactured Housing Board~~ shall have the following powers and duties:

- 13 (1) To issue licenses to manufacturers, dealers, ~~salesmen~~ salespersons, and  
14 ~~set-up contractors;~~ contractors.
- 15 (2) To require that an adequate bond or other security be posted by all  
16 licensees, except manufactured housing ~~salesmen;~~ salespersons.
- 17 (3) To receive and resolve complaints from buyers of manufactured homes  
18 and from persons in the manufactured housing industry, in connection  
19 with the warranty, warranty service, licensing requirements or any other  
20 provision under this ~~Article;~~ and Article.
- 21 (4) To ~~promulgate~~ adopt rules in accordance with Chapter 150B of the  
22 General Statutes as are necessary to carry out the provisions of this  
23 Article.
- 24 (5) To file against the bond posted by a licensee for warranty repairs and  
25 service on behalf of a buyer.

26 **"§ 143-143.11. License required; application for license.**

27 (a) It shall be unlawful for any manufactured home manufacturer, dealer, ~~salesman~~  
28 salesperson, or set-up contractor to engage in business as such in this State without first  
29 obtaining a license from the Board, as provided in this Article. The fact that a person is  
30 licensed by the Board as a set-up contractor or a dealer does not preempt any other  
31 licensing boards' applicable requirements for that person.

32 (b) Application for ~~such~~ the license shall be made to the Board at such time, in  
33 such form, and contain ~~such~~ information as the Board ~~shall require,~~ requires, and shall be  
34 accompanied by the ~~required~~ fee established by the Board. ~~Such~~ The fee shall not exceed  
35 three hundred dollars (\$300.00) for any license.

36 (c) In ~~such~~ the application, the Board shall require information relating to the  
37 matters set forth in G.S. 143-143.13 as grounds for refusal of a license, and information  
38 relating to other pertinent matters consistent with safeguarding the public interest. All  
39 ~~such of this~~ information shall be considered by the Board in determining the fitness of the  
40 ~~applicant to engage in the business for which a license is sought.~~ applicant.

41 (d) All licenses ~~that are granted~~ shall expire, unless ~~sooner~~ revoked or suspended, on  
42 June 30 of each year following the date of issue.

1 (e) Every ~~registrant under this Chapter~~ licensee shall, on or before the first day of  
2 July of each year, obtain a renewal of a license for the ~~ensuing next~~ year, by application,  
3 accompanied by the required fee; ~~and upon fee.~~ Upon failure to renew, ~~his a~~ license shall  
4 automatically ~~expire; but such~~ expires. The license may be renewed at any time within one  
5 year upon payment of the ~~prescribed renewal fee and upon evidence satisfactory to the Board~~  
6 ~~that the applicant has not engaged in business as a manufactured home manufacturer, dealer,~~  
7 ~~salesman or set-up contractor after expiration of the license and is otherwise eligible for~~  
8 ~~registration under the provisions of this Chapter.~~ renewal fee.

9 (f) Supplemental licenses shall be issued for each place of business, operated or  
10 proposed to be operated by the licensee, that is not contiguous to other premises for  
11 which a license is issued. The fee for a supplemental license shall be established by the  
12 Board and shall not exceed three hundred dollars (\$300.00), provided that no  
13 supplemental license shall be required for a place of business operated by a licensee that  
14 is used exclusively for storage.

15 (g) Notwithstanding the provisions of subsection (a), the Board may provide by  
16 rule that a manufactured home ~~salesman~~ salesperson will be allowed to engage in business  
17 during the time period after making application for a license but before such license is  
18 granted.

19 (h) ~~To obtain~~ As a prerequisite to obtaining a license under this Article, a person  
20 ~~must~~ may be required to pass an examination prescribed by the Board that is based on the  
21 ~~North Carolina Manufactured/Mobile Home Regulations and Administrative Procedures required~~  
22 ~~to enforce the Codes.~~ Code, this Article, and any other subject matter considered relevant  
23 by the Board.

24 **"§ 143-143.11A. Notification of change of address; service of notice.**

25 (a) Every applicant for a license shall inform the Board of the applicant's business  
26 address. Every licensee shall give written notification to the Board of any change in the  
27 licensee's business address, for whatever reason, within 10 business days after the  
28 licensee moves to a new address or a change in the address takes place. A violation of  
29 this subsection shall not constitute grounds for revocation, suspension, or non-renewal of  
30 a license or for the imposition of any other penalty by the Board.

31 (b) Notwithstanding any other provision of law, whenever the Board is authorized  
32 or required to give notice to a licensee under this Article, the notice may be delivered  
33 personally to the licensee or sent by first-class mail to the licensee at the address provided  
34 to the Board under subsection (a) of this section. Notice shall be deemed given four days  
35 after mailing, and any Department employee may certify that notice has been given.

36 **"§ 143-143.11B. Continuing education.**

37 (a) The Board may establish programs and requirements of continuing education  
38 for licensees, but shall not require licensees to complete more than eight credit hours of  
39 continuing education. Prior to the renewal of a license, a licensee shall present evidence  
40 to the Board that he or she has completed the required number of continuing education  
41 hours in courses approved by the Board during the two months immediately preceding  
42 the expiration of his or her license.

1       (b) The Board may establish nonrefundable fees for the purpose of providing staff  
2 and resources to administer continuing education programs, and may establish  
3 nonrefundable course application fees, not to exceed one hundred fifty dollars (\$150.00),  
4 for the Board's review and approval of proposed continuing education courses. The  
5 Board may charge the sponsor of an approved course a nonrefundable fee not to exceed  
6 seventy-five dollars (\$75.00) for the annual renewal of course approval. The Board may  
7 also require a course sponsor to pay a fee, not to exceed five dollars (\$5.00) per credit  
8 hour per licensee, for each licensee completing an approved continuing education course  
9 conducted by the sponsor. The Board may award continuing education credit for a  
10 course that has not been approved by the Board or for related educational activity and  
11 may prescribe the procedures for a licensee to submit information on the course or related  
12 educational activity for continuing education credit. The Board may charge the licensee a  
13 fee not to exceed fifty dollars (\$50.00) for each course or activity submitted.

14       (c) The Board may adopt any reasonable rules not inconsistent with this Article to  
15 give purpose and effect to the continuing education requirement, including rules that  
16 govern:

- 17       (1) The content and subject matter of continuing education courses.
- 18       (2) The criteria, standards, and procedures for the approval of courses,  
19 course sponsors, and course instructors.
- 20       (3) The methods of instruction.
- 21       (4) The computation of course credit.
- 22       (5) The ability to carry forward course credit from one year to another.
- 23       (6) The waiver of or variance from the continuing education requirement  
24 for hardship or other reasons.
- 25       (7) The procedures for compliance and sanctions for noncompliance.

26       (d) The license of any person who fails to comply with the continuing education  
27 requirements under this section shall lapse. The Board may, for good cause shown, grant  
28 extensions of time to licensees to comply with these requirements. Any licensee who,  
29 after obtaining an extension, offers evidence satisfactory to the Board that he or she has  
30 satisfactorily completed the required continuing education courses shall be deemed in  
31 compliance with this section.

32       (e) A manufactured home manufacturer or manufacturer is exempt from the  
33 requirements of this section.

34 **"§ 143-143.12. Bond required.**

35       (a) A person licensed as a manufactured home ~~salesman~~-salesperson shall not be  
36 required to furnish a bond, but each applicant approved by the Board for license as a  
37 manufacturer, dealer, or set-up contractor shall furnish a corporate surety bond, cash  
38 bond or fixed value equivalent thereof in the following amounts:

- 39       (1) For a ~~manufactured~~-manufacturer, two thousand dollars (\$2,000) per  
40 manufactured home manufactured in the prior license year, up to a  
41 maximum of one hundred thousand dollars (\$100,000). When no  
42 manufactured homes were produced in the prior year, the amount

1 required shall be based on the estimated number of manufactured homes  
2 to be produced during the current ~~year~~, year.

3 (2) For a dealer ~~who buys, sells, or deals in manufactured homes and~~ who has  
4 four or less places of business, the amount shall be twenty-five thousand  
5 dollars ~~(\$25,000)~~; (\$25,000).

6 (3) For a dealer ~~who buys, sells, or deals in manufactured homes and~~ who has  
7 more than four places of business, the amount shall be fifty thousand  
8 dollars ~~(\$50,000)~~; (\$50,000).

9 (4) For a set-up contractor, the amount shall be five thousand dollars  
10 (\$5,000).

11 (b) A corporate surety bond shall be approved by the Board as to form and shall be  
12 conditioned upon the obligor faithfully conforming to and abiding by the provisions of  
13 this Article. A cash bond or fixed value equivalent ~~thereof~~ shall be approved by the Board  
14 as to form and terms of deposits in order to secure the ultimate beneficiaries of the bond.  
15 A corporate surety bond shall be for a one-year period, and a new bond or a proper  
16 continuation certificate shall be delivered to the Board at the beginning of each  
17 subsequent one-year period.

18 (c) Any buyer of a manufactured home who suffers any loss or damage by any act  
19 of a licensee that constitutes a violation of this Article ~~shall have the right to~~ may institute  
20 an action to recover against ~~such~~ the licensee and the surety.

21 (d) The Board may adopt rules to assure satisfaction of claims.

22 **"§ 143-143.13. Grounds for denying, suspending, or revoking license.**  
23 **licenses; civil penalties.**

24 (a) A license may be denied, suspended or revoked by the Board on any one or  
25 more of the following grounds:

26 (1) ~~Material~~ Making a material misstatement in application for ~~license;~~  
27 license.

28 (2) ~~Failure~~ Failing to post an adequate corporate surety bond, cash bond or  
29 fixed value ~~equivalent thereof;~~ equivalent.

30 (3) Engaging in the business of manufactured home manufacturer, dealer,  
31 ~~salesman~~ salesperson, or set-up contractor without first obtaining a  
32 license from the ~~Board;~~ Board.

33 (4) ~~Failure~~ Failing to comply with the warranty service obligations and  
34 claims procedure established by this ~~Article;~~ Article.

35 (5) ~~Failure~~ Failing to comply with the ~~set-up and tie-down~~ set-up  
36 requirements established by this ~~Article;~~ Article.

37 (6) ~~Having knowingly failed or refused~~ Failing or refusing to account for or to  
38 pay over moneys or other valuables belonging to others ~~which~~ that have  
39 come into licensee's possession arising out of the sale of manufactured  
40 ~~homes;~~ homes.

41 (7) ~~Use of~~ Using unfair methods of competition or committing unfair or  
42 deceptive ~~commercial acts or practices;~~ practices.

43 (8) ~~Failure~~ Failing to comply with any provision of this ~~Article;~~ Article.



- 1           (9) ~~Failure—Failing to appear for a hearing before the Board or for a~~  
2 ~~prehearing conference with a person or persons designated by the Board~~  
3 ~~upon due after proper notice or failing to follow directives comply with~~  
4 ~~orders of the Board issued pursuant to this Article; Article.~~
- 5           (10) Employing unlicensed ~~retail salesmen; salespersons.~~
- 6           (11) ~~Knowingly offering for sale the products of manufacturers who are not~~  
7 ~~licensed pursuant to this Article or selling, to dealers not licensed~~  
8 ~~pursuant to this Article, manufactured homes which are to be sold in this~~  
9 ~~State to buyers as defined in this Article; Offering for sale manufactured~~  
10 ~~homes manufactured or assembled by unlicensed manufacturers or~~  
11 ~~selling manufactured homes to unlicensed dealers for sale to buyers in~~  
12 ~~this State.~~
- 13           (12) Conviction of a felony or any crime involving moral ~~turpitude; turpitude.~~
- 14           (13) Having had a license revoked, suspended or denied by the ~~Board under~~  
15 ~~this Article; Board; or having had a license revoked, suspended or denied~~  
16 ~~by a similar entity in another state; or engaging in conduct in another~~  
17 ~~state which conduct, if committed in this State, would have been a~~  
18 ~~violation under this Article; Article.~~
- 19           (14) ~~Knowingly engaging—Employing or contracting with~~ any person to  
20 ~~perform set-up operations—setups~~ who is not licensed by the Board as a  
21 ~~set-up contractor.~~
- 22           (b) Repealed by Session Laws 1985, c. 666, s. 38.
- 23           (c) In addition to the authority to deny, suspend, or revoke a license under this  
24 Article, the Board ~~also has the authority to may~~ impose a civil penalty upon any person  
25 violating the provisions of this Article. Upon a finding by the Board of a violation of this  
26 Article, the Board shall ~~direct order~~ the payment of a penalty of not less than one hundred  
27 dollars (\$100.00) nor more than five hundred dollars (\$500.00). In determining the  
28 amount of the penalty, the Board shall consider the degree and extent of harm caused by  
29 the violation, the amount of money that inured to the benefit of the violator as a result of  
30 the violation, whether the violation was committed willfully, and the prior record of the  
31 violator in complying or failing to comply with laws, rules, or orders applicable to the  
32 violator. Each day during which a violation occurs shall constitute a separate offense.  
33 The penalty shall be payable to the Board. The Board shall remit the clear proceeds of  
34 penalties provided for in this subsection to the Civil Penalty and Forfeiture Fund in  
35 accordance with G.S. 115C-457.2.
- 36           Payment of the civil penalty under this section shall be in addition to payment of any  
37 other penalty for a violation of the criminal laws of this State. Nothing in this subsection  
38 shall prevent the Board from negotiating a mutually acceptable agreement with any  
39 person as to the status of the person's license or certificate or as to any civil penalty.
- 40 **"§ 143-143.14. Notice and hearing. Hearings; rules.**
- 41           (a) License suspensions, revocations, and renewal refusals are subject to the  
42 provisions of Chapter 150B of the General Statutes.

1 (b) If the Board finds that an applicant has not met the requirements for licensure,  
2 the Board shall refuse to issue the applicant a license and shall notify the applicant in  
3 writing of the denial and the grounds for the denial. The application may also be denied  
4 for any reason for which a license may be suspended or revoked or not renewed under  
5 G.S. 143-143.13. Within 30 days after receipt of a notification that an application for a  
6 license has been denied, the applicant may make a written request for a review by a

7 c. ~~That, during the course of setup~~ That the setup and transportation of  
8 the manufactured home performed by the dealer, substantial defects  
9 do not occur to the manufactured home. dealer did not result in  
10 substantial defects.

11 (3) The supplier warrants that any warranties generally offered in the  
12 ordinary sale of his product to consumers shall be extended to buyers of  
13 manufactured homes. The manufacturer's warranty shall remain in  
14 effect notwithstanding the existence of a supplier's warranty.

15 (4) The set-up contractor warrants that ~~set-up operations are performed the~~  
16 manufactured home is set up in compliance with applicable standards  
17 adopted by the Commissioner for the installation of manufactured  
18 homes, the Code and that during the course of set-up operations  
19 performed on the manufactured home, substantial defects do not occur  
20 to the manufactured home. the setup did not result in any substantial  
21 defects.

23 (a) Whenever a claim for warranty service or about a substantial defect is made to  
24 a licensee, it shall be handled as provided ~~by in~~ in this Article. ~~A The licensee shall make a~~  
25 ~~record shall be made~~ of the name and address of each claimant and the date, substance,  
26 and disposition of each claim about a substantial defect. The licensee may request that a  
27 claim be in writing, but must nevertheless record it as provided above, and may not delay  
28 service pending receipt of the written claim.

33 be removed for service without substantial expense or inconvenience to the buyer.

8 entire structural, electrical, heating, plumbing and air-conditioning  
9 systems could be closely observed and inspected;

12 standards and rules and regulations provided by this Article.

13 The legal status of any structure built before the effective date of the Act shall not be  
14 affected by any changes made in this Article by the General Assembly.

15 **"§ 143-148. Certain structures excluded from coverage.**

16 The Commissioner may by rule provide for the exclusion of certain structures by  
17 certification in accordance with the National Manufactured Housing Construction and Safety  
18 Standards Act of 1974. Act.

19 **"§ 143-149. Necessity for obtaining label or certificate for purposes of sale.**

20 No individual natural person, firm, partnership, association or corporation person  
21 shall after September 1, 1971, sell or offer for sale any manufactured home in this State,  
22 which manufactured home State that does not bear permanently attached thereto a label  
23 of compliance or for which manufactured home the individual natural person, firm,  
24 partnership, association, or corporation selling or offering to sell such manufactured  
25 home does not have a certificate of compliance; provided it shall be have a label. It is a  
26 defense to any prosecution for a violation of the provisions of this section if such  
27 individual natural person, firm, partnership, association or corporation shall show a  
28 person shows that a certificate of title for such the manufactured home as required by  
29 G.S. 20-52 was obtained prior to September 1, 1971, before June 15, 1976, or produces  
30 other satisfactory evidence on file with the North Carolina Department Division of Motor  
31 Vehicles that such the manufactured home was manufactured prior to September 1, 1971,  
32 before June 15, 1976.

33 **"§ 143-150. No electricity to be furnished units not in compliance.**

34 It is unlawful for any person to initially furnish electricity for use in any manufactured  
35 home without first ascertaining that the manufactured home and its electrical supply has  
36 been inspected pursuant to G.S. 143-139 by the inspection authority having jurisdiction  
37 and found to comply with the requirements of the State Electrical Code. The certificate  
38 of compliance issued by the inspection jurisdiction shall be accepted as evidence of  
39 compliance.

40 **"§ 143-151. Penalties.**

41 (a) Whoever violates (i) the provisions of this Article; or (ii) Any person who is found  
42 by the Commissioner to have violated the provisions of the Act, this Article, or any rules  
43 promulgated-adopted under this Article, shall be liable for a civil penalty not to exceed one

1 thousand dollars (\$1,000) for each violation. Each ~~such~~ violation shall constitute a  
2 separate violation ~~with respect to~~ for each manufactured home or with respect to ~~for each~~  
3 failure or refusal to allow or perform an act required ~~thereby, except that the~~ by the Act,  
4 this Article, or any rules adopted under this Article. The maximum civil penalty may not  
5 exceed one million dollars (\$1,000,000) for any related series of violations occurring  
6 within one year ~~from~~ after the date of the first violation. In determining the amount of the  
7 penalty, the Commissioner shall consider the degree and extent of harm caused by the  
8 violation, the amount of money that inured to the benefit of the violator as a result of the  
9 violation, whether the violation was willful, and the prior record of the violator in  
10 complying or failing to comply with laws, rules, or orders applicable to the violator. The  
11 clear proceeds of civil penalties provided for in this section shall be remitted to the Civil  
12 Penalty and Forfeiture Fund in accordance with G.S. 115C-457.2.

13 (b) Any individual, ~~corporation,~~ or a director, officer or agent of a corporation who  
14 knowingly and willfully violates the Act, this Article ~~Article,~~ or any rules ~~promulgated~~  
15 adopted under this Article in a manner ~~which~~ that threatens the health or safety of any  
16 purchaser is guilty of a Class ~~4~~ felony.

17 **"§ 143-151.1. Enforcement.**

18 The Commissioner ~~of Insurance or any inspection department~~ may initiate any  
19 appropriate action or proceeding to prevent, restrain, or correct any violation of the Act,  
20 this Article, or any rules adopted under this Article. The Commissioner, or any of his  
21 deputies or employees, upon showing proper credentials and in the discharge of their

42 Each manufacturer, distributor, and dealer of manufactured homes shall establish and  
43 maintain such records, make such reports, and provide such information as the

1 Commissioner or the Secretary of ~~Housing and Urban Development~~ HUD may reasonably  
2 require to be able to determine whether ~~such the~~ manufacturer, distributor, or dealer has  
3 acted or is acting in compliance with this Article, or the ~~National Manufactured Housing~~  
4 ~~Construction and Safety Standards Act of 1974~~ Act and shall, upon request of a person duly  
5 designated by the Commissioner or the Secretary of ~~Housing and Urban Development~~,

13 ~~any defect and correction procedures~~ in any manufactured home produced by ~~such the~~  
14 manufacturer and ~~correct such defect~~ in accordance with the Act, this Article, and any  
15 procedures specified rules adopted by the Commissioner.

16 **"§ 143-151.5. Prohibited acts.**

17 (a) No person shall:

- 18 (1) Manufacture for sale, lease, sell, offer for sale or lease, or introduce or  
19 deliver, or import into the United States, any manufactured home ~~which~~

21 manufactured home construction and safety standard under the Act or

42 section does not apply to the sale, the offer for sale, or the
