2 AN ACT TO PROVIDE FOR AN ADDITIONAL FEE OF SEVENTY-FIVE  
3 DOLLARS FOR CERTAIN SPECIAL REGISTRATION PLATES.

4 The General Assembly of North Carolina enacts:

5 **SECTION 1.** G.S. 20-79.7 reads as rewritten:

6 "**§ 20-79.7. Fees for special registration plates and distribution of the fees.**

7 (a) Fees. – Upon request, the Division shall provide and issue free of charge one  
8 registration plate to a recipient of the Congressional Medal of Honor, a 100% disabled  
9 veteran, and an ex-prisoner of war. ~~All other special registration plates, including~~  
10 The Division shall provide additional Congressional Medal of Honor, 100% Disabled  
11 Veteran, and Ex-Prisoner of War plates, are subject to and National Guard Member,  
12 Legion of Valor, Purple Heart Recipient, and Silver Star Recipient special registration  
13 plates upon the payment of the regular motor vehicle registration fee in G.S. 20-87 or  
14 G.S. 20-88 G.S. 20-88. All other special registration plates are subject to the regular  
15 motor vehicle registration vehicle fee in G.S. 20-87 or G.S. 20-88 plus an additional fee  
16 of seventy-five dollars (\$75.00), in the following amount:

26 (b) Distribution of Fees. – The Special Registration Plate Account and the  
 27 Collegiate and Cultural Attraction Plate Account are is established within the Highway  
 28 Fund. The Division must shall credit one-half of the additional fee imposed for the  
 29 special registration plates listed in subsection (a) among of this section to the Special  
 30 Registration Plate Account (SRPA), the Collegiate and Cultural Attraction Plate  
 31 Account (CCAPA), and the Natural Heritage Trust Fund (NHTF), which is established  
 32 under G.S. 113-77.7, as follows:

23 and one-half of the fee shall be remitted quarterly to the State Treasurer to be divided  
 24 equally for retirement benefits for state law enforcement officers administered in  
 25 accordance with Article 12C of Chapter 143 of the General Statutes, separation  
 26 allowances for law enforcement officers administered in accordance with Article 12D of  
 27 Chapter 143 of the General Statutes, retirement benefits for local governmental law  
 28 enforcement officers administered in accordance with Article 12E of Chapter 143 of the  
 29 General Statutes, Separate Insurance Benefits Plan for State and local governmental law  
 30 enforcement officers administered in accordance with Article 12F of Chapter 143 of the  
 31 General Statutes, and the Sheriffs' Supplemental Pension Fund administered in  
 32 accordance with Article 12H of Chapter 143 of the General Statutes.

33 (c) Use of Funds in Special Registration Plate Account. –

34 (1) The Division shall deduct the costs of special registration plates,  
 35 including the costs of issuing, handling, and advertising the availability  
 36 of the special plates, from the Special Registration Plate Account.

37 (2) From the funds remaining in the Special Registration Plate Account  
 38 after the deductions in accordance with subdivision (1) of this  
 39 subsection, there is annually appropriated from the Special  
 40 Registration Plate Account the sum of five hundred twenty-five  
 41 thousand dollars (\$525,000) to provide operating assistance for the  
 42 Visitor Centers:

43 a. on U.S. Highway 17 in Camden County, (\$75,000);

44 b. on U.S. Highway 17 in Brunswick County, (\$75,000);

- 1 c. on U.S. Highway 441 in Macon County, (\$75,000);  
2 d. in the Town of Boone, Watauga County, (\$75,000);  
3 e. on U.S. Highway 29 in Caswell County, (\$75,000);  
4 f. on U.S. Highway 70 in Carteret County, (\$75,000); and  
5 g. on U.S. Highway 64 in Tyrrell County, (\$75,000).
- 6 (3) The Division shall transfer the remaining revenue in the Account  
7 quarterly as follows:
- 8 a. Thirty-three percent (33%) to the account of the Department of  
9 Commerce to aid in financing out-of-state print and other media  
10 advertising under the program for the promotion of travel and  
11 industrial development in this State.
- 12 b. Fifty percent (50%) to the Department of Transportation to be  
13 used solely for the purpose of beautification of highways other  
14 than those designated as interstate. These funds shall be  
15 administered by the Department of Transportation for  
16 beautification purposes not inconsistent with good landscaping  
17 and engineering principles.
- 18 c. Seventeen percent (17%) to the account of the Department of  
19 Health and Human Services to promote travel accessibility for  
20 disabled persons in this State. These funds shall be used to  
21 collect and update site information on travel attractions  
22 designated by the Department of Commerce in its publications,  
23 to provide technical assistance to travel attractions concerning  
24 accommodation of disabled tourists, and to develop, print, and  
25 promote the publication ACCESS NORTH CAROLINA as  
26 provided in G.S. 168-2. Any funds allocated for these purposes  
27 that are neither spent nor obligated at the end of the fiscal year  
28 shall be transferred to the Department of Administration for  
29 removal of man-made barriers to disabled travelers at  
30 State-funded travel attractions. Guidelines for the removal of  
31 man-made barriers shall be developed in consultation with the  
32 Department of Health and Human Services."

33 **SECTION 2.** G.S. 20-81.12 reads as rewritten:

34 **"§ 20-81.12. Collegiate insignia plates and certain other special plates.**

35 (a) Collegiate Insignia Plates. – The Division must receive 300 or more  
36 applications for a collegiate insignia license plate for a college or university before a  
37 collegiate license plate may be developed. The color, design, and material for the plate  
38 ~~must~~ shall be approved by both the Division and the alumni or alumnae association of  
39 the appropriate college or university. ~~The Division must transfer quarterly the money in~~  
40 ~~the Collegiate and Cultural Attraction Plate Account derived from the sale of in State~~  
41 ~~collegiate insignia plates to the Board of Governors of The University of North Carolina~~  
42 ~~for in State, public colleges and universities and to the respective board of trustees for~~  
43 ~~in State, private colleges and universities in proportion to the number of collegiate~~  
44 ~~plates sold representing that institution for use for academic enhancement.~~

1 (b) Historical Attraction Plates. – The Division must receive 300 or more  
2 applications for an historical attraction plate representing a publicly owned or nonprofit  
3 historical attraction located in North Carolina and listed below before the plate may be  
4 developed. The Division must transfer quarterly the money in the Collegiate and  
5 Cultural Attraction Plate Account derived from the sale of historical attraction plates to  
6 the organizations named below in proportion to the number of historical attraction plates  
7 sold representing that organization:

8 (1) Historical Attraction Within Historic District. — The revenue derived  
9 from the special plate shall be transferred quarterly to the appropriate  
10 Historic Preservation Commission, or entity designated as the Historic  
11 Preservation Commission, and used to maintain property in the historic  
12 district in which the attraction is located. As used in this subdivision,  
13 the term "historic district" means a district created under G.S.  
14 160A-400.4.

15 (2) Nonprofit Historical Attraction. — The revenue derived from the  
16 special plate shall be transferred quarterly to the nonprofit corporation  
17 that is responsible for maintaining the attraction for which the plate is  
18 issued and used to develop and operate the attraction.

19 (3) State Historic Site. — The revenue derived from the special plate shall  
20 be transferred quarterly to the Department of Cultural Resources and  
21 used to develop and operate the site for which the plate is issued. As  
22 used in this subdivision, the term "State historic site" has the same  
23 meaning as in G.S. 121-2(11).Carolina.

24 (b1) Special Olympics Plates. – The Division must receive 300 or more  
25 applications for a special olympics plate before the plate may be developed. The  
26 Division must transfer quarterly the money in the Collegiate and Cultural Attraction  
27 Plate Account derived from the sale of special olympics plates to the North Carolina  
28 Special Olympics, Inc., to be used to train volunteers to assist in the statewide games  
29 and to help pay the costs of the statewide games.

30 (b2) State Attraction Plates. – The Division must receive 300 or more applications  
31 for a State attraction plate before the plate may be developed. The Division must  
32 transfer quarterly the money in the Collegiate and Cultural Attraction Plate Account  
33 derived from the sale of State attraction plates to the organizations named below in  
34 proportion to the number of State attraction plates sold representing that organization:

35 (1) Friends of the Great Smoky Mountains National Park. — The revenue  
36 derived from the special plate shall be transferred quarterly to the  
37 Friends of the Great Smoky Mountains National Park, Inc., to be used  
38 for educational materials, preservation programs, capital  
39 improvements for the portion of the Great Smoky Mountains National  
40 Park that is located in North Carolina, and operating expenses of the  
41 Great Smoky Mountains National Park.

42 (1a) The North Carolina Arboretum. — The revenue derived from the  
43 special plate shall be transferred quarterly to The North Carolina  
44 Arboretum Society and used to help the Society obtain grants for the

1 ~~North Carolina Arboretum and for capital improvements to the North~~  
2 ~~Carolina Arboretum.~~

3 (1b) ~~The North Carolina Maritime Museum.— The revenue derived from~~  
4 ~~the special plate shall be transferred quarterly to Friends of the~~  
5 ~~Museum, North Carolina Maritime Museum, Inc., to be used for~~  
6 ~~educational programs and conservation programs and for operating~~  
7 ~~expenses of the North Carolina Maritime Museum.~~

8 (2) ~~The North Carolina Zoological Society.— The revenue derived from~~  
9 ~~the special plate shall be transferred quarterly to The North Carolina~~  
10 ~~Zoological Society, Incorporated, to be used for educational programs~~  
11 ~~and conservation programs at the North Carolina Zoo at Asheboro and~~  
12 ~~for operating expenses of the North Carolina Zoo at Asheboro.~~

13 (b3) ~~Wildlife Resources Plates. – The Division must receive 300 or more~~  
14 ~~applications for a wildlife resources plate with a picture representing a particular native~~  
15 ~~wildlife species occurring in North Carolina before the plate may be developed. The~~  
16 ~~Division must transfer quarterly the money in the Collegiate and Cultural Attraction~~  
17 ~~Plate Account derived from the sale of wildlife resources plates to the Wildlife~~  
18 ~~Conservation Account established by G.S. 143-247.2.~~

19 (b4) ~~Olympic Games. – The Division may not issue an Olympic Games special~~  
20 ~~plate unless it receives 300 or more applications for the plate and the U.S. Olympic~~  
21 ~~Committee licenses, without charge, the State to develop a plate bearing the Olympic~~  
22 ~~Games symbol and name. The Division must transfer quarterly the money in the~~  
23 ~~Collegiate and Cultural Attraction Plate Account derived from the sale of Olympic~~  
24 ~~Games plates to the N.C. Health and Fitness Foundation, Inc., which will allocate the~~  
25 ~~funds as follows:~~

- 26 (1) ~~Fifty percent (50%) to the U.S. Olympic Committee to assist in~~  
27 ~~training olympic athletes.~~
- 28 (2) ~~Twenty five percent (25%) to North Carolina Amateur Sports to assist~~  
29 ~~with administration of the State Games of North Carolina.~~
- 30 (3) ~~Twenty five percent (25%) to the Governor's Council on Physical~~  
31 ~~Fitness and Health to support local fitness council development~~  
32 ~~throughout North Carolina.~~

33 (b5) ~~March of Dimes Plates. – The Division must receive 300 or more applications~~  
34 ~~for a March of Dimes plate before the plate may be developed. The Division shall~~  
35 ~~transfer quarterly the money in the Collegiate and Cultural Attraction Plate Account~~  
36 ~~derived from the sale of March of Dimes plates to the Eastern Carolina Chapter of the~~  
37 ~~March of Dimes Birth Defects Foundation. The Eastern Carolina Chapter shall disperse~~  
38 ~~the revenue proportionately among the Eastern Carolina Chapter, the Western Carolina~~  
39 ~~Chapter, the Greater Triad Chapter, and the Greater Piedmont Chapter of the March of~~  
40 ~~Dimes Birth Defects Foundation based upon the population of the area each Chapter~~  
41 ~~represents. The money must be used for the prevention of birth defects through local~~  
42 ~~community services and educational programs and through research and development.~~

43 (b6) ~~School Technology Plates. – The Division must receive 300 or more~~  
44 ~~applications for a School Technology plate before the plate may be developed. The~~

1 ~~Division shall transfer quarterly the money in the Collegiate and Cultural Attraction~~  
2 ~~Plate Account derived from the sale of School Technology plates to the State School~~  
3 ~~Technology Fund, which is established under G.S. 115C-102.6D.~~

4 (b7) Scenic Rivers Plates. – The Division must receive 300 or more applications  
5 for a Scenic Rivers plate before the plate may be developed. ~~The Division shall transfer~~  
6 ~~quarterly the money in the Collegiate and Cultural Attraction Plate Account derived~~  
7 ~~from the sale of Scenic Rivers plates to the Clean Water Management Trust Fund~~  
8 ~~established in G.S. 113-45.3.~~

9 (b8) Soil and Water Conservation Plates. – The Division must receive 300 or more  
10 applications for a soil and water conservation plate before the plate may be developed.  
11 ~~The Division shall transfer quarterly the money in the Collegiate and Cultural Attraction~~  
12 ~~Plate Account derived from the sale of the soil and water conservation plates to the Soil~~  
13 ~~and Water Conservation Account established in G.S. 143B-297.1.~~

14 (b9) Kids First Plates. – The Division must receive 300 or more applications for a  
15 Kids First plate before the plate may be developed. ~~The Division shall transfer quarterly~~  
16 ~~the money in the Collegiate and Cultural Attraction Plate Account derived from the sale~~  
17 ~~of Kids First plates to the North Carolina Children's Trust Fund established in G.S.~~  
18 ~~7B-1302.~~

19 (b10) University Health Systems of Eastern Carolina. – The Division must receive  
20 300 or more applications for a University Health Systems of Eastern Carolina plate  
21 before the plate may be developed. ~~The Division shall transfer quarterly the money in~~  
22 ~~the Collegiate and Cultural Attraction Plate Account derived from the sale of University~~  
23 ~~Health Systems of Eastern Carolina plates to the Pitt Memorial Hospital Foundation,~~  
24 ~~Inc., for use in the Children's Hospital of Eastern North Carolina.~~

25 (b11) Animal Lovers Plates. – The Division must receive 300 or more applications  
26 before an animal lovers plate may be developed. ~~The Division shall transfer quarterly~~  
27 ~~the money in the Collegiate and Cultural Attraction Plate Account derived from the sale~~  
28 ~~of the animal lovers plate to the Spay/Neuter Account established in G.S. 19A-60.~~

29 (b12) Support Public Schools Plates. – The Division must receive 300 or more  
30 applications for a Support Public Schools plate before the plate may be developed. ~~The~~  
31 ~~Division shall transfer quarterly the money in the Collegiate and Cultural Attraction~~  
32 ~~Plate Account derived from the sale of Support Public Schools plates to the Fund for the~~  
33 ~~Reduction of Class Size in Public Schools created pursuant to G.S. 115C-472.10.~~

34 (b13) Ducks Unlimited Plates. – The Division must receive 300 or more  
35 applications for a Ducks Unlimited plate and receive any necessary licenses from Ducks  
36 Unlimited, Inc., for use of their logo before the plate may be developed. ~~The Division~~  
37 ~~shall transfer quarterly the money in the Collegiate and Cultural Attraction Plate~~  
38 ~~Account derived from the sale of Ducks Unlimited plates to the Wildlife Resources~~  
39 ~~Commission to be used to support the conservation programs of Ducks Unlimited, Inc.,~~  
40 ~~in this State.~~

41 (b14) Omega Psi Phi Fraternity Plates. – The Division must receive 300 or more  
42 applications for an Omega Psi Phi Fraternity plate and receive any necessary licenses,  
43 without charge, from Omega Psi Phi Fraternity, Incorporated, before the plate may be  
44 developed. ~~The Division shall transfer quarterly the money in the Collegiate and~~

1 ~~Cultural Attraction Plate Account derived from the sale of Omega Psi Phi Fraternity~~  
2 ~~plates to the United Negro College Fund, Inc., through the Winston-Salem Area Office~~  
3 ~~for the benefit of UNCF colleges in this State.~~

4 (b15) Litter Prevention Plates. – The Division must receive 300 or more  
5 applications for a Litter Prevention plate before the plate may be developed. The  
6 ~~Division shall transfer quarterly the money in the Collegiate and Cultural Attraction~~  
7 ~~Plate Account derived from the sale of the litter prevention plates to the Litter~~  
8 ~~Prevention Account created pursuant to G.S. 136-125.1.~~

9 (b16) Goodness Grows Plates. – The Division must receive 300 or more  
10 applications for a Goodness Grows plate before the plate may be developed. The  
11 ~~Division shall transfer quarterly the money in the Collegiate and Cultural Attraction~~  
12 ~~Plate Account derived from the sale of Goodness Grows plates to the North Carolina~~  
13 ~~Agricultural Promotions, Inc., to be used to promote the sale of North Carolina~~  
14 ~~agricultural products.~~

15 (b17) Audubon North Carolina Plates. – The Division must receive 300 or more  
16 applications for an Audubon North Carolina plate before the plate may be developed.  
17 ~~The Division must transfer quarterly the money in the Collegiate and Cultural Attraction~~  
18 ~~Plate Account derived from the sale of Audubon North Carolina plates to the National~~  
19 ~~Audubon Society, Inc., a nonprofit corporation, for the account of the NC State Office~~  
20 ~~to be used for bird and other wildlife conservation and educational activities in the State~~  
21 ~~of North Carolina.~~

22 (b18) Special Forces Association. – The Division must receive 300 or more  
23 applications for a Special Forces Association plate before the plate may be developed.  
24 ~~The Division shall transfer quarterly the money in the Collegiate and Cultural Attraction~~  
25 ~~Plate Account derived from the sale of Special Forces Association plates to the~~  
26 ~~Airborne & Special Operations Museum in Fayetteville, North Carolina.~~

27 (b19) The V Foundation for Cancer Research. – The Division must receive 300 or  
28 more applications for a V Foundation plate before the plate may be developed. The  
29 ~~Division shall transfer quarterly the money in the Collegiate and Cultural Attraction~~  
30 ~~Plate Account derived from the sale of V Foundation plates to The V Foundation for~~  
31 ~~Cancer Research to fund cancer research grants.~~

32 (b20) Save the Sea Turtles. – The Division must receive 300 or more applications  
33 for a Save the Sea Turtles plate before the plate may be developed. ~~The Division must~~  
34 ~~transfer quarterly the money in the Collegiate and Cultural Attraction Plate Account~~  
35 ~~derived from the sale of Save the Sea Turtles plates to The Karen Beasley Sea Turtle~~  
36 ~~Rescue and Rehabilitation Center.~~

37 (b21) Harley Owners' Group. – The Division must receive 300 or more applications  
38 for a Harley Owners' Group plate before the plate may be developed. ~~The Division shall~~  
39 ~~transfer quarterly the money in the Collegiate and Cultural Attraction Plate Account~~  
40 ~~derived from the sale of Harley Owners' Group plates to the State Board of Community~~  
41 ~~Colleges to support the motorcycle safety instruction program established pursuant to~~  
42 ~~G.S. 115D-72.~~

43 (b22) Rocky Mountain Elk Foundation. – The Division must receive 300 or more  
44 applications for a Rocky Mountain Elk Foundation plate before the plate may be



1 developed. ~~The Division must transfer quarterly the money in the Collegiate and~~  
2 ~~Cultural Attraction Account derived from the sale of Rocky Mountain Elk Foundation~~  
3 ~~plates to Rocky Mountain Elk Foundation, Inc.~~

4 (b23) NC Agribusiness. – The Division must receive 300 or more applications for a  
5 NC Agribusiness plate before the plate may be developed. ~~The Division must transfer~~  
6 ~~quarterly the money in the Collegiate and Cultural Attraction Plate Account derived~~  
7 ~~from the sale of NC Agribusiness plates to the North Carolina Agribusiness Council,~~  
8 ~~Inc., to be used to promote awareness of the importance of agribusiness in North~~  
9 ~~Carolina.~~

10 (c) General. – An application for a special license plate named in this section  
11 may be made at any time during the year. If the application is made to replace an  
12 existing current valid plate, the special plate ~~must~~ shall be issued with the appropriate  
13 decals attached. No refund shall be made to the applicant for any unused portion  
14 remaining on the original plate. The request for a special license plate named in this  
15 section may be combined with a request that the plate be a personalized license plate.

16 (d) through (g) Repealed by Session Laws 1991 (Regular Session, 1992), c.  
17 1042, s. 3."

18 **SECTION 3.** This act becomes effective July 1, 2003, and shall apply to the  
19 special registration plates listed in this act and any other special registration plates that  
20 may be authorized by the General Assembly on or after the effective date of this act.
