5	Whereas, the maritime communities of Carteret, Hyde, Dare, and Pamlico
6	Counties are rich in culture, history, and natural resources; and
7	Whereas, the National Park Service identified the communities surrounding
8	Cape Lookout and Cape Hatteras National Seashores as important gateway communities
9	serving an integral role in the preservation and conservation of the region's cultural and
10	natural heritage; and
11	Whereas, the North Carolina Outer Banks Scenic Byway is projected to
12	become the Outer Banks National Scenic Byway in 2005, bringing with it important
13	opportunities for the area; and
14	Whereas, the revival of the Ocracoke Coast Guard Station as the North
15	Carolina Center for the Advancement of Teaching-East allows teachers to explore
16	coastal culture through firsthand learning experience in the maritime communities; and
17	Whereas, other projects nearing completion in 2005 include Visitor Centers at
18	ferry landings on Ocracoke and Cedar Islands; openings of the Cape Lookout
19	Lighthouse and Ocracoke Lighthouse, and new exhibits at Portsmouth Village, Harkers
20	Island Visitor Center, the Cape Lookout Light Keepers' Quarters; and
21	Whereas, a heritage tourism development officer is needed to lead the
22	development of sustainable heritage tourism products and target marketing that will
23	both increase the visitation to the Down East area and generate additional small
24	business and economic development opportunities for local residents using maritime

General Assembly of North Carolina

SECTION 1. There is appropriated to the Department of Commerce the sum
of fifty thousand dollars (\$50,000) for the 2005-2006 fiscal year and the sum of fifty
thousand dollars (\$50,000) for the 2006-2007 fiscal year for a Heritage Tourism
Development Officer position to preserve and promote the maritime traditions, cultural
history, and natural resources that connect Carteret, Hyde, Dare, and Pamlico Counties.
SECTION 2. This act becomes effective July 1, 2005.
