| The General Assembly of North Carolina enacts: |  |
| SECTION 1. G.S. 20-79.4(b) reads as rewritten: |  |
| Types. - The Division shall issue the following types of special registration |  |
| plates: |  |
| (38a) Share the Road. - Issuable to the registered owner of a motor vehicle |  |
| accordance with G.S. 20-81.12. The plate shall bear a representation |  |
| of the standard Department of Transportation "Share the Road" traffic |  |
| warning sign showing the bicycle (MUTCD W11-1) and the subplate |  |
| including the text "Share the Road" (MUTCD W28-1) will be placed |  |
| on the left side of the plate. The plate shall be developed with the |  |
| assistance of the Division of Bicycle and Pedestrian Transportation. |  |
| The Division may not issue the plate authorized by this subdivision |  |
| unless it receives at least 300 applications for the plate." |  |
| SECTION 2. G.S. 20-79.7(a) reads as rewritten: |  |
| "(a) Fees. - Upon request, the Division shall provide and issue free of charge one |  |
| istration plate to a recipient of the Congressional Medal of Honor, a 100\% disa |  |
| veteran, and an ex-prisoner of war. All other special registration plates, including additional Congressional Medal of Honor, 100\% Disabled Veteran, and Ex-Prisoner of |  |

| War plates, are subject to the regular motor vehicle registration fee in G.S. 20-87 or |  |
| G.S. 20-88 plus an additional fee in the following amount: |  |

SECTION 3. G.S. 20-79.7(b) reads as rewritten:
"(b) Distribution of Fees. - The Special Registration Plate Account and the Collegiate and Cultural Attraction Plate Account are established within the Highway Fund. The Division must credit the additional fee imposed for the special registration plates listed in subsection (a) among the Special Registration Plate Account (SRPA), the Collegiate and Cultural Attraction Plate Account (CCAPA), the Natural Heritage Trust Fund (NHTF), which is established under G.S. 113-77.7, and the Parks and Recreation Trust Fund, which is established under G.S. 113-44.15, as follows:

SECTION 4. G.S. 20-81.12 is amended by adding a new subsection to read: "(b39) Share the Road. - The Division must receive 300 or more applications for the Share the Road plate before the plate may be developed. The Division shall transfer quarterly the money in the Collegiate and Cultural Attraction Plate Account derived from the sale of the Share the Road plates to the Department of Transportation, Division of Bicycle and Pedestrian Transportation for its programs."

SECTION 5. This act is effective when it becomes law.
