A BILL TO BE ENTITLED

AN ACT TO AUTHORIZE THE DIVISION OF MOTOR VEHICLES TO ISSUE U.S.
EQUINE RESCUE LEAGUE SPECIAL REGISTRATION PLATE.

The General Assembly of North Carolina enacts:

SECTION 1. G.S. 20-63(b) reads as rewritten:

"(b) Every license plate shall have displayed upon it the registration number assigned to the vehicle for which it is issued, the name of the State of North Carolina, which may be abbreviated, and the year number for which it is issued or the date of expiration. A plate issued for a commercial vehicle, as defined in G.S. 20-4.2(1), and weighing 26,001 pounds or more, must bear the word "commercial," unless the plate is a special registration plate authorized in G.S. 20-79.4 or the commercial vehicle is a trailer or is licensed for 6,000 pounds or less. The plate issued for vehicles licensed for 7,000 pounds through 26,000 pounds must bear the word "weighted".

Except as otherwise provided in this subsection, a registration plate issued by the Division for a private passenger vehicle or for a private hauler vehicle licensed for 6,000 pounds or less shall be a "First in Flight" plate. A "First in Flight" plate shall have the words "First in Flight" printed at the top of the plate above all other letters and numerals. The background of the plate shall depict the Wright Brothers biplane flying over Kitty Hawk Beach, with the plane flying slightly upward and to the right. The following special registration plates do not have to be a "First in Flight" plate. The design of the plates that are not "First in Flight" plates must be approved by the Division and the State Highway Patrol for clarity and ease of identification.

- (3) Blue Ridge Parkway Foundation.
- (4) Friends of the Appalachian Trail.

SECTION 2. G.S. 20-79.4(b) reads as rewritten:

"(b) Types. – The Division shall issue the following types of special registration plates:

- 15 (46b) U.S. Equine Rescue League. – Issuable to the registered owner of a
- 16 motor vehicle. The plate shall bear the phrase "United States Equine
- 17 Rescue League," and a depiction of two horses in a circle. The
- 18 Division must receive 300 or more applications for the plate before it
- 19 may be developed.

SECTION 3. G.S. 20-79.7(a) reads as rewritten:

"(a) Fees. – Upon request, the Division shall provide and issue free of charge one registration plate to a recipient of the Congressional Medal of Honor, a 100% disabled veteran, and an ex-prisoner of war. All other special registration plates, including additional Congressional Medal of Honor, 100% Disabled Veteran, and Ex-Prisoner of War plates, are subject to the regular motor vehicle registration fee in G.S. 20-87 or G.S. 20-88 plus an additional fee in the following amount:

4 **SECTION 4.** G.S. 20-79.7(b) reads as rewritten:

5 "(b) Distribution of Fees. – The Special Registration Plate Account and the
 6 Collegiate and Cultural Attraction Plate Account are established within the Highway
 7 Fund. The Division must credit the additional fee imposed for the special registration
 8 plates listed in subsection (a) among the Special Registration Plate Account (SRPA), the
 9 Collegiate and Cultural Attraction Plate Account (CCAPA), the Natural Heritage Trust
 10 Fund (NHTF), which is established under G.S. 113-77.7, and the Parks and Recreation
 11 Trust Fund, which is established under G.S. 113-44.15, as follows:

35 **SECTION 5.** G.S. 20-81.12 is amended by adding a new subsection to read:
36 "(b53) U.S. Equine Rescue League. – The Division must receive 300 or more
37 applications for the U.S. Equine Rescue League plate before the plate may be
38 developed. The Division must transfer quarterly the money in the Collegiate and
39 Cultural Attraction Plate Account derived from the sale of U.S. Equine Rescue League
40 plates to the United States Equine Rescue League, Inc., to be used for the care and
41 upkeep of rescued equines."

42 **SECTION 6.** This act is effective when it becomes law. The Revisor of
43 Statutes is authorized to renumber the definitions in G.S. 20-79.4(b) as necessary to
44 maintain their alphabetical order.
