AN ACT TO APPROPRIATE FUNDS FOR THREE ADDITIONAL ASSISTANT DISTRICT ATTORNEYS FOR PROSECUTORIAL DISTRICT 20A AND A FORENSIC SCIENTIST POSITION FOR PROSECUTORIAL DISTRICT 20/20A.

The General Assembly of North Carolina enacts:

SECTION 1. Effective January 1, 2007, G.S. 7A-60(a1) reads as rewritten:

"(a1) The counties of the State are organized into prosecutorial districts, and each district has the counties and the number of full-time assistant district attorneys set forth in the following table:

SECTION 2. There is appropriated from the General Fund to the Judicial Department the sum of one hundred thirty-four thousand four hundred twelve dollars (\$134,412) for the 2006-2007 fiscal year to establish the three additional assistant district attorneys authorized by this act.

There is appropriated from the General Fund to the Judicial 2 Department the sum of sixty-one thousand eighty-nine dollars (\$61,089) for the 2006-2007 fiscal year to establish a new forensic scientist position for District 20 until 3 4 December 31, 2006, and to serve District 20A effective January 1, 2007. 5 **SECTION 4.** Sections 1 and 2 of this act become effective January 1, 2007. The remainder of this act becomes effective July 1, 2006. 6
