## **SENATE BILL 744**

## A BILL TO BE ENTITLED

3 The General Assembly of North Carolina enacts:

4 SECTION 1. There is appropriated from the General Fund to the 5 Department of Health and Human Services the sum of two million five hundred thousand dollars (\$2,500,000) for the 2005-2006 fiscal year. 6 These funds shall be 7 allocated to the North Carolina Institute for Public Health, School of Public Health at 8 the University of North Carolina, Chapel Hill, to coordinate the development of "public health incubators." Core participants in these incubators will be local public health 9 10 departments in selected underserved regions. Other governmental agencies and 11 nonprofit organizations will also be invited to participate. The funds shall be used to 12 provide ongoing public health incubator projects in the four public health incubators currently established at the rate of two hundred fifty thousand dollars (\$250,000) to each 13 14 of the four incubators, with the remaining appropriation to be allocated to up to four additional regional public health incubators selected by a selection committee. The 15 16 selection committee shall consist of a representative of the North Carolina Association 17 of Local Health Directors, a representative of the North Carolina Public Health 18 Association, two representatives from each currently funded public health incubator, a representative of the Division of Public Health of the Department of Health and Human 19 20 Services, and two representatives from the Institute for Public Health. The Institute for 21 Public Health may use up to two hundred fifty thousand dollars (\$250,000) for special projects and administrative expenses. The funds shall be used to: 22 23

- (1) Establish or strengthen the capacity to conduct epidemiological investigation and to actively monitor public health conditions, diseases, and risk factors.
- (2) Establish or strengthen the capacity to monitor health disparities and to develop plans to reduce those disparities.
- develop plans to reduce those disparities.
  (3) Conduct regional community health assessments with the assistance of other members of the public health community including other

1		governmental agencies and nonprofit organizations to establish
2		partnership health priorities based on these findings and to draft public
3		health interventions to address the highest health priorities.
4	(4)	Raise public awareness of the health-related issues in partnership
5		communities, collaborating with members of the larger public health
6		community and with local and State media, reporting health issues to
7		the county commissioners, the boards of health, legislators, at-risk
8		groups, and to the community at large.
9	(5)	Provide regular, supplemental training to members of the participating
10		boards of health to inform them about their overall responsibilities
11		including their role in policy development, to introduce them to
12		evidence-based best practices in public health with an emphasis on
13		collaborative initiatives, and to update them on emerging public health
14		issues, particularly those that are of greatest concern to their
15		communities.
16	(6)	Conduct workforce preparedness assessments and follow-on training
17		for the public health workforce in the pilot regions and to establish or
18		supplement policy to facilitate effective responses to public health
19		emergencies where appropriate.
20	(7)	Assist the accreditation administrator in the review of partnership
21		health departments and to assist in remediation where necessary,
22		through collaborative efforts.
23	(8)	Establish a formal, systematic review of the incubators to track and
24		evaluate the efficacy of roles, organization, and programs, to identify
25		best practices, and to develop recommendations for improvement
26		based on these findings.
27		<b>FION 2.</b> The Department of Health and Human Services shall report on
28		se funds and an evaluation of the incubator efforts to the Senate
29		Committee on Health and Human Services, the House of
30		Appropriations Subcommittee on Health and Human Services, and the
31		Division. The Department shall submit the report October 1, 2005, and
32	March 1, 2006.
