Deceptive representation of geographical location in telephone directory by florists. No person, firm, or corporation, engaged in the business of selling, delivery, (a) or solicitation of cut flowers, flower arrangements, or floral products may misrepresent its geographic location by either of the following means: Listing a local telephone number in a local telephone directory if both (1) of the following apply: Calls to the telephone number are routinely forwarded or otherwise transferred to a business location that is outside the calling area covered by the local telephone directory. The listing fails to conspicuously disclose the locality and state b. in which the business is located. Listing a business name in a local telephone directory if both of the <u>(2)</u> following apply: The name misrepresents the business's geographic location. a.
