1           **SECTION 2.** The Governor shall appoint the additional district court judge  
2 for District 19A authorized by this act, and that judge's successor shall be elected in the  
3 2008 election for a four-year term commencing January 1, 2009.

4           **SECTION 3.** There is appropriated from the General Fund to the Judicial  
5 Department the sum of eighty thousand eight hundred twenty dollars (\$80,820) for the  
6 2007-2008 fiscal year and the sum of one hundred thirty-six thousand six hundred sixty  
7 dollars (\$136,660) for the 2008-2009 fiscal year to fund the additional district court  
8 judgeship authorized by this act.

9           **SECTION 4.** This act becomes effective January 1, 2008.
