A BILL TO BE ENTITLED

AN ACT TO CHANGE THE NAME OF THE HIGHWAY FUND TO THE HIGHWAY  
MAINTENANCE FUND AND THE NAME OF THE HIGHWAY TRUST FUND TO  
THE HIGHWAY SPECIAL PROJECTS FUND.

The General Assembly of North Carolina enacts:

**SECTION 1.** The Revisor of Statutes shall rename the Highway Fund to the Highway Maintenance Fund in the following statutes: G.S. 20-7, 20-26, 20-58, 20-73, 20-79, 20-79.2, 20-79.7, 20-85, 20-85.1, 20-88.1, 20-97, 20-137.10, 20-183.7, 20-194, 20-289, 20-324, 20-382.2, 20-386, 58-85A-1, 105-164.44D, 105-330.10, 105-449.49, 105-449.125, 105-449.126, 105-564, 114-4.2, 119-23, 120-70.51, 136-16, 136-16.4, 136-16.6, 136-16.8, 136-18, 136-19, 136-25, 136-28.10, 136-44.2, 136-44.2A, 136-66.5, 136-89.192, 136-103.1, 136-125.1, 136-176, 136-177.1, 142-101, 143-341, 143C-1-4, 143C-3-5, 143C-5-3, 143C-6-6, 143C-6-11, 147-69.1, 147-86.11, 147-86.15, 147-86.22, and 158-42.

**SECTION 2.** The Revisor of Statutes shall rename the Highway Trust Fund to the Highway Special Projects Fund in the following statutes: G.S. 20-85, 20-85.1, 105-187.9, 105-449.125, 120-70.51, 120-70.52, 136-28.10, 136-41.1, 136-44.2A, 136-82.2, 136-89.192, 136-175, 136-176, 136-177, 136-177.1, 136-178, 136-179, 136-180, 136-180.1, 136-181 through 136-189, 142-101, 143-345.22, 143C-1-4, 143C-3-5, 143C-5-3, 143C-6-11, 147-69.1, and 147-86.15.

**SECTION 3.** The Revisor of Statutes is authorized to make other necessary changes to the General Statutes to effectuate the changing of the names of the Highway Fund and the Highway Trust Fund as directed by Sections 1 and 2 of this act or as the result of any acts passed prior to or after the enactment of this act.

**SECTION 4.** This act becomes effective July 1, 2009.
