1 AN ACT TO APPOINT PERSONS TO VARIOUS PUBLIC OFFICES UPON THE  
2 RECOMMENDATION OF THE PRESIDENT PRO TEMPORE OF THE SENATE.

4 Whereas, G.S. 120-121 authorizes the General Assembly to make certain  
5 appointments to public offices upon the recommendation of the President Pro Tempore of the  
6 Senate; and

7 Whereas, the President Pro Tempore of the Senate has made recommendations;

8 Now, therefore,

9 The General Assembly of North Carolina enacts:

11 **PART I. PRESIDENT PRO TEMPORE'S RECOMMENDATIONS**

12 **SECTION 1.1.** Cindy L. Marrelli of Wake County is appointed to the Board of  
13 Trustees of the North Carolina Museum of Art for a term expiring on June 30, 2015, to fill the  
14 unexpired term of Becki Gray.

15 **SECTION 1.2.** Effective October 1, 2014, Reverend Dr. Pierre J. Crawford of  
16 Gaston County is appointed to the African-American Heritage Commission for a term expiring  
17 on September 30, 2017.
