5	SECTION 2.5. Only persons who reside in Burke or Caldwell County may be
6	candidates for the judgeship created in District 25 by Section 2 of this act.
7	SECTION 3. There is appropriated from the General Fund to the Administrative
8	Office of the Courts the sum of four hundred forty-seven thousand seven hundred ninety-six
9	dollars (\$447,796) for the 2020-2021 fiscal year.
10	SECTION 4. Sections 1 and 2 of this act become effective January 1, 2021, and
11	elections conducted in 2020 shall be conducted in accordance with the judgeships created in those
12	sections. Section 3 of this act becomes effective July 1, 2020. The remainder of this act is

effective when it becomes law.
