HOUSE BILL DRH10288-MWf-68

Short Title: NCAMC/NCACC Special Regis. Plate. (Public)

A BILL TO BE ENTITLED
AN ACT TO AUTHORIZE THE DIVISION OF MOTOR VEHICLES TO PRODUCE AN
"NCAMC/NCACC" SPECIAL REGISTRATION PLATE.

The General Assembly of North Carolina enacts:

SECTION 1. G.S. 20-79.4(b)(147) is reenacted as it existed immediately before its expiration and reads as rewritten:

"(147) NCAMC/NCACC Clerk. – Issuable to a clerk of a municipal governing board or a clerk of a county board of commissioners of a municipality or county in this State. For a municipal clerk, the plate shall bear the words "NCAMC Clerk" followed by a number representing the municipal clerk's city or town. The number of a city shall be the order of the city in an alphabetical list of cities that assigns number one to the first city in the list. For a county clerk, the plate shall bear the words "NCACC Clerk" followed by a number representing the county clerk's county. The number of a county shall be the order of the county in an alphabetical list of counties that assigns number one to the first county in the list. The Division may not issue the plate authorized by this subdivision unless it receives at least ~~300~~50 applications for the plate."

SECTION 2. G.S. 20-79.7 reads as rewritten:

"§ 20-79.7. Fees for special registration plates and distribution of the fees.

...

(a1) Fees. – All other special registration plates are subject to the regular motor vehicle registration fee in G.S. 20-87 or G.S. 20-88 plus an additional fee in the following amount:

(b) Distribution of Fees. – The Special Registration Plate Account and the Collegiate and Cultural Attraction Plate Account are established within the Highway Fund. The Division must credit the additional fee imposed for the special registration plates listed in ~~subsection (a)~~ subsection (a1) of this section among the Special Registration Plate Account (SRPA), the Collegiate and Cultural Attraction Plate Account (CCAPA), the Clean Water Management Trust Fund (CWMTF), which is established under G.S. 113A-253, and the Parks and Recreation Trust Fund, which is established under G.S. 113-44.15, as follows:

2 "**§ 20-81.12. Collegiate insignia plates and certain other special plates.**

4 **(b162) NCAMC/NCACC Clerk.** – The Division shall transfer quarterly the money in the
5 Collegiate and Cultural Attraction Plate Account derived from the sale of "NCAMC/NCACC
6 Clerk" plates to the NC Kids digital library.

8 **SECTION 4.** The Revisor of Statutes is authorized to alphabetize, number, and
9 renumber the special registration plates listed in G.S. 20-79.4(b) to ensure that all the special
10 registration plates are listed in alphabetical order and numbered accordingly.

11 **SECTION 5.** The plate authorized by this act is not subject to the requirements to
12 establish a new special registration plate in G.S. 20-79.3A and the expiration of special
13 registration plate authorization in G.S. 20-79.8.

14 **SECTION 6.** This act becomes effective July 1, 2019.
