6	The General Assembly of North Carolina enacts:			
7	SECTION 1. The Board of Governors of The University of North Carolina shall			
8	study the feasib	ility of offering accelerated undergraduate degree programs at constituent		
9	institutions that a	re effective and efficient for students while remaining consistent with the access		
10	and affordability goals of the Strategic Plan for The University of North Carolina adopted by the			
11	Board of Governors. In conducting the study, the Board of Governors shall consider at least the			
12	following factors			
13	(1)	The use of online education for certain courses to shorten time to degree		
14		completion, particularly for general education requirements.		
15	(2)	The feasibility of increasing summer term options or flexible calendar		
16		scheduling to accelerate degree completion.		
17	(3)	The potential for piloting specific accelerated degree program models, such		
18		as three-year degree programs, combined bachelor's and master's degree		
19		programs, and competency-based programs. In reviewing potential pilot		
20		programs, the Board of Governors shall determine (i) whether a pilot program		
21		would be required or optional for constituent institutions, (ii) the type of		
22		flexibility that would be allowed during a pilot program, and (iii) whether		
23		incentive funding through the funding formula should be tied to constituent		
24		institutions relative to such a program.		
25	(4)	Any obstacles or needed changes to State financial aid programs or the		
26		university funding model to incentivize accelerated paths to a degree.		
27	(5)	The potential cost savings to students who enroll in accelerated degree		
28		programs, including any reduction to tuition and fees.		
29	(6)	Any possible shifts in curriculum design to focus on specialized skills earlier		
30		in the degree program.		
31	(7)	Issues related to student support to facilitate successful completion of		
32		requirements, selection of majors early in programs, and the management of		
33		increased student coursework loads in accelerated degree programs.		
34	(8)	The importance of credit transfers from college level high school courses,		
35		community college courses, or courses from other institutions to maximize		
36		accelerated degree program efficiency.		



General Assembly Of North Carolina Session 2019 1 (9) The level of student interest and demand for accelerated degree programs. 2 SECTION 2. By March 1, 2021, the Board of Governors shall report on the results 3 of the study and any recommendations to the Joint Legislative Education Oversight Committee. 4 SECTION 3. There is appropriated from the General Fund to the Board of Governors 5 of The University of North Carolina the sum of fifty thousand dollars (\$50,000) in nonrecurring 6 funds for the 2020-2021 fiscal year for the purpose of conducting the study required by Section 7 1 of this act. The Board of Governors may use these funds to contract with an independent 8 research organization to conduct the study. 9 SECTION 4. This act becomes effective July 1, 2020.
