1 A BILL TO BE ENTITLED
2 AN ACT TO MAKE VARIOUS CHANGES TO GENERAL LOCAL GOVERNMENT LAW.
3 The General Assembly of North Carolina enacts:

4 **SECTION 1.(a)** A motor vehicle combination operated on a designated road in
5 violation of subsection (a) or subsection (b) of G.S. 20-115.1 is subject to the axle-group weight
6 penalties set in G.S. 20-118(e). The penalties apply to the amount by which the motor vehicle
7 combination Gross Vehicle Weight Rating (GVWR) exceeds 20,000 pounds.

8 **SECTION 1.(b)** For purposes of this act, the term "designated road" is U.S. Route
9 64 between State Road 1533 and N.C. Highway 106 in Macon County.

10 **SECTION 1.(c)** This section applies only to Macon County.

11 **SECTION 1.(d)** This section becomes effective December 1, 2024, and applies to
12 offenses committed on or after that date.

13 **SECTION 2.(a)** G.S. 130A-50 is amended by adding a new subsection to read:

14 "(h) For purposes of the election of the members of the sanitary district board, a sanitary
15 district board shall adopt single-member residency districts in which only a person residing in a
16 single-member residency district shall be eligible as a candidate in the election for the seat
17 apportioned to that single-member residency district, but candidates shall be elected at large by
18 the qualified voters of the entire sanitary district. The district boundaries shall be established by
19 resolution adopted by the sanitary district board following a public hearing on the matter. The
20 resolution, and a copy of a map depicting the single-member residency districts as adopted, shall
21 be filed with the county board of elections. The most recent federal decennial census data shall
22 be used as the sole basis of population for the establishment of the single-member residency
23 districts. The single-member residency districts shall be revised after the return of each federal
24 decennial census as necessary. Notwithstanding subsection (b) of this section, members of a
25 sanitary district board under this subsection shall serve staggered four-year terms and the
26 staggering shall be taken into consideration when adopting or revising the single-member
27 residency districts. This subsection shall apply only to a sanitary district lying wholly within a
28 county with more than 17 municipalities lying wholly within that county."

29 **SECTION 2.(b)** A sanitary district board subject to G.S. 130A-50(h), as enacted by
30 this act, shall adopt a resolution establishing single-member residency district boundaries as
31 required by G.S. 130A-50(h), as enacted by this act, not later than December 1, 2024. The
32 residency district boundaries so established shall remain in effect until after the return of the 2030
33 federal decennial census, at which time the residency district boundaries shall be revised in
34 accordance with G.S. 130A-50(h), as enacted by this act.



1 **SECTION 2.(c)** This section is effective when it becomes law and applies to
2 elections held in 2025 and thereafter.

3 **SECTION 3.(a)** Section 4.2(h) of S.L. 2024-1 reads as rewritten:

4 **"SECTION 4.2.(h)** Funds allocated to the City of Saluda and the Towns of Columbus and
5 Tryon by Section 12.2(e)(161) of S.L. 2023-134 shall, notwithstanding that subdivision or any
6 provision of the Committee Report described in Section 43.2 of S.L. 2023-134 to the contrary,
7 be transferred to the Office of State Budget and Management to provide a grant to the City of
8 Saluda and the Towns of Columbus and Tryon for the repayment of debt incurred ~~by the City~~ for
9 construction of a water or wastewater project."

10 **SECTION 3.(b)** Section 12.2(e)(161) of S.L. 2023-134 reads as rewritten:

11 "(161) Two million three hundred four thousand eight hundred seventy-eight dollars
12 (\$2,304,878) to the City of ~~Saluda~~.Saluda and the Towns of Columbus and
13 Tryon."

14 **SECTION 4.(a)** Article 2 of Chapter 130A of the General Statutes is amended by
15 adding a new section to read:

16 "**§ 130A-70.2. Extension of district boundaries to include all of a municipality.**

17 (a) Notwithstanding G.S. 130A-69, 130A-70, and 130A-70.1, a sanitary district board
18 may extend the boundaries of the sanitary district to include all of the contiguous corporate areas
19 of any municipality adopting a resolution requesting inclusion into the sanitary district. The
20 sanitary district board shall conduct a public hearing on the matter as soon as practicable upon
21 receipt of the resolution from the municipality. The sanitary district boundaries, if expanded,
22 shall be established by resolution by the sanitary district board after the public hearing on the
23 matter.

24 (b) The effective date of the sanitary district boundary change under this section shall be
25 determined by the sanitary district board and shall coincide with the start of a fiscal or calendar
26 year.

27 (c) Upon expansion of the sanitary district boundaries in accordance with this section,
28 the sanitary district board shall file a copy of the resolution and a map of the new sanitary district
29 boundaries, with the county board of elections."

30 **SECTION 4.(b)** This section is effective when it becomes law, and applies to any
31 resolution from a municipality received by a sanitary district board on or after January 1, 2024.

32 **SECTION 5.** Except as otherwise provided, this act is effective when it becomes
33 law.
