5	The General Assembly of North Carolina enacts:			
6	<b>SECTION 1.(a)</b> The Study Committee on Metropolitan Planning Organizations is			
7	created. The Committee shall consist of five members of the House of Representatives, as			
8	appointed by the Speaker of the House of Representatives, and five members of the Senate, as			
9	appointed by the President Pro Tempore of the Senate. The Speaker of the House of			
10 11	Representatives and the President Pro Tempore of the Senate shall each designate one member as a cochair. Vacancies of the Committee shall be filled within 30 days by the same appointing			
11	authority that made the initial appointment, and resignation or removal from service in the			
12	General Assembly constitutes resignation or removal from service on the Committee. The			
13	Committee shall meet upon the joint call of the cochairs. A majority shall constitute a quorum of			
15	the Committee, and no official action may be taken except by a majority vote at a meeting at			
16	which a quorum is present.

Members of the Committee shall receive subsistence and travel expenses at the rates set forth in G.S. 120-3.1.			



## **General Assembly Of North Carolina**

The Legislative Services Commission, through the Legislative Services Officer, shall 1 2 assign professional staff to assist the Committee in its work. The House of Representatives' and 3 the Senate's Director of Legislative Assistants shall assign clerical staff to the Committee, and 4 the expenses relating to the clerical employees shall be borne by the Committee. The Committee 5 may contract for professional, clerical, or consultant services, as provided by G.S. 120-32.02. 6 **SECTION 1.(d)** The Committee shall report its findings and recommendations, 7 including any recommended legislation, to the Speaker of the House of Representatives and 8 President Pro Tempore of the Senate no later than two years after the effective date of this act. 9 The Committee shall terminate upon filing its report or two years after the effective date of this

- 10 act, whichever is earlier.
