1 A BILL TO BE ENTITLED 2 AN ACT TO MAKE CERTAIN ADJUSTMENTS TO THE CURRENT OPERATIONS 3 APPROPRIATIONS ACT OF 2023. 4 The General Assembly of North Carolina enacts: 5 6 EXTEND TIME LINE FOR CERTAIN NONRECURRING APPROPRIATIONS 7 **SECTION 1.** This section applies to any nonrecurring appropriation that will revert 8 to the fund from which the appropriation was made on June 30, 2024. Notwithstanding any 9 provision of law to the contrary, these appropriations shall not revert at the end of the 2023-2024 10 fiscal year and shall remain available for expenditure until September 30, 2024. 11 12 **CHILD CARE SFRF REALLOCATION** 13 SECTION 2.(a) Notwithstanding any provision of law to the contrary, State Fiscal 14 Recovery Funds appropriated in S.L. 2021-180 to the Department of Health and Human Services (Budget Code 14445) for "Premium Pay Bonuses" as provided on page C44, item 109 of the 15 Committee Report described in Section 43.2 of that act and further described in Section 39.21 of 16 17 S.L. 2021-180 is reduced by the sum of eleven million nine hundred ninety-three thousand 18 eighty-eight dollars (\$11,993,088). The Department shall return these funds to the State Fiscal 19 Recovery Fund, established in Section 2.2 of S.L. 2021-25 (SFRF), as soon as practicable but no 20 later than 15 business days after this section becomes law. 21 **SECTION 2.(b)** The Office of State Budget and Management shall allocate the sum 22 of eight million two hundred fifty-one thousand seventy-eight dollars (\$8,251,078) from the 23 SFRF to the Department of Health and Human Services (Budget Code 14420) for Child Care 24 Stabilization Grants. 25 26 CLARIFY LANGUAGE/COMPENSATION GRANTS FOR CHILD CARE PROGRAMS 27 SECTION 3. Section 9L.2(b) of S.L. 2021-180, as amended by Section 9L.2(a) of S.L. 2022-74 and Section 9D.11 of S.L. 2023-134, reads as rewritten: 28 29 "SECTION 9L.2.(b) Of the funds appropriated in this act from federal Child Care and 30 Development Block Grant funds received pursuant to ARPA to the Department of Health and Human Services, Division of Child Development and Early Education, the sum of five hundred 31 32 three million seven hundred ninety-three thousand seven hundred eleven dollars (\$503,793,711) 33 in nonrecurring funds shall be allocated for the following in response to the COVID-19 34 pandemic:
