Extension of Time. - For good cause shown, the Department may extend the time for 11 (d) the license renewal and the annual filing of updated information for a period not to exceed 60 12 days, days beyond the (i) fifteenth day of the fifth calendar month after the close of each fiscal 13 14 year in which the charitable organization or sponsor solicited in this State or (ii) date of any applicable extension of the federal informational tax form filing date, during which time the 15 previous license shall remain in effect. - 1 1, 2023, and applies to license renewals filed on or after that date. The remainder of this act is
- 2 effective when it becomes law.
