A BILL TO BE ENTITLED

AN ACT TO MAKE VARIOUS CHANGES TO LOCAL ELECTION LAWS IN NORTH CAROLINA.

The General Assembly of North Carolina enacts:

PART I. TOWN OF PINK HILL – EVEN-NUMBERED YEAR ELECTIONS

SECTION 1.(a) Section 3.1 of the Charter of the Town of Pink Hill, being Chapter 31 of the Private Laws of 1915, as amended by S.L. 2011-46, reads as rewritten:

"Sec. 3.1. ~~In 2011 and quadrennially thereafter, the~~ The governing body of the Town of Pink Hill shall consist of a Mayor shall be elected for a four-year term. In 2011, and three commissioners shall be elected, with the top vote getter receiving a four-year term and the two persons receiving the next highest numbers of votes receiving two-year terms. In 2013 and quadrennially thereafter, two commissioners shall be elected for four-year terms. In 2015 and quadrennially thereafter, one commissioner shall be elected for a four-year term. ~~elected to serve staggered four-year terms.~~"

SECTION 1.(b) The Charter of the Town of Pink Hill, being Chapter 31 of the Private Laws of 1915, as amended by Chapter 221 of the Private Laws of 1933 and by S.L. 2011-46, is amended by adding a new section to read:

"Sec. 3.2. Regular municipal elections shall be held at the time of the general election in each even-numbered year. The Mayor and commissioners shall be elected on a nonpartisan plurality basis in accordance with G.S. 163-292. Except as otherwise provided, elections shall be held and conducted in accordance with the uniform municipal election laws of Chapter 163 of the General Statutes."

SECTION 1.(c) Section 3 of the Charter of the Town of Pink Hill, being Chapter 31 of the Private Laws of 1915, as amended by Chapter 221 of the Private Laws of 1933, is repealed.

SECTION 1.(d) Chapter 760 of the 1955 Session Laws is repealed.

SECTION 1.(e) No municipal elections shall be conducted in the Town of Pink Hill in 2027. The terms of office for the Mayor and one commissioner in the Town of Pink Hill serving on the effective date of this section whose terms are set to expire in 2027 shall be extended by one year. The terms of office for the two commissioners in the Town of Pink Hill serving on the effective date of this section whose terms are set to expire in 2029 shall be extended by one year. Regular municipal elections in the Town of Pink Hill shall resume in even-numbered years beginning in 2028 with the same staggering of terms as when elections were conducted in the odd-numbered years.

2 **PART II. TOWN OF BOLIVIA – EVEN-NUMBERED YEAR ELECTIONS AND**
3 **FOUR-YEAR TERMS**

4 **SECTION 2.(a)** Section 2 of the Charter of the Town of Bolivia, as reactivated by
5 Chapter 366 of the 1961 Session Laws, reads as rewritten:

6 "Sec. 2. ~~On the first Monday in May 1963, and biennially thereafter, there shall be held in at~~
7 ~~which time there shall be elected a~~ Regular municipal elections shall be held at the time of the
8 general election in even-numbered years. The mayor and four aldermen who shall take office on
9 the first Tuesday in May next succeeding their election and shall be elected on a nonpartisan
10 plurality basis in accordance with G.S. 163-292. The mayor and aldermen shall hold office for
11 two four years and until their successors are elected and qualified. The said ~~Except as otherwise~~
12 provided, elections shall be held and conducted under the provisions of Article 3 of Chapter 160
13 in accordance with the uniform municipal election laws in Chapter 163 of the General Statutes
14 of North Carolina."

15 **SECTION 2.(b)** No municipal elections shall be conducted in the Town of Bolivia
16 in 2027. The terms of office for the mayor and four aldermen serving on the effective date of this
17 section whose terms are set to expire in 2027 shall be extended by one year. Regular municipal
18 elections in the Town of Bolivia shall resume in even-numbered years beginning in 2028.

20 **PART III. TOWN OF BELVILLE – EVEN-NUMBERED YEAR ELECTIONS AND**
21 **FOUR-YEAR TERM FOR MAYOR**

22 **SECTION 3.(a)** Section 4 of the Charter of the Town of Belville, being Chapter 84
23 of the 1977 Session Laws, reads as rewritten:

24 "Sec. 4. ~~The regular~~ Regular municipal election elections shall be held in November 1977,
25 ~~and biennially thereafter for the election of a mayor and the members of the board of~~
26 ~~commissioners. at the time of the general election in each even-numbered year. The election~~
27 mayor and members of the board of commissioners shall be elected on a nonpartisan and decided
28 by simple plurality and held at the time specified in G.S. 163-279(a)(1). plurality basis in
29 accordance with G.S. 163-292.

30 The municipal elections shall be held and conducted by the county board of elections and the
31 town shall reimburse the county board of elections for the cost ~~thereof except the first election~~
32 ~~required to be held herein. thereof.~~ The elections shall be conducted in accordance with the
33 ~~applicable provisions of Articles 23 and 24 of uniform municipal election laws in Chapter 163~~
34 ~~of the General Statutes of North Carolina, except as otherwise provided herein."~~

35 **SECTION 3.(b)** Section 5 of the Charter of the Town of Belville, being Chapter 84
36 of the 1977 Session Laws, reads as rewritten:

37 "Sec. 5. ~~In the 1977 municipal election and biennially thereafter, the~~ The mayor shall be
38 elected for a term of two four years. In the 1977 municipal election the two candidates for
39 commissioner receiving the highest number of votes shall be elected for a term of four years, and
40 the two candidates receiving the next highest number of votes shall be elected for a term of two
41 years. Thereafter as the term of each member of the board of commissioners expires, his
42 successor shall be elected for a term of four years. Members of the board of commissioners shall
43 be elected to serve staggered four-year terms."

44 **SECTION 3.(c)** No municipal elections shall be conducted in the Town of Belville
45 in 2027. The terms of office of the mayor and the two members of the board of commissioners
46 set to expire in 2027 shall be extended by one year. The terms of office of the two members of
47 the board of commissioners set to expire in 2029 shall be extended by one year. Regular
48 municipal elections in the Town of Belville shall resume in even-numbered years beginning in
49 2028 with the same staggering of terms as when elections were conducted in the odd-numbered
50 years and with the mayor being elected to serve a four-year term.

1 **PART IV. CITY OF NEW BERN – EVEN-NUMBERED YEAR ELECTIONS AND**
2 **FILLING OF UNFILLED VACANCIES BY SPECIAL ELECTION**

3 **SECTION 4.1.(a)** Section 3.1 of the Charter of the City of New Bern, being S.L.
4 2016-41, reads as rewritten:

5 "Section 3.1. Method of election. Regular municipal elections shall be held in the City ~~every~~
6 ~~four years at the time of the general election in odd-numbered years, and even-numbered years.~~
7 Except as otherwise provided, elections shall be held and conducted in accordance with general
8 the uniform laws of the State governing municipal elections. The Mayor and members of the
9 Board of Aldermen shall be elected according to the nonpartisan election and runoff method, as
10 provided in G.S. 163-293, plurality basis in accordance with G.S. 163-292."

11 **SECTION 4.1.(b)** No municipal elections shall be conducted in the City of New
12 Bern in 2029. The terms of office of the Mayor and six aldermen serving on the effective date of
13 this section whose terms are set to expire in 2029 shall be extended by one year. Regular
14 municipal elections in the City of New Bern shall resume in even-numbered years beginning in
15 2030.

16 **SECTION 4.2.(a)** Article III of the Charter of the City of New Bern, being S.L.
17 2016-41, is amended by adding a new section to read:

18 "Section 3.6. Vacancies. Notwithstanding G.S. 160A-63, the remaining members of the
19 Board of Aldermen shall appoint a qualified person to fill a vacancy within 90 days of the
20 occurrence of the vacancy to serve the remainder of the unexpired term. Notwithstanding
21 G.S. 163-287, if the Board of Aldermen fail to appoint a qualified person in accordance with this
22 section, the county board of elections shall set a special election to fill the vacancy for the
23 remainder of the unexpired term. The county board of elections shall determine the date of the
24 special election, which shall be held within 180 days of the occurrence of the vacancy, and shall
25 have the authority to set a filing period in advance of the special election which filing period shall
26 be for no less than seven calendar days. The county board of elections shall publish legal notice
27 no less than 30 days prior to the special election with the date and time of the special election
28 and the precincts in which the special election shall be held."

29 **SECTION 4.2.(b)** This section is effective when it becomes law and applies to
30 vacancies occurring on or after that date.

31
32 **PART V. TOWN OF EVERETTS – FOUR-YEAR TERMS**

33 **SECTION 5.(a)** The Charter of the Town of Everetts, being Chapter 321 of the
34 Private Laws of 1893, as amended by Chapter 82 of the 1979 Session Laws, is amended by
35 adding a new section to read:

36 "Sec. 3.1. The officers of the Town of Everetts shall consist of a mayor and three
37 commissioners. The mayor and three commissioners shall be elected to serve four-year terms.
38 Elections in the Town of Everetts shall be conducted on a nonpartisan plurality basis in
39 accordance with G.S. 163-292."

40 **SECTION 5.(b)** Sections 1, 2, and 3 of Chapter 82 of the 1979 Session Laws are
41 repealed.

42
43 **PART VI. TOWN OF SNOW HILL – EVEN-NUMBERED YEAR ELECTIONS**

44 **SECTION 6.(a)** Section 3.1 of the Charter of the Town of Snow Hill, being Chapter
45 58 of the 1977 Session Laws, reads as rewritten:

46 "Sec. 3.1. Regular municipal elections; conduct and method of election.–Regular municipal
47 elections shall be held in the Town ~~every two years in odd-numbered years and~~ at the time of the
48 general election in each even-numbered year. Except as otherwise provided, elections shall be
49 conducted in accordance with the uniform municipal election laws of North Carolina. Members
50 The mayor and the members of the Board of Commissioners shall be elected according to the on

1 a nonpartisan plurality method of elections. Municipal elections shall be conducted by the County
2 Board of Elections basis in accordance with G.S. 163-292."

3 **SECTION 6.(b)** Section 2.2 of the Charter of the Town of Snow Hill, being Chapter
4 58 of the 1977 Session Laws, reads as rewritten:

5 "Sec. 2.2. Board of commissioners; composition; terms of office.–The Board of
6 Commissioners shall be composed of five members, each of whom shall be elected for staggered
7 terms of four years in the manner provided by Article 3 of this Charter, provided they shall serve
8 until their successors are elected and qualified."

9 **SECTION 6.(c)** Section 3.2 of the Charter of the Town of Snow Hill, being Chapter
10 58 of the 1977 Session Laws, is repealed.

11 **SECTION 6.(d)** No municipal elections shall be conducted in the Town of Snow
12 Hill in 2027. The terms of office for the two commissioners in the Town of Snow Hill serving
13 on the effective date of this section whose terms are set to expire in 2027 shall be extended by
14 one year. The terms of office for the mayor and the three commissioners in the Town of Snow
15 Hill serving on the effective date of this section whose terms are set to expire in 2029 shall be
16 extended by one year. Regular municipal elections in the Town of Snow Hill shall resume in
17 even-numbered years beginning in 2028 with the same staggering of terms as when elections
18 were conducted in the odd-numbered years.

19 **PART VII. TOWN OF COLUMBUS – FOUR-YEAR TERMS FOR MAYOR**

20 **SECTION 7.(a)** Section 2.3 of the Charter of the Town of Columbus, being Chapter
21 46 of the 1985 Session Laws, reads as rewritten:

22 "Section 2.3. Mayor; Term of Office; Duties. The Mayor shall be elected for a term of ~~two~~
23 four years, or until his or her successor is elected and qualified; shall be the official head of the
24 Town government and preside at all meetings of the Council; shall have the right to vote only
25 when there is an equal division on any question or matter before the Council; and shall exercise
26 the powers and duties conferred by law or as directed by the Council."

27 **SECTION 7.(b)** The term of office for the Mayor for the Town of Columbus serving
28 on the effective date of this section whose term is set to expire in 2026 shall be extended by two
29 years. The Polk County Board of Elections shall not open the filing period for the office of Mayor
30 for the Town of Columbus in 2026 under G.S. 163-294.2.

31 **SECTION 7.(c)** Subsection (a) of this section is effective when it becomes law and
32 applies to elections held on or after that date. The remainder of this section is effective when it
33 becomes law.
34

35 **PART VIII. TOWN OF RURAL HALL – UNAFFILIATED CANDIDATES AND** 36 **VACANCY FILLING PROCESS**

37 **SECTION 8.(a)** The Charter of the Town of Rural Hall, being Chapter 1100 of the
38 1973 Session Laws, as amended by S.L. 2023-31 and by S.L. 2024-14, is amended by adding a
39 new section to read:

40 "Sec. 4.1. Any candidate seeking nomination by petition for municipal office shall comply
41 with the requirements of Article 11 of Chapter 163 of the General Statutes, except that the date
42 and time petitions must be filed with the county board of elections shall be in accordance with
43 G.S. 163-122(a)(3)."
44

45 **SECTION 8.(b)** Section 5 of Chapter 1100 of the 1973 Session Laws, as amended
46 by S.L. 2023-31, reads as rewritten:

47 "**Sec. 5. (a)** A regular municipal election shall be held in the Town of Rural Hall at the
48 time of the general election in each even-numbered year. Candidates for election shall be
49 nominated at the same time and manner as county officers.

1 (b) Vacancies occurring for any reason in the council shall be filled for the unexpired
2 term by appointment by the remaining members of the council. A vacancy in the office of mayor
3 shall be filled for the unexpired term by appointment by the council.

4 (c) Notwithstanding G.S. 160A-63, in filling a vacancy under subsection (b) of this
5 section, if the vacating official was elected as the nominee of a political party, then the individual
6 recommended by the county executive committee of that political party shall be appointed if the
7 county executive committee makes a recommendation within 30 days of the occurrence of the
8 vacancy and restricts voting to committee members who reside within the corporate limits of the
9 Town of Rural Hall."

10 **SECTION 8.(c)** Notwithstanding subsection (a) of this section, for purposes of the
11 2026 election only, any candidate seeking nomination by petition for municipal office must file
12 a petition with the county board of elections no later than 12:00 noon on July 6, 2026. Except as
13 otherwise provided by this section, candidates shall comply with the requirements set out in
14 Article 11 of Chapter 163 of the General Statutes.

15 **SECTION 8.(d)** Subsection (a) of this section becomes effective January 1, 2027,
16 and applies to elections held in 2028 and thereafter. Subsection (b) of this section is effective
17 when it becomes law and applies to vacancies occurring on or after that date. Subsection (c) of
18 this section is effective when it becomes law and applies to petitions filed on or after that date.

20 **PART IX. CATAWBA COUNTY MUNICIPALITIES – EVEN-NUMBERED YEAR**

21 **ELECTIONS**

22

23 **TOWN OF BROOKFORD**

24 **SECTION 9.1.(a)** Section 3 of the Charter of the Town of Brookford, being Chapter
25 230 of the Private Laws of 1907, reads as rewritten:

26 "Sec. 3. ~~That the~~ The officers of the said corporation shall be a mayor, three commissioners
27 and such other officers and agents as may be appointed by the board of commissioners to enforce
28 their ordinances, keep their records, and otherwise aid in the conduct of the affairs of the town.
29 That until Tuesday after the first Monday in May, one thousand nine hundred and seven, T. J.
30 Leonard is appointed to the office of mayor of said town, and W. H. Shuford, J. W. Ballew and
31 C. E. Cole are appointed commissioners thereof; that the said mayor and commissioners shall
32 hold their offices until their successors are elected and qualified, as hereafter provided. Town of
33 Brookford shall consist of a mayor and four aldermen elected to serve staggered four-year terms."

34 **SECTION 9.1.(b)** Section 4 of the Charter of the Town of Brookford, being Chapter
35 230 of the Private Laws of 1907, reads as rewritten:

36 "Sec. 4. ~~That there shall be an election to the offices of mayor and commissioners of said~~
37 ~~town on Tuesday after the first Monday in May, one thousand nine hundred and seven, and~~
38 ~~biennially thereafter, under the same restrictions and regulations under which State and county~~
39 ~~elections are held, and as provided by law for elections in cities and towns in North~~
40 ~~Carolina.~~ Regular municipal elections for officers shall be held at the time of the general election
41 in each even-numbered year. The election shall be conducted on a nonpartisan plurality basis in
42 accordance with G.S. 163-292. Except as otherwise provided, the election shall be conducted in
43 accordance with the uniform municipal election laws in Chapter 163 of the General Statutes."

44 **SECTION 9.1.(c)** Chapter 109 of the 1961 Session Laws is repealed.

45 **SECTION 9.1.(d)** No municipal elections shall be conducted in the Town of
46 Brookford in 2027. The terms of office for the two aldermen in the Town of Brookford serving
47 on the effective date of this section whose terms are set to expire in 2027 shall be extended by
48 one year. The terms of office for the mayor and two aldermen in the Town of Brookford serving
49 on the effective date of this section whose terms are set to expire in 2029 shall be extended by
50 one year. Regular municipal elections in the Town of Brookford shall resume in even-numbered

1 years beginning in 2028 with the same staggering of terms as when elections were conducted in
2 the odd-numbered years.

3 4 **TOWN OF CATAWBA**

5 **SECTION 9.2.(a)** The Charter of the Town of Catawba, being Chapter 274 of the
6 Private Laws of 1893, as amended by Chapter 333 of the 1951 Session Laws, Chapter 224 of the
7 1965 Session Laws, Town Ordinance No. 02-10 adopted on July 1, 2002, and Town Ordinance
8 No. 2006-15 adopted on November 6, 2006, is amended by adding a new section to read:

9 "Sec. 3.1. The governing body for the Town of Catawba shall consist of a mayor and four
10 council members, elected to serve staggered four-year terms. Regular municipal elections shall
11 be held at the time of the general election in each even-numbered year. The mayor and council
12 members shall be elected on a nonpartisan plurality basis in accordance with G.S. 163-292.
13 Except as otherwise provided, the election shall be conducted in accordance with the uniform
14 municipal election laws in Chapter 163 of the General Statutes."

15 **SECTION 9.2.(b)** Sections 3 and 4 of the Charter of the Town of Catawba, being
16 Chapter 274 of the Private Laws of 1893, as amended by Chapter 333 of the 1951 Session Laws,
17 Chapter 224 of the 1965 Session Laws, Town Ordinance No. 02-10 adopted on July 1, 2002, and
18 Town Ordinance No. 2006-15 adopted on November 6, 2006, and referred to as Section 5 in the
19 current amended Town Code, are repealed.

20 **SECTION 9.2.(c)** No municipal elections shall be conducted in the Town of
21 Catawba in 2027. The terms of office for the mayor and two council members in the Town of
22 Catawba serving on the effective date of this section whose terms are set to expire in 2027 shall
23 be extended by one year. The terms of office for the two council members in the Town of
24 Catawba serving on the effective date of this section whose terms are set to expire in 2029 shall
25 be extended by one year. Regular municipal elections in the Town of Catawba shall resume in
26 even-numbered years beginning in 2028 with the same staggering of terms as when elections
27 were conducted in the odd-numbered years.

28 29 **CITY OF CLAREMONT**

30 **SECTION 9.3.(a)** The Charter of the City of Claremont, being Chapter 11 of the
31 Private Laws of 1893, as amended by Town Ordinance adopted on February 3, 1976, is amended
32 by adding a new section to read:

33 "Sec. 3.1. The governing body for the City of Claremont shall consist of a mayor and five
34 council members, elected to serve staggered four-year terms. Regular municipal elections shall
35 be held at the time of the general election in each even-numbered year. The mayor and council
36 members shall be elected on a nonpartisan plurality basis in accordance with G.S. 163-292.
37 Except as otherwise provided, the election shall be conducted in accordance with the uniform
38 municipal election laws in Chapter 163 of the General Statutes."

39 **SECTION 9.3.(b)** Sections 3 and 4 of the Charter of the City of Claremont, being
40 Chapter 11 of the Private Laws of 1893, as amended by Town Ordinance adopted on February
41 3, 1976, are repealed.

42 **SECTION 9.3.(c)** The following acts are repealed:

- 43 (1) Chapter 76 of the 1961 Session Laws.
- 44 (2) Chapter 97 of the 1975 Session Laws.
- 45 (3) Section 2 of S.L. 2005-54.

46 **SECTION 9.3.(d)** No municipal elections shall be conducted in the City of
47 Claremont in 2027. The terms of office for the three council members in the City of Claremont
48 serving on the effective date of this section whose terms are set to expire in 2027 shall be
49 extended by one year. The terms of office for the mayor and two council members in the City of
50 Claremont serving on the effective date of this section whose terms are set to expire in 2029 shall
51 be extended by one year. Regular municipal elections in the City of Claremont shall resume in

1 even-numbered years beginning in 2028 with the same staggering of terms as when elections
2 were conducted in the odd-numbered years.

3 4 **CITY OF CONOVER**

5 **SECTION 9.4.(a)** Section 4.01 of the Charter of the City of Conover, being Chapter
6 78 of the 1977 Session Laws, as amended by City Ordinance No. 16-96 adopted on July 8, 1996,
7 reads as rewritten:

8 "Section 4.01. Conduct of city elections. Regular municipal elections shall be held at the time
9 of the general election in each even-numbered year. All elections for mayor and council members
10 shall be held on a nonpartisan plurality basis and the results determined by plurality as provided
11 in G.S. 163-279(a)(1). in accordance with G.S. 163-292. The term of office of the mayor shall
12 be four (4)-years. The terms of office of councilmen council members shall be four years. At the
13 regular election in November, 1997, and quadrennially thereafter, two councilmen and the mayor
14 shall be elected. At the regular election in November, 1979, and quadrennially thereafter, three
15 councilmen shall be elected. The serve staggered four-year terms. Except as otherwise provided,
16 the elections for the City of Conover shall be held and conducted pursuant to the applicable
17 provisions of Articles 23 and 24 of in accordance with the uniform municipal election laws in
18 Chapter 163 of the General Statutes of North Carolina."

19 **SECTION 9.4.(b)** No municipal elections shall be conducted in the City of Conover
20 in 2027. The terms of office for the three council members in the City of Conover serving on the
21 effective date of this section whose terms are set to expire in 2027 shall be extended by one year.
22 The terms of office for the mayor and two council members in the City of Conover serving on
23 the effective date of this section whose terms are set to expire in 2029 shall be extended by one
24 year. Regular municipal elections in the City of Conover shall resume in even-numbered years
25 beginning in 2028 with the same staggering of terms as when elections were conducted in the
26 odd-numbered years.

27 28 **CITY OF HICKORY**

29 **SECTION 9.5.(a)** Section 2.01 of the Charter of the City of Hickory, being Chapter
30 323 of the 1961 Session Laws, as amended by Chapter 404 of the 1967 Session Laws, reads as
31 rewritten:

32 "Sec. 2.01. Composition, Election, and Terms of City Council; Time of General Election. (a)
33 The voters of the city shall elect The governing body for the City of Hickory shall consist of a
34 mayor and six aldermen. The mayor shall be nominated and elected at large. The aldermen shall
35 each reside in and represent a ward, but all aldermen shall be nominated and elected at large. The
36 candidate from each ward receiving the highest number of votes shall be declared elected. Except
37 as is otherwise provided in this Charter, no two aldermen shall be residents of the same ward. All
38 municipal elections shall be nonpartisan. No person shall be eligible to file for or be elected as an
39 alderman unless the person is a qualified voter and resident of the ward in which the person seeks
40 to be elected.

41 (b) A general municipal election shall be held annually on the first Monday in June of
42 1967, and on the first Monday in June of 1968. In 1970, and biennially thereafter, the general
43 municipal election shall be held on the first Monday in June. Regular municipal elections shall be
44 held at the time of the general election in each even-numbered year. The mayor and aldermen
45 shall be elected using the nonpartisan primary and election method in accordance with
46 G.S. 163-294. The nonpartisan primary shall be held on the date provided by G.S. 163-1 for
47 county partisan primaries. Candidates shall file the notice of candidacy with the county board of
48 elections under the same schedule provided by G.S. 163-106.2. Except as otherwise provided,
49 the election shall be conducted in accordance with the uniform municipal election laws in Chapter
50 163 of the General Statutes.

1 (c) ~~The terms of all council members shall begin at the day and hour prescribed by~~
2 ~~Section 3.03 of this Charter for the taking of the oath of office, and shall run for a period four~~
3 ~~years, except for member's interim terms of three years for the next election of aldermen of the~~

36 resident of the ward in which the person seeks to be elected."

43 the effective date of this section whose terms are set to expire in 2027 shall be extended by one
44 year. The terms of office for the mayor and two aldermen in the Town of Long View serving on
45 the effective date of this section whose terms are set to expire in 2029 shall be extended by one
46 year. Regular municipal elections in the Town of Long View shall resume in even-numbered
47 years beginning in 2028 with the same staggering of terms as when elections were conducted in
48 the odd-numbered years.

1 **SECTION 9.7.(a)** The Charter of the Town of Maiden, being Chapter 103 of the
2 Private Laws of 1883, as amended by Chapter 5 of the Private Laws of 1885, Chapter 415 of the
3 Private Laws of 1905, Chapter 54 of the Private Laws of 1920, Chapter 350 of the Private Laws
4 of 1939, Chapter 445 of the 1955 Session Laws, Chapter 150 of the 1981 Session Laws, Chapter

6 Ordinance No. 11-2006 adopted on April 3, 2006, is amended by adding a new section to read:

21 **SECTION 9.7.(c)** No municipal elections shall be conducted in the Town of Maiden
22 in 2027. The terms of office for the mayor and three council members in the Town of Maiden
23 serving on the effective date of this section whose terms are set to expire in 2027 shall be
24 extended by one year. The terms of office for two council members in the Town of Maiden
25 serving on the effective date of this section whose terms are set to expire in 2029 shall be
26 extended by one year. Regular municipal elections in the Town of Maiden shall resume in
27 even-numbered years beginning in 2028 with the same staggering of terms as when elections
28 were conducted in the odd-numbered years.

30 CITY OF NEWTON

31 **SECTION 9.8.(a)** Article III of the Charter of the City of Newton, being Chapter
32 1042 of the 1989 Session Laws, as amended by City Ordinance No. 2002.29 adopted on July 10,
33 2002, reads as rewritten:

34 "ARTICLE III. GOVERNING BODY.

35 "Section 3.1. **Structure of Governing Body; Number of Members.** The Governing Body
36 of the City of Newton is the Council, which has six members, and the Mayor.

43 "Section 3.4. **Election of Mayor; Term of Office.** The qualified voters of the entire City
44 elect the Mayor. ~~A new Mayor shall be elected in 2003 and each four years thereafter.~~ Mayor who
45 shall be elected to serve a four-year term."

46 **SECTION 9.8.(b)** Section 4.1 of the Charter of the City of Newton, being Chapter
47 1042 of the 1989 Session Laws, reads as rewritten:

48 "Section 4.1. **Conduct of City Elections.** Regular municipal elections shall be held at the
49 time of the general election in each even-numbered year. City officers shall be elected on a
50 nonpartisan basis and the results determined by plurality, as provided by G.S. 163-292. Except

1 as otherwise provided, the election shall be conducted in accordance with the uniform municipal
2 election laws in Chapter 163 of the General Statutes."

3 **SECTION 9.8.(c)** No municipal elections shall be conducted in the City of Newton
4 in 2027. The terms of office for the mayor and three council members in the City of Newton
5 serving on the effective date of this section whose terms are set to expire in 2027 shall be
6 extended by one year. The terms of office for the three council members in the City of Newton
7 serving on the effective date of this section whose terms are set to expire in 2029 shall be
8 extended by one year. Regular municipal elections in the City of Newton shall resume in
9 even-numbered years beginning in 2028 with the same staggering of terms as when elections
10 were conducted in the odd-numbered years.

11 **PART X. TOWN OF CONETOE – MAYOR VOTING AUTHORITY**

12 **SECTION 10.(a)** Section 3.3.6 of the Charter of the Town of Conetoe, being Chapter
13 154 of the Private Laws of 1887, as amended, and as evidenced by the Code of Ordinances of
14 the Town of Conetoe adopted March 11, 2025, reads as rewritten:

33 of the occurrence of the vacancy, the superintendent of the Iredell-Statesville Schools Board of
34 Education shall immediately report the vacancy to the clerk of superior court of the county. The
35 clerk of superior court shall appoint to fill the vacancy within 10 calendar days after receiving
36 notification from the superintendent, provided that the person appointed by the clerk of superior
37 court shall be all of the following:

- 39 (1) A voter registered with the same political party as the vacating member, if the
40 vacating member was elected as the nominee of a political party.
 - 41 (2) A resident of the same electoral district as the vacating member, if the vacating

13 provided by Article III of this Charter, provided they shall serve until their successors are elected

15 **SECTION 12.1.(c)** Sections 3.2 and 3.3 of the Charter of the City of Marion, being

18 in 2027. The terms of office for the two council members in the City of Marion serving on the
19 effective date of this section whose terms are set to expire in 2027 shall be extended by one year.
20 The terms of office for the mayor and three council members in the City of Marion serving on
21 the effective date of this section whose terms are set to expire in 2029 shall be extended by one
22 year. Regular municipal elections in the City of Marion shall resume in even-numbered years
23 beginning in 2028 with the same staggering of terms as when elections were conducted in the
24 odd-numbered years.

25 26 **TOWN OF OLD FORT**

27 **SECTION 12.2.(a)** Section 3 of the Charter for the Town of Old Fort, being Chapter
28 271 of the Private Laws of 1911, reads as rewritten:

40 **SECTION 12.2.(c)** Sections 5 and 10 of the Charter of the Town of Old Fort, being
41 Chapter 271 of the Private Laws of 1911, are repealed.

42 **SECTION 12.2.(d)** The following acts are repealed:

- 43 (1) Chapter 793 of the 1947 Sessions Laws.
- 44 (2) Chapter 389 of the 1953 Session Laws.
- 45 (3) Chapter 35 of the 1993 Session Laws.

46 **SECTION 12.2.(e)** No municipal elections shall be conducted in the Town of Old
47 Fort in 2027. The terms of office for the three aldermen in the Town of Old Fort serving on the
48 effective date of this section whose terms are set to expire in 2027 shall be extended by one year.
49 The terms of office for the mayor and two aldermen in the Town of Old Fort serving on the
50 effective date of this section whose terms are set to expire in 2029 shall be extended by one year.
51 Regular municipal elections in the Town of Old Fort shall resume in even-numbered years

1 beginning in 2028 with the same staggering of terms as when elections were conducted in the
2 odd-numbered years.
