(c) Notwithstanding any other provision of law to the contrary, nothing in this section
prohibits a wireless telecommunications carrier from establishing protocols by which the carrier
voluntarily discloses phone location information of a telecommunications device.

(d) No cause of action shall lie in any court against any wireless telecommunications
carrier, its officers, employees, agents, or other specified persons for providing phone location
information of a telecommunications device while acting in good faith and in accordance with
the provisions of this section.

33 (e) <u>All wireless telecommunications carriers registered to do business in this State or</u>

35 <u>shall submit their emergency contact information to the State Bureau of Investigation in order to</u>

1	with this section. This contact information shall be submitted annually by June 15 or immediately
2	upon any change in contact information. The State Bureau of Investigation shall maintain a
3	database containing emergency contact information for all wireless telecommunications carriers
4	registered to do business in this State and shall make the information immediately available upon
5	request to all public safety answering points in this State."
6	<b>SECTION 3.</b> The State Bureau of Investigation shall adopt temporary rules to
7	implement the provisions of this act. Temporary rules adopted in accordance with this act shall
8	remain in effect until permanent rules that replace the temporary rules become effective.

9 SECTION 4. This act becomes effective July 1, 2025.
